Dear Counsel,

Dear colleagues,

With regard to victims' participation and legal representation, the Chamber notes that several filings were submitted as either 'confidential' or 'confidential ex parte'. In order to ensure publicity of the proceedings, and noting the submitters' indications as to the confidentiality of such filings, the Chamber hereby orders:

- (1) the Registry to file public redacted versions of filing no. 236 and its Annex 1, or indicate by email that it agrees with them being reclassified as public;
- (2) the Defence to file public redacted versions of filings no. 248 and 250, or indicate by email that it agrees with them being reclassified as public; and
- (3) the Office of Public Counsel for Victims ('OPCV') to file a public redacted version of filing no. 245.

The above orders shall be implemented by no later than Monday, 1 September 2025 at 12:00.
