Dear Registry,

The Single Judge notes the VPRS' request to grant the Common Legal Representatives of Victims (CLRv) access to the Group A victim application forms transmitted as annexes currently classified as confidential *ex parte*, only available to the Registry. The Single Judge recognises that this request arises from the VPRS approach of sharing the applications with the appointed legal representatives.

The Single Judge further notes that, as a result of this approach, granting the request requires reclassifying the annexes to extend access to the CLRv. Accordingly, pursuant to regulation 23(bis) of the Regulations of the Court, the Single Judge grants the request and instructs CMS to reclassify the annexes to the following filings to ensure access by both the Registry and the CLRv:
