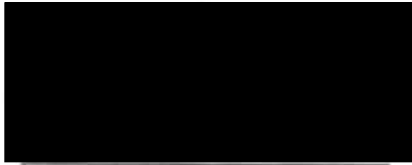

Additional remarks:

The certification of the prior recorded testimony was conducted with the assistance of an Associate Court Interpreter from the Registry Language Services Section. The certification was conducted in Sango.

The witness brought his voter registration card and the birth certificate issued by the Pissa Commune to the certification and showed both documents to the camera. The birth certificate issued by the Bangui Town Hall was provided by the Defence team and the witness confirmed to have provided them this version of his birth certificate. Due to the poor quality of the Bangui-issued birth certificate, the witness had later obtained the birth certificate issued by the Pissa Commune.

During the certification process, the witness took a phone call, although he had previously been informed not to use his phone during the certification process. The Interpreter informed witnessing officer that during the phone call, the witness informed

the caller that he had not yet finished. The witness informed the witnessing officer that he spoke with his wife during the phone call.

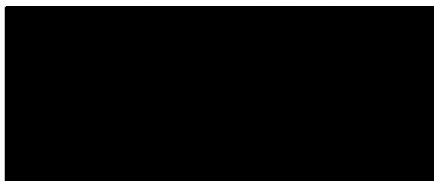
