Subject: Duterte case - Requests to reclassify [ICC-01/21-01/25-247] and submit a lesser redacted version [ICC-01/21-01/25-239]

Dear Pre-Trial Chamber I,

We are writing in relation to: 1) the “Registry Report on Group A and B Applications for Victim Participation in Pre-Trial Proceedings”, (ICC-01/21-01/25-247, 27 August 2025 – “Group A and B Report”); and 2) the “Registry Report on Group C Applications for Victim Participation in Pre-Trial Proceedings” (ICC-01/21-01/25-239, 20 August 2025 – “Group C Report”). At the time of filing, the Document Containing the Charges (DCC) and the Pre-Confirmation Brief (PCB) were confidential, which prompted the majority of the redactions applied in the public redacted versions of the two Reports.

Following the Chamber's order, public redacted versions of the DCC and PCB were filed by the Office of the Prosecutor on 22 September. Accordingly, and pursuant to regulation 23bis(3) of the Regulations of the Court, the VPRS:

1. Seeks the Chamber's approval to re-classify as public the Group A and B Report;
2. Seeks the Chamber's approval to file a lesser redacted version of the Group C Report, consistent with the public redacted versions of the DCC and PCB.
