Dear Pre-Trial Chamber I,

The Defence is preparing its response to filing 0081 (Prosecution's request for authorisation to submit anonymous summaries of 10 witnesses) and has just moments ago received notification of filing 0087 (Prosecution's request for authorisation to submit anonymous summaries of 5 further witnesses).

Given the significant crossover in the nature of the two requests, we respectfully suggest that it would be most efficient if we were to file a consolidated response to both requests, and accordingly ask that the PTC grant leave to do so by close of business on Friday, 20 March. This will mean the PTC is fully briefed before the weekend in respect of both requests instead of waiting until the end of the day next Monday.
