**List of corrections made in the “Amended and corrected version of Prosecution
Response to the «Requête urgente de la Défense sollicitant la mise en liberté
provisoire de Monsieur Fidèle Babala Wandu» of 3 January 2014 (ICC-01/05-01/13-
38)”**

1. The Prosecution has corrected a typographical error in the name of one of the Suspects.
2. The Prosecution has added accents on French words and names, added capitals, deleted spaces and modified the punctuation where appropriate.
3. The Prosecution has noted and corrected the following clerical or typographic errors in the Response:
 - i. Title page and at paragraph 6 - “2014” replaces “2013”.
 - ii. Page 4, paragraph 1, “Rome Statute (“Statute”)” replaces “Statute”.
 - iii. Paragraph 2: “*Bemba* case” replaces “Main Case”.
 - iv. Page 5, footnote 2: “, ICC-01/05-67-US-Exp” replaces “*See* ICC-01/05-01/13-1-US-Exp-tEng”; “AWA” replaces “arrest warrant application” “its” is inserted before “supporting”.
 - v. Page 5, footnote 3: “ICC-01/05-01/13-1-US-Exp-tENG.” replaces “ICC-01/05-01/13-1-US-Exp-tEng.” and “ICC-01/05-01/13-1-Red2-tENG” replaces “ICC-01/05-01/13-1-RED” and hereinafter at page 7, at footnote 13, page 8, at footnotes 17 and 18, page 9, at footnote 23 and page 13, at footnote 44.
 - vi. Page 6, footnote 7: “(OA)” is inserted after “ICC-02/11-01/11-278-Red”.
 - vii. Paragraph 13 - deletes “the” before “Article” at the first line;
 - subparagraph i., inserts a hyphen between “Jean” and “Pierre” and adds (“Bemba”), (“Kilolo”) and (“Mangenda”) as defined terms after their respective names and corrects the spelling of the word “witnesses”. These defined terms are applied hereinafter with deletion to the first names at

paragraph 13, subparagraphs ii. and iii and to their courtesy titles "Mr" at paragraphs 34, 35 and at its footnote 47 and paragraph 38 and "Messrs" at paragraph 24.

- inserts the number "iv." before the corresponding subparagraph.

viii. Paragraph 15 - capitalises "Suspects".

ix. Page 9, footnote 24 - inserts "Annex K.6." before "CAR-OTP-0072-0104"; and "K.7." before "CAR-OTP-0072-0107";

x. Paragraph 18 - deletes the word "his" between "outweigh" and "the".

xi. Page 10, footnote 27 - inserts "(CAR-OTP-0072-0098)" after Annex K.2.

xii. Page 10, footnote 29 - inserts "Annex K.1" before "CAR-OTP-0072-0091".

xiii. Page 10, footnote 30 - deletes "that" between "Babala" and "Kilolo's".

xiv. Page 10, footnote 31 - "ICC-01/05-67-Conf" replaces "ICC-01/05-67-US-Exp" and hereinafter at page 10, footnotes 32 and 33.

xv. Page 10, footnote 32 - at the first line inserts "ICC-01/05-67-Conf, Annex B.4" before "(CAR-OTP-0070-0007)"; at the second line inserts "Annex B.1. (CAR-OTP-0070-0004)" before "payments"; and at the third line, deletes "CAR-OTP-0070-0004".

xvi. Page 10, footnote 33 - "USD" replaces "SUD" at the first line and deletes "USD" at the second line; inserts "Bemba witness" before D-11 and D-57.

xvii. Paragraph 24 - corrects the number "73,89.15" to read "7,389.15".

xviii. Paragraph 27, "it" replaces "them" at the third line.

xix. Page 12, footnote 38 - at the first line, it inserts "of" between "warrant" and "arrest"; at the second line, "warrant" replaces "version".

xx. Paragraph 28 - "release" replaces "detention".

xxi. In the title of Section II, page 12 "that Babala" replaces "he".

xxii. Paragraph 30 - inserts "via" between "persons" and "telephone"; and "in" replaces "on" at the last line.

- xxiii. Paragraph 31 - "the Suspects" replaces "them".
 - xxiv. Paragraph 32 - deletes "The" at the beginning of the paragraph.
 - xxv. Page 14, footnote 47 - removes "that" before "Babala's" at the first line; and at the fifth line adds "ICC-01/05-67 Conf, Annex I.1," before "telephone conversation".
 - xxvi. Paragraph 35 - deletes "on" between the words "least" and "13".
 - xxvii. Paragraph 37 - deletes "The" preceding "continued" at the beginning of the paragraph.
 - xxviii. Paragraph 44 - "the Pre-Trial Chamber's" replaces "the Pre-Trial's".
4. As noted in the Application, the proposed filing corrects three additional errors in the Response:
- i. Paragraph 13, subparagraph 2 - "privileged-line" replaces "privileged".
 - ii. Page 13, footnote 48 - "ICC-01/05-67-Conf, para. 85, and Annex I.1., telephone conversation 2013/000034808 on 28 September 2012 from 10:21:33 to 10:26:07, in which Bemba instructs Babala." replaces "ICC-01/05-67-Conf, Annex I.1., telephone conversation 2013/000034780 on 14 September 2012 from 06:35 to 06:52:21."
 - iii. Page 16, footnote 56 - deletes "It is interesting to note nonetheless that Babala did not substantiate his allegations regarding the illegality of his arrest pursuant to DRC law, nor did he file such a complaint before the DRC's judicial system."
