Re: Your appointment as Legal Adviser

Dear Ms. Kerwegi,

I hereby inform you that you have been appointed as a Legal Adviser in order to assist during the testimony Witness P-0379 and Witness P-0309 before the International Criminal Court (the "Court"). Your mandate will consist of notifying the witness of the provisions of Rule 74 of the Rules and Procedure and Evidence (the "Rule"), and of providing her or him with an independent and qualified legal advice in a language that she or he fully understands. The purpose of your appointment is restricted to issues relating to self-incrimination and no other aspect of the testimony should be discussed with the witness during the meeting.

The testimony of the witnesses is scheduled to take place between 13 and 21 March 2017 at the Seat of the Court in The Hague. You will be contacted shortly by the Victims and Witnesses Section who will inform you on the practical modalities of your mandate, including but not limited to, when the meeting with the witnesses are taking place.

In order to ensure the proper conduct of the proceedings of the case, you shall submit to the competent Chamber a report on the outcome of your meeting with the witness and any recommendation as provided in Rule 74(3)(c) of the Rule.

Please be informed that your appointment is limited to the mandate and dates outlined in this letter and in no way connotes an appointment as counsel for the person you will assist in the course of this interview, should he or she in the future be implicated in further proceedings before the Court.

The appointment takes effect the date of this letter and, unless otherwise decided by the competent organs of the Court, is exclusively limited to the purpose stated above. The Court reserves the right to modify or terminate this mandate when any relevant factors will justify doing so.

Your remuneration for services rendered in your capacity as Legal Adviser will amount to € 40.50 per hour, with an upper limit of € 304.00 per day, and a maximum of € 6,612.00 per month. This remuneration will be determined on the basis of the actual activities performed by you during the assistance provided to the person in the course of the testimony. The Court reserves the right to reconsider this payment scheme when any relevant factors will justify doing so, including in case of amendment or subsequent approval of any measure concerning its legal aid system.

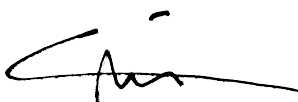

In your capacity as Legal Adviser, you will be governed by the Rome Statute, the Rules of Procedure and Evidence, the Regulations of the Court, the *Code of Professional Conduct for counsel* (Res. Kindly note that counsel intervening in proceedings before the Court must give the solemn undertaking required by Article 5 of the *Code of Professional Conduct for counsel* (ICC-ASP/4/Res.1) and, when acting in the framework of the legal aid scheme, that required by Article 22(3) of the Code. We notice that you already duly executed these two undertakings on 8 July 2015, which remain valid for the purpose of the present proceedings. Finally, we draw your attention in particular to your obligation to respect professional secrecy and confidentiality in accordance with Article 8 of the same Code.
