This is a request for an extension of the deadline imposed during the Status conference on Monday 23 May for the parties to comply with the requirements of the order of the Pre-Trial chamber (#420) by Wednesday 1 June (T-25 p.4 ll.11-15).

Since the hearing the Prosecution has effected significant compliance with this order (five documents either reclassified or now filed in a PRV) but another nine documents are not yet completed. They remain to be checked by the Prosecution Protection Strategies Unit. The PSU staff member concerned will only be able to commence work on these tomorrow and is unlikely to be able to deal with them all in the one day. The staff member within the prosecution team dealing with the matter is scheduled to be on leave for the following week, not returning until Monday 6 June.

The current deadline will cause difficulty, in that a task which has been dealt with by a single person within the prosecution team will have to be reassigned. This could be achieved but it will lead to inevitable inefficiency and repetition of work.

In these circumstances, the Prosecution asks that the Single Judge consider extending the deadline by one week to Wednesday 8 June.
