Dear Prosecution Counsel:

In the 'Initial Directions on the Conduct of the Proceedings' (ICC-02/04-01/15-497), the Prosecution was directed to specify on its witness list when its live witnesses are: (i) video-link witnesses; (ii) expert witnesses and/or (iii) Rule 68(3) witnesses (ICC-02/04-01/15-497, paras 17-18, 32).

The Prosecution's witness list of 6 September (ICC-02/04-01/15-532-Conf-AnxB) does not provide this extra information – all intended *viva voce* witnesses are labelled as 'Live Witness' without further specification. Unless clarification can be given that none of these additional categories apply, the Prosecution is directed to file an updated witness list forthwith which contains the additional information specified in decision ICC-02/04-01/15-497.
