INSTRUMENT OF FULL POWER

WHEREAS the Republic of South Africa has been invited to participate in an Article 87 (7) hearing by the Pre-Trial Chamber of the International Criminal Court on 7 April 2017 in The Hague, Netherlands;

AND WHEREAS the Republic of South Africa has decided to participate in the Article 87 (7) hearing;

AND WHEREAS it is expedient that fit and proper persons be invested with Full Powers to argue the merits of South Africa's case on behalf of the Government of the Republic of South Africa;

NOW THEREFORE I, MAITE NKOANA-MASHABANE, Minister of International Relations and Cooperation of the Republic of South Africa, do hereby declare that I have authorised and appointed, and do by this Instrument authorise and appoint, with Full Powers, the following persons to represent the Government of the Republic of South Africa at the Article 87 (7) hearing:

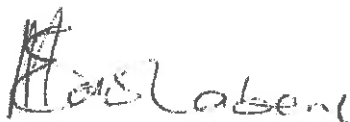
