The Defence will argue that pursuant to Article 60(3) of the Rome Statute, there are changed circumstances which necessitate a review of Mr Ongwen's detention.

The Defence shall be filing written submissions on the issue next week on or before Thursday, 25 May 2017, as required by Rule 118(3). The Defence understands that pursuant to Regulation 34 of the RoC, the Prosecution and LRVs would have 10 days to file a response, which would be due on 5 June 2017.
