It states that the CNRD and FPI should work together in order to recover the totality of the territory, assure the reelection of the CNRD candidate (Laurent GBAGBO) and the majority at the Congress. As argued in the Mid-Trial Brief, this shows that one of the CNRD’s avowed aims was to secure GBAGBO’s re-election. The Prosecution recalls that Simone GBAGBO was the Secretary-General of the CNRD (<i>see</i> CNRD	This document is dated 26 May 2007, and, although the author is unknown, it is reliable and of probative value having in mind its content, read within the context of other evidence in the case, and because it forms part of a collection of other reliable documents. In addition, it was found in Simone GBAGBO’s office. This is a copy of a document collected at the Presidential Residence. Investigator's report CIV-OTP-0024-0641 describes the collection process of the documents at the Presidential Residence. At 0646 of the report, it is stated that this document was found in Room 2, identified to the Prosecution as Simone GBAGBO's office.
