 Dear colleagues in the Registry,

The Chamber notes the Defence comments on the redactions proposed by the Prosecution for D-0134 and that some of the redactions proposed by the Prosecution for the Decision on Submitted Materials for D-0013 are disputed by the Defence.

It takes note of the additional redactions proposed by the Prosecution (email from the Prosecution on 11 December 2019, at 12:02 with two attachments including the requested redactions) and the response by the Defence (email from the Defence on 11 December 2019, at 13:47).

First, with regard to the communication related to D-0134 concerning material to be recognised as formally submitted, the Chamber notes Articles 64(7) of the Statute and the fact that the witness testified without protective measures. Accordingly, the Chamber does not consider that the Prosecution's proposal, commented on by the Defence, needs to be redacted.

Second, with regard to the communication related to D-0013 concerning material to be recognised as formally submitted, the Chamber notes the Defence's objection and previous decisions by the Chamber regarding the redaction of this kind of information. There is no apparent reason to deviate from this conclusion in the current case. Accordingly, the Chamber does not consider that the Prosecution's proposals, which the Defence opposes, need to be redacted.

The remaining redaction proposals are uncontested and can be implemented.
