The Defence for Mr. Al Hassan would like to include the following issues on the agenda for the Status Conference :

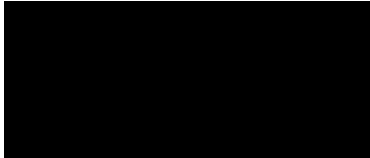
A) Disclosure issues :

- The piece-meal nature of disclosure, and the impact that this has had on Defence preparation and planning;
- Outstanding disclosure requests;
- The Prosecution's overly narrow interpretation of its disclosure obligations (for example, as concerns the disclosure of information from security assessments [REDACTED], and refusal to clarify whether it will or will not disclose certain information.

B) Updates/Deadlines :

Updates as concerns:

- Disclosure of lesser redacted versions (including lifting of anonymity of P-0638) ;
- Disclosure of Rule 76 Arabic translations ;
- Status of disclosure applications of dual-victim witnesses i.e. the Prosecution has identified the following dual victim-witnesses, but we have not received their applications:



- Impact of the *Al Mahdi* reparations phase on this trial, and status of *Al Mahdi* reparation forms.

- C) Logistical issues concerning Defence investigations, which impact on equality of arms**
- D) Impact of the Prosecution request to amend the Charges on the Time Table and Mr. Al Hassan's right to expeditious proceedings.**
- E) The status of individuals who were not included on the Prosecution's provisional list of witnesses**
- F) The status of *ex parte* (Prosecution, Registry only) filings/transcripts, which were filed before the Pre-Trial Chamber (there are thirty such filings)**

The Defence expresses its appreciation to the Trial Chamber for its consideration of these issues. The Defence further signals that it is available and willing to meet the Prosecution and the Legal Representatives for Victims on the 14th, or 17th February in order to discuss any issues that can be resolved in advance on an *inter partes* basis, including the draft contact protocol circulated by the Defence.
