Dear Trial Chamber X, Dear Colleagues,

Yesterday, Mr. Al Hassan's Father-in law passed away. Mr. Al Hassan was informed this morning by the Defence. He then indicated that he would like to speak to his wife today for approximately twenty minutes to express his condolences.

Given that he was scheduled to speak to his family tomorrow, and not today, the Defence has submitted an urgent request to the Detention Unit to make an exception. Since this may result in him having an additional twenty minutes this week or may otherwise impact on time allotted under the monitoring regime, the Defence further requests the Trial Chamber, on an exceptional and humanitarian basis, to vary the monitoring regime in order to facilitate his request. It is the understanding of the Defence and Mr. Al Hassan that this call would be subject to active monitoring, and that as such, no additional risk arises from the implementation of this request.
