The Yekatom Defence takes note of the "Prosecution's Response to Yekatom's Notification to Rule 79 of the Rules of Evidence, ICC-01/14-01/18-818-Conf, and Request for Related Orders" (ICC-01/14-01/18-851-Conf), which contains five different requests pertaining to the alleged defective notice of alibi. While the Prosecution's filing is primarily titled as a Response to the Yekatom's Notification Pursuant to Rule 79 of the Rules of Evidence, it is also titled as a Request and contains a number of reliefs against the Defence.
