Dear Trial Chamber V,

Pursuant to the "*Decision on the Prosecution Requests for Formal Submission of Prior Recorded Testimonies under Rule 68(3) of the Rules concerning Witnesses P-1962, P-0925, P-2193, P-2926, P-2927, P-1577 and P-0287, and the Ngaïssona Defence Motion to Limit the Scope of P-2926's Evidence*", ("the Decision") the Chamber ordered, *inter alia*, the Yekatom Defence to file a public redacted version of ICC-01/14-01/18-903-Conf within one week of notification of the Decision.

After reviewing our filing ICC-01/14-01/18-903-Conf, we consulted the Ngaïssona team and the Prosecution to inquire as to whether or not they would oppose a request for reclassification of ICC-01/14-01/18-903-Conf from Confidential to Public.
