Dear Trial Chamber X, dear Colleagues,

On 24 June 2020, the Registry transmitted 209 applications for participation in the proceedings assessed by the Registry as complete and falling in Group A, in unredacted version, as Confidential *Ex Parte* annexes only available to the Registry and the Common Legal Representatives of Victims (see Registry First Transmission of Group A Victim Applications for Participation in Trial Proceedings, 24 June 2020, ICC-01/12-01/18-901).

The 209 applications were notified by the Court Management Section on 25 June 2020.

On 1st July 2020, it was brought to the attention of the VPRS that out of the 209 annexes filed, 8 pertain to information from a different case record and mistakenly replaced the application forms bearing the following reference numbers: a/20212/19, a/45281/18, a/45371/18, a/45397/18, a/45398/18, a/45424/18, a/45425/18 and a/45441/18. This is due to a technical malfunction which we will be exploring with the Information Security officer.

The Registry therefore respectfully requests the Chamber to authorise the reclassification of these annexes, ie annexes ICC-01/12-01/18-901-Conf-Exp-Anx15, ICC-01/12-01/18-901-Conf-Exp-Anx41, ICC-01/12-01/18-901-Conf-Exp-Anx79, ICC-01/12-01/18-901-Conf-Exp-Anx101, ICC-01/12-01/18-901-Conf-Exp-Anx102, ICC-01/12-01/18-901-Conf-Exp-Anx125, ICC-01/12-01/18-901-Conf-Exp-Anx126, ICC-01/12-01/18-901-Conf-Exp-Anx141, in order for the accesses to these annexes to be blocked to all recipients except to the VPRS, for VPRS to replace the files erroneously transmitted in the record of the Al Hassan case with the correct victim application forms.

The Registry, after this replacement, will request to the Chamber to authorise the reclassification of the newly uploaded correct annexes as Confidential *Ex Parte* only available to the Registry and Common Legal Representatives of Victims, following the initial classification level.
