The Defence refers to filings ICC-01/12-01/18-1120-Conf-Exp filed 21 October 2020 and ICC-01/12-01/18-1137-Conf-Exp filed 2 November 2020.

The Defence is in the process of preparing its response to these filings ('Response') and pursuant to the below email from Trial Chamber X dated 21 October 2020, the Response is due next Thursday 12 November 2020.

Pursuant to Regulation 35(1) of the Regulations of Court, the Defence requests an extension of time for filing the Response to the following day, being **Friday 13 November 2020**.

There is good cause for the Chamber to grant this extension because the Defence is currently managing:

- ❖ a number of competing deadlines, as the Defence's responses to ICC-01/12-01/18-1131-Conf and ICC-01/12-01/18-1136-Conf are due on 9 November 2020 and 13 November 2020 respectively;
- ❖ a lengthy period of examination of an important witness (P-0065), with the Defence's cross-examination to commence next week during the period in which the Defence will be finalising this response;
- ❖ preparations for Mr. Al Hassan's medical examinations with the Panel of experts (which have included complicated logistical arrangements with the Registry and require the Defence to prepare and support Mr. Al Hassan with the process); and
- ❖ extensive recent disclosure from the Prosecution (including Rule 77 packages 88, 89, 90, 91, and 92 disclosed between 29 October 2020 to 6 November 2020, INCRIM package 101 disclosed on 29 October 2020 and reclassification to INCRIM package 15 disclosed on 4 November 2020) which requires the Defence's review in anticipation of cross-examination of Witness P-0065 and which includes:
