Dear Counsel, dear colleagues from the Registry,

The Chamber takes note of the emails on the submission of evidence following the examination of P-0884 by the Yekatom Defence (*see* attached email from the Yekatom Defence, 23 July 2021, at 12:31), the Ngaïssona Defence (*see* attached email from the Ngaïssona Defence, 23 July 2021, at 15:19) and the Prosecution (*see* below email from the Prosecution, 23 July 2021, at 15:38), as well as the Defence's responses to the Prosecution's email (*see* below email from the Yekatom Defence, 26 July 2021, at 16:59; email from the Ngaïssona Defence, 26 July 2021, at 18:11).

At the outset, the Chamber notes that the following items included in the parties' emails have already been recognised as formally submitted:

The Chamber recalls that it is not necessary to re-submit items that have already been recognised as formally submitted.

The Chamber notes the Ngaïssona Defence's objections to the submission of items CAR-OTP-2023-1863 (a video) and CAR-OTP-2122-9401 (its transcript), which were used during the Prosecution's re-examination of the witness. In this regard, the Chamber recalls that 'the question of whether an item used during re-examination was also mentioned on the examining party's initial list of material is not, as such, determinative as to whether the item can be submitted into evidence'. Indeed, and while in principle, parties should avoid using items during their questioning which are not included in their lists of material, parties may, in the context of re-examination, refer to items which were not included on that party's list, provided they were duly disclosed to the other parties (see Decision on Submitted Materials for P-2251, email from the Chamber, 1 July 2022, at 14:16).

Accordingly, noting that the video and its transcript were mentioned by the Prosecution during the re-examination of P-0884 (see T-058, p. 95, lines 7-16), and considering that there are no further reasons which would preclude it from recognising the items as submitted, the Chamber recognises items CAR-OTP-2023-1863 and CAR-OTP-2122-9401 as formally submitted.

Regarding the Ngaïssona Defence's objections to the submission of item CAR-OTP-2113-0664, which the Prosecution mentioned during its direct examination, the Chamber reiterates that, in principle, parties should indeed avoid using items during their questioning which are not included in their lists of material. Noting that the Prosecution explained during the hearing that it mentioned the item's ERN 'just for the Chamber's edification' without intending to use it with the witness (see T-054, p. 38, lines 13-16), the Chamber rejects the Prosecution's request to formally submit item CAR-OTP-2113-0664 by email through P-0884.

In addition, the Chamber observes that three more items included in the parties' emails (CAR-OTP-2001-0357, CAR-OTP-2127-4504 and CAR-OTP-2107-2960) were also not included in their lists of materials and that the requests for submission have nonetheless been unopposed.

With regard to CAR-OTP-2001-0357, included in the Prosecution's email, the Chamber notes that this item was mentioned by the Prosecution during the re-examination of P-0884 (see T-058, p. 93, line 24 to p. 94, line 7) and for the same reasons as indicated above in relation to CAR-OTP-2023-1863 and CAR-OTP-2122-9401, recognises this item as formally submitted.

With regard to item CAR-OTP-2127-4504, included in the Prosecution's email, the Chamber notes that the Prosecution did not mention this item during P-0884's testimony. However, noting that this item is a transcript of video CAR-OTP-2066-5312, already recognised as formally submitted and which was mentioned by the Prosecution during the hearing (see T-056, p. 86, lines 8-10), and further noting that both the video and the translation of the transcript (CAR-OTP-2127-4593) are included in the Prosecution's list of materials, the Chamber recognises item CAR-OTP-2127-4504 as formally submitted.

Likewise, and with regard to CAR-OTP-2107-2960, included in the Defence teams' emails, the Chamber notes that none of the Defence teams, which now seek its submission, mentioned this item during P-0884's testimony. However, noting that this item is a transcript of video CAR-OTP-2023-1812, which was mentioned by the Defence during the hearing (see T-057, p. 67, lines 13-25; T-058, p. 57, lines 17-25), and further noting that both the video and the translation of the transcript (CAR-OTP-2118-5597) are included in the Prosecution's and the Ngaïssona Defence's lists of materials, the Chamber recognises item CAR-OTP-2107-2960 as formally submitted.

Finally, with regard to CAR-OTP-2098-0200, for which the Ngaïssona Defence only requests the submission of '[r]ows 305, 384-387 (associated with [REDACTED], the Chamber notes that this item consists of an Excel spreadsheet containing [REDACTED] and the corresponding metadata. In light of the nature and scope of this item, compared to the extent to which it was used during P-0884's questioning, the Chamber is of the view that it would be more appropriate to seek its formal submission

through a bar table application. Therefore, without prejudice to its ruling on any bar table request, the Chamber rejects the Ngaïssona's request to formally submit this item by way of email through P-0884.

Dear Trial Chamber V,

Pursuant to paragraph 63(2) of the *Initial Directions on the Conduct of the Proceedings* and pursuant to rule 64 of the Rules of Procedure and Evidence, the Defence presents the following observations:

- 1) The Defence objects to document **CAR-OTP-2113-0664** (#26 on the Prosecution list (i) below) being formally through P-884. Not only was this document - evoked during examination-in-chief - not included on the Prosecution's list of materials, the Prosecution specifically indicated during the hearing that this item was not on its list of evidence because it did not intend to use it with the witness, ie. it was only "for the Chamber's edification" (RT Transcript T-54, page 46, lines 15-19). For these reasons, its formal submission should be rejected.
- 2) The Defence objects to the formal submission of video **CAR-OTP-2023-1863** and its transcript **CAR-OTP-2122-9401** (#7 and #29 on the Prosecution list (i), below). The video in question, which was not on the Prosecution's list of evidence, is an extensive press conference given by then-President Catherine Samba-Panza lasting 45 minutes, and the Prosecution referred to a few seconds' excerpt, in passing, during its re-examination (see RT Transcript T-58, page 110, lines 15-25). The element of surprise, combined with the extensive nature of this video which addresses several topics upon which the witness was not questioned, and for which the Defence could not prepare in advance, would render the submission of the video and its transcript prejudicial to the fundamental rights of Mr Ngaissona. As such, its formal submission through P-884 should be rejected.
