Dear Trial Chamber,

The Defence for Mr Ngaissona wishes to make a request in relation to the printing of physical binders to be used at trial. It has come to the Defence's attention that there are a number of documents which the Defence repeatedly refers to during its cross examination of witnesses. These documents have been properly disclosed to the parties and participants, uploaded onto e-court and officially submitted. The contents of these documents are also well known to the Chamber, parties and participants due to their repeated use in the courtroom. However, the Defence finds itself making physical copies of these documents over and over again, with every witness it examines, which consumes a lot of time and resources.

The Defence requests to be exempted from printing documents which have already been officially submitted. If this request is granted the Defence would continue to include these documents in its list of materials, its e-Binder and the documents can also be displayed in Court during the Defence's examination.
