Dear Counsel,

The Single Judge intends to reclassify to public, or issue a lesser redacted public version of the Confirmation Decision (ICC-01/14-01/18-403-Red-Corr).

For this purpose, the Prosecution is instructed, in consultation with the other participants and the VWU, to indicate by 10 March 2021 whether the applied redactions can be lifted. Should redactions need to be maintained, the Prosecution is instructed to (i) indicate, by way of filing, why these redactions remain justified, and (ii) highlight these redactions in the text of the confidential version of the Confirmation Decision and annex it to its filing.

The Prosecution is further ordered to file (i) a lesser redacted public version of its Document Containing the Charges by 17 March 2021 and (ii) a public redacted version of its Trial Brief by 31 March 2021, or to request their reclassification to public.
