Regarding outstanding Defence responses to the various Rule 68 motions that have been filed in recent days by the Prosecution, we respectfully make the following proposal to the Trial Chamber. The Defence

would like to respond orally to Prosecution motions #564 and #574 (respectively, fourth and fifth applications under Rule 68(3)) next week. These motions relate to a total of nine witnesses.

In addition, the Defence would propose responding orally to Prosecution motion #578 (application under Rule 68(2)(c), which relates to a further five witnesses.

It is submitted that such an approach would result in an overall saving of time since the Trial Chamber will be fully briefed well before the current deadline of 14 February, certainly insofar as our responses to #574 and #578 are concerned. Furthermore, this approach would free up Defence time to address the multiple applications made pursuant to Rule 68(2)(b). At present, our intention is to use our best efforts to file responses without having to ask for an extension of time.

We hope this suggestion will find favour with the Trial Chamber. For the sake of completeness, we ought to point out that our response to motion #564 is due next Monday. If the Chamber is minded to permit an oral response, but the schedule does not allow us to get to it on Monday, we will have to formally request a short extension of 1 day.

The Chamber has taken note of the parties' and participants' suggestions.

As regards the items proposed by the common legal representatives, in particular items 2 and 2b (allocations of costs), the Chamber considers these are matters within the purview of the Registry and the legal aid provisions. As regards topic 2a (Contact Protocol), the Chamber reiterates that the pre-trial protocol remains in place and will continue to apply until a standardised protocol is adopted (T-17, p. 29, lines 19 *et seq.*; T-18, p. 50, lines 15 *et seq.*). Moreover, the Chamber notes that the parties and participants were provided with the opportunity to comment on the current protocol and that particularly as regards filing 553 of the Defence, no responses were filed within the set deadline. Accordingly, these items will not be included in the agenda.
