Dear Colleagues,

The Defence of Mr Abd-Al-Rahman is anticipating the need of extending the page-limit of 12 pages to the regular 20 pages limit under Regulation 37(1) of the RoC. The reason for that request is that Application ICC-02/05-01/20-580-Conf covers 21 witnesses and is 36-pages long. It is thus not possible to answer it usefully in 12 pages.

Our colleagues in OTP have already agreed to such requests for extension within Regulation 37(1) limitation.

We would be grateful if the Trial Chamber could authorize the requested extension. Should we find that we need an extension beyond the 20-pages limit, we may apply for a further extension accordingly, but 20-pages is estimated as sufficient at this juncture.
