Dear Trial Chamber,

The Defence is about to finalize its Response to OTP Application ICC-02/05-01/20-624-Conf, which will be filed today.

The Response is exceeding the 12-pages limit by one or two pages. The reason for this is the number and complexity of issues addressed in the application, which was 14-pages long. The ICC case law authorizes extensions of page limits to respond to motions for which an extension of page limit was granted ([ICC-01/04-01/07-1314](#), par. 5-6). The OTP already confirmed that it would not object to extension of page limit not exceeding the normal page limit of 20 pages under Regulation 37(1) of the RoC.

The Defence therefore hereby seeks authorization pursuant to Regulation 37(2) of the RoC to exceed the limit of 12 pages for its Response and file a Response not exceeding 14 pages.
