[REDACTED], the VWU met with witness P-0736 for the purpose of an in-court protective measures assessment. He stated that although he feels safe in his place of residence, he is concerned about the security of his relatives that [REDACTED], should his testimony before the Court become public.

The VWU considers it prudent that the witness testifies with procedural protective measures to ensure that he will not be identified as a result of his testimony before the Court.

The VWU recommends the following in-court protective measures be granted:

- o image and voice distortion;
- o use of pseudonyms;
- o use of closed and/or private session when needed; and
- o redaction of any identifying information from the Court's records before dissemination to the public.

Finally, the VWU recommends that the witness should not be asked to read or write anything in the courtroom and should be provided with reading assistance.

The Chamber instructs the parties to provide their views on the VWU's recommendations by **COB today**.

The VWU explained to the witness the various procedural protective measures that the Court may implement to mitigate risks that may stem from his testimony before it; he requested that the VWU request the Court to consider granting him procedural protective measures to hide his identity.
