Dear Trial Chamber V,

The Defence of Mr Patrice-Edouard Ngaissona ("Defence") respectfully requests leave to add one document ("Document") to its List of Materials to be used during the examination of witness P-0889. While the Document will be disclosed on eCourt tomorrow, a courtesy copy thereof is attached for the benefit of the Chamber, as well as of the parties and participants. The Defence submits that the sought addition is warranted in order to shed light on information provided by witness P-0889 during the Prosecution's examination on CAR-OTP-2127-3304 (item 38 of the Prosecution's List of Exhibits). The Defence was not able to foresee the Prosecution's line of questioning on CAR-OTP-2127-3304, a document which is of general nature and vast in content, especially given that the Prosecution had not indicated the excerpts it intended to focus on during P-0889's examination. Henceforth, relevance of the Document only became apparent during the Prosecution's examination.

The Defence submits that granting its limited request will contribute to the Chamber's truth seeking mandate, while causing limited prejudice to the parties and participants, if any.
