Dear Trial Chamber X,

Following P-0127's inability to appear to testify before the Chamber this week (26 to 30 April 2021), the Prosecution requests that the Chamber allow a change in the upcoming schedule as follows:

- The Prosecution proposes that P-0127 appear to testify on Friday 28 May 2021. The Prosecution envisages that it will require approximately one session (1.5 hours) for P-0127's examination in chief, rather than the three hours the Prosecution had originally estimated. As a result, it should be possible to conclude P-0127's testimony on the same day.
- If P-0127 is heard on 28 May 2021, the next Prosecution witness, namely P-0150, would begin testifying on Monday 31 May 2021.
