12 The International Criminal Court is now in session.
13 Please be seated.

15 Appearances. Defence, please.
16 MR LAUCCI: [9:34:20](Interpretation) Good morning, your Honour, your Honours,
17 dear colleagues. The same composition as yesterday. Mr Abd-Al-Rahman is in the
18 room and Iain Edwards is participating from a distance.
19 PRESIDING JUDGE KORNER: [9:34:33] Yes, Prosecution.
20 MR NICHOLLS: [9:34:36] Good morning, Madam President, good morning,
21 your Honours. The same as yesterday.
22 PRESIDING JUDGE KORNER: [9:34:39] And victims.
23 MS VON WISTINGHAUSEN: [9:34:43] Good morning, Madam President,
24 your Honours. Anand Shah, our visiting professional, Charlotte Imhof and myself,
25 Natalie von Wistinghausen for the participating victims.

1 PRESIDING JUDGE KORNER: [9:34:58] Thank you very much.

2 I have asked for the witness just to be kept out of the room, just to raise a couple of
3 matters.

4 Firstly, Mr Nicholls, I don't know how long you are going to be, but because we all
5 anticipated the witness would finish in one day, one of our number has got an
6 appointment which they can't miss, so we will finish at 11 and, if necessary, start
7 again at 2. So, I mean that's the way it will work. I mean, do you think you'll be
8 going up to the break, anyhow?

9 MR NICHOLLS: [9:35:33] I think I can try to do it in an hour.

10 PRESIDING JUDGE KORNER: [9:35:38] Right. Well, don't worry, because that's
11 the next thing I want -- I want to say.

12 Mr Laucci, just so you know, unless I'm mistaken, because it's not on the list, the
13 Prosecution don't intend to ask the witness about the second video. As I explained
14 when we showed the first video to the first witness, the video is part of the evidence
15 that is before the Trial Chamber, but we've had not a great deal of evidence about it.
16 And this man, firstly, was in the CRF and secondly, obviously, knows Mr Al-Rahman.
17 And it seems to me that as we're enjoined to receive as much evidence which is
18 relevant to issues in the case so that the truth can be established, we really need to
19 know what this witness is going to say -- would say about the video.
20 You didn't show it to him, it doesn't look as though the Prosecution are going to, so
21 the Judges are going to. But what I suggest we do is, in the same way as last time,
22 before you re-examine, when the Prosecution have finished so that you can ask any
23 questions which arise out of that. I hope that's clear.

24 MR LAUCCI: [9:37:02] Very clear, Madam President, and I did not need to receive
25 explanation or justification from the Chamber on the questions that he intends to ask

4 So I thought this time I'd give you any chance to do that again.

5 MR LAUCCI: [9:37:27] To be exactly clear, my objection was against the use in
6 cross-examination, not against the use by the Bench.

8 That's very helpful, Mr Laucci.
9 All right, well, let's have the witness back in again.

13 Q. [9:43:52] (Microphone not activated)

14 Sorry, I didn't have my mic on.

15 Witness, I'm going to take you back to something you testified to under oath

16 yesterday. This is page 34, lines 14 to 20.

17 You were asked by Mr Laucci: "Do you know yourself what 'Janjaweed' are?"

18 And your answer was: "I heard about the Janjaweed from a distance but I did not

19 know what they were. I don't know them."

20 Question from Mr Laucci: "What did you hear about the Janjaweed, sir?"

21 Answer: "I heard people say the word Janjaweed, but I did not know what it means."

22 Question: "Were you curious, you have no idea what this word means?"

23 Answer: "No."

24 Do you remember saying that yesterday?

25 A. [9:45:03] No, I don't know this. I don't know.

- 1 Q. [9:45:10] Okay. Then on the next page 35, you were asked, line 7:
2 "[...] did you hear about [any] attacks in 2003 and 2004?"
3 Answer from you: "What attacks?"
4 Question from Mr Laucci: "Attacks on the villages in Wadi Salih, for instance?"
5 And your answer was: "No."
6 Do you remember saying that yesterday?
7 A. [9:45:42] Yes, I said that yesterday. And the attacks, I heard about these attacks
8 from afar, but I -- I didn't witness anything in person.
9 Q. [9:45:57] Well, what you said yesterday was:
10 "Did you" --
11 The question was:
12 "[...] did you hear about attacks in 2003 and 2004?"
13 "What attacks?"
14 "Attacks [on the] villages in Wadi Salih, for instance?"
15 And your answer was: "No."
16 That's what you said yesterday, that's my question, right?
17 A. [9:46:24] Yes. True.
18 Q. [9:46:26] Okay. Once again, I'm going back to your statement which we've
19 established you said you were truthful in and that you had time to check.
20 Paragraph 27, you were asked just a couple of months ago about the defence by the
21 Janjaweed. And you said:
22 "I never saw [the] Janjaweed in Garsila although I had heard of Janjaweed in other
23 parts of Darfur. By Janjaweed, I understand this term to mean thugs and thieves,
24 criminals who robbed and killed innocent people. I never heard Uncle Ali mention
25 the Janjaweed or Fursan or Mujahidin."

1 So, sir, this is just another example of you not being able to keep your story straight,
2 isn't it? You testify under oath here yesterday that you don't know what the word
3 "Janjaweed" means. Two months ago, you understand the term to mean thugs,
4 thieves and criminals who robbed and killed innocent people.

5 Why did you tell the Judges you don't know what the word "Janjaweed" means?

6 A. [9:47:46] The word "Janjaweed" was a word used by people and I was able to
7 hear the word in the radio -- on the Radio Dabanga, on Radio Dabanga and on TV,
8 but I didn't witness this myself and I didn't know them. Yes, there were some thefts
9 and looting and thugs, but I don't know if they -- they were the Janjaweed who were
10 doing this or other people.

11 Q. [9:48:23] Right. So when you said to the Judges yesterday that you had no idea
12 what the word means, you were not being truthful, were you?

13 A. [9:48:37] I was telling the truth.

14 Q. [9:48:43] You also said in your statement:

15 "Of course" --

16 This is at paragraph 28:

17 "Of course, in 2003-2004 I heard that villages in Darfur were attacked by the
18 Janjaweed. I did not witness any such attacks myself. I just stayed in Garsila.
19 When I spent time in Mukjar during my service with the CRF, I heard that Mukjar
20 and villages in Wadi Salih had been attacked by the Janjaweed some years earlier and
21 that people had been robbed and killed."

22 A. [9:49:26] (No interpretation)

23 Q. [9:49:28] Wait for the question. Wait for the question.

24 Yesterday you said to the Judges under oath:

25 Question: "[...] did you hear about attacks in 2003 and 2004?"

2 Question: "[About] attacks of villages in Wadi Salih, for instance?"

3 Answer: "No."

4 Once again, you weren't truthful to the Judges in your testimony yesterday, were
5 you?

6 A. [9:50:03] I speak the truth, the truth. And about the -- those attacks in Garsila, I
7 heard about these, I heard about these, that they were committed by the Janjaweed
8 and the thugs, but I never witnessed this.

9 Q. [9:50:24] Well, I'll move on, sir, but that's not what your statement says and it's
10 not what your testimony says. Your testimony yesterday was that you never heard
11 about this. That was not true, correct?

12 I'm not asking you whether you witnessed it.

13 A. [9:50:39] Well, as I mentioned, I heard about the Janjaweed, but they do not exist
14 in -- inside Garsila. I only heard about them.

15 Q. [9:51:03] Did you hear about mass executions in Wadi Salih? Not about attacks.
16 About mass executions where many people, say a hundred, over a hundred people
17 taken out and murdered.

18 Did you hear -- not see, did you hear about that?

19 A. [9:51:29] No, I did not hear.

20 Q. [9:51:32] Okay. You never heard that there was a mass execution in Mukjar?

21 A. [9:51:43] No, I didn't.

22 Q. [9:51:44] You never heard there was a mass execution just outside Deleig?

23 A. [9:51:53] No, I never heard about that.

24 Q. [9:51:57] You're hearing about that today for the first time from me?

25 A. [9:52:06] Yes, from you. I never heard about this. If I -- if I ever heard about it,

1 I would have told you immediately.

2 Q. [9:52:14] All right. But you did hear -- you told me that yesterday at page 96
3 that you did hear about the *sheikh* from your neighbourhood, Dikobi, *Sheikh* Ismail,
4 being taken out and killed in Deleig. You did hear about that, right?

5 A. [9:52:39] I heard that he was killed, but who killed him, I didn't know.

6 Q. [9:52:44] And you had no idea till today when I'm telling you that he was killed
7 in a mass execution outside Deleig?

8 A. [9:52:55] No, I didn't know. Whether he was killed in a mass execution or
9 elsewhere, I don't know.

10 Q. [9:53:01] I should have said in connection with the executions in Deleig.
11 All right, you lived in {ICR: (Redacted)} when you were a boy, your father was {ICR:
12 (Redacted)}, right?

13 {ICR: (Redacted)}

14 MR NICHOLLS: [9:53:25] Sorry, that should maybe be redacted.

15 Q. [09:53:26] You served in Bindisi in the CRF for a period?

16 A. [9:53:41] For six months approximately.

17 Q. [9:53:42] And during that six months in Bindisi, did you ever learn that the town
18 you were in, the area you were in, Bindisi, had been attacked and burned down in
19 2003?

20 A. [9:53:59] Yes, it was burnt in 2003, I heard it from people but I never witnessed
21 that. I was very young, I didn't know anything.

22 Q. [9:54:11] Well, you weren't that young. You were in the CRF serving as
23 a policeman.

24 A. [9:54:21] In 2003, I was not. I was not in the CRF.

25 Q. [9:54:26] Okay. I'm talking about when you were serving in the CRF, when

1 you were a policeman/soldier in the CRF. Yesterday you said as part of your duties
2 in the CRF, you were in Bindisi, right?

3 A. [9:54:44] Yes, I was in Bindisi, but at that time --

4 Q. [09:54:45] Stop.

5 A. [09:54:48] -- it was safe.

6 Q. [9:54:52] Stop, stop. You answered my question when you said yes.

7 Now, while you were in Bindisi in the CRF, did you learn about the attack on Bindisi
8 in 2003?

9 A. [9:55:06] Yes, I heard, but I didn't know anything about that.

10 Q. [9:55:11] Okay. So once again, when you said yesterday you hadn't heard
11 about any attacks in Wadi Salih, that wasn't true, was it?

12 A. [9:55:23] Wadi Salih is big, there is -- there is Bindisi in Wadi Salih, there are
13 other areas.

14 PRESIDING JUDGE KORNER: [9:55:34] Sorry, Mr Nicholls.

15 In 2003, you were in Garsila you told us, that's right, isn't it?

16 THE WITNESS: [9:55:43](Interpretation) Yes, I was.

17 PRESIDING JUDGE KORNER: [9:55:46] During the course of 2003 and indeed in
18 2004, weren't there refugees coming to Garsila from the various places that had been
19 attacked?

20 THE WITNESS: [9:56:00](Interpretation) Yes, there were refugees.

21 PRESIDING JUDGE KORNER: [9:56:05] And you never heard from any of the
22 refugees or from anybody who had spoken to them that their villages had been
23 attacked, burnt, looted? Nothing like that?

24 THE WITNESS: [9:56:23](Interpretation) I heard from people, but I didn't witness
25 myself.

1 PRESIDING JUDGE KORNER: [9:56:36] Okay. So you did hear that these villages
2 had been attacked, burnt, and looted?

3 THE WITNESS: [9:56:42](Interpretation) Yes.

4 PRESIDING JUDGE KORNER: [9:56:53] Thank you.

5 Yes, sorry, Mr Nicholls.

6 MR NICHOLLS: [9:56:56]

7 Q. [9:56:57] Do you know what the accused Mr Abd-Al-Rahman is accused of in
8 this case? Do you know what incidents and crimes he was charged with, or do you
9 have no idea about that?

10 A. [9:57:14] I don't know anything about these crimes.

11 Q. [9:57:19] Okay, listen to the question. I'll put it a different way. Do you know
12 that the man who, you know, very well became your father, in effect, do you know
13 what he is accused of in this trial? Do you know what crimes he is accused of?

14 A. [9:57:41] Well, I heard, but I don't know anything about him.

15 Q. [9:57:54] So --

16 PRESIDING JUDGE KORNER: [9:57:57] I'm sorry, Mr Nicholls, that answer wasn't
17 clear. I think you better ask the question again.

18 MR NICHOLLS: [9:58:03] Yes, okay, I was going to just move on, but --

19 Q. [9:58:10] Do you know what crimes Mr Abd-Al-Rahman, the accused in this
20 case, is charged with? Do you know what he is on trial for?

21 A. [9:58:25] Sorry, these crimes I don't know anything about, these -- the ones he's
22 charged -- Mr Ali Abd-Al-Rahman is charged with. I heard from people, but I don't
23 know anything about...

24 Q. [9:58:45] Okay. Let me continue.

25 Do you know that he's been charged with mass executions in Mukjar?

2 Q. [9:59:01] Okay, and did you also hear that he's been charged with the mass

4 A. [9:59:10] I also heard about that, but I didn't see.

5 Q. [9:59:15] Okay, you didn't see it. It also means that about five minutes ago,
6 when you said you were hearing about those mass executions from me for the first
7 time today, you weren't telling the truth.

8 A. [9:59:30] I said the truth.

9 Q. [9:59:35] Okay. You were stationed in Mukjar with the CRF, right? After
10 you -- after you completed your training, right?

11 A. [9:59:47] Yes. Yes, true.

12 Q. [9:59:54] And your job there was as a driver?

13 A. [9:59:59] Yes, true.

14 Q. [10:00:01] Okay. There's a road -- I mean, you know that area well, obviously.
15 You've lived there and you've driven there. There's a road going from Mukjar to
16 Garsila. It goes through Nyerli, right?

17 A. [10:00:16] Excuse me?

18 Q. [10:00:20] Could we have tab --

19 A. [10:00:25] I'm sorry. I didn't hear.

20 Q. [10:00:27] Okay. Well, let's bring up tab 20. That might help.

21 It's DAR-OTP-0220-4739. And, your Honours, that's a map in the map book of the
22 Mukjar area.

23 Okay, I'm going to show you a map now, sir. And I know that you have -- you
24 know, you don't read and write well, but you must be able to read maps to some
25 extent if you're a driver and you don't have a smartphone with GPS.

1 So can you recognise this here? The town on the -- the big town on the bottom right
2 is Mukjar, and above it along the road we see Nyerli.

3 Do you recognise this area, sir?

4 A. [10:01:28] I know Mukjar and Kassa (phon), but I don't know anything about
5 this map.

6 Q. [10:01:49] Okay. Do you know there is a road from Mukjar that goes north to
7 Nyerli?

8 A. [10:01:57] I never went in this road. I never saw this road.

9 Q. [10:02:06] Okay, so you've lived in this area since -- your entire life. You've
10 been stationed at Mukjar. You're a driver. You've never driven on this main road
11 from Mukjar to Nyerli? You've never driven down that road?

12 A. [10:02:29] To Nyerli? No, I didn't drive in this road. I usually go from Mukjar
13 to Garsila and Bindisi, and from the other side, Artala.

14 Q. [10:02:48] Okay. I'm going to ask you a different way. Let's try to move
15 along.

16 You were stationed in Mukjar. You're a driver in that area. You know that there
17 was a UNAMID base built there, not in 2003 and '04, after that, there was a UNAMID
18 base just north of Mukjar, right?

19 A. [10:03:13] Yes, yes. The UNAMID base, I know that. It's there.

20 Q. [10:03:20] Okay. And you have driven by that location where the base is,
21 right?

22 A. [10:03:27] Yes.

23 * Q. [10:03:28] All right. And that's also where there's a *khore* that is called Khor
24 Talaba; right?

25 A. [10:03:46] Khor Talaba?

1 Q. [10:03:49] Yes. It's also sometimes called Khor UNAMID. You know that
2 (Overlapping speakers) --

3 A. [10:03:55] Yes, I heard. Yes, I heard about Khor Talaba, yes, the UNAMID *khor*,
4 yes.

5 Q. [10:04:05] And you know, don't you, that that is the site of a mass execution and
6 a mass grave, where over 100 men were murdered in 2004?

7 A. [10:04:30] No, I only heard about that now from you. That there is a mass
8 grave in this *khor*? No, I didn't hear about that, only now from you.

9 Q. [10:04:44] So you're in Mukjar, serving in the CRF, you're a policeman and you
10 don't know about this mass grave that you have driven by, by the UNAMID base; am
11 I correct?

12 A. [10:05:03] I used to drive by it, but I didn't hear about it. I don't know anything
13 about it -- I didn't hear about a mass grave there.

14 Q. [10:05:17] Right. And then I take it you also haven't heard that the other name
15 for that horrible execution site is "Khor Kushayb"?

16 A. [10:05:33] Khor Kushayb? I didn't hear this name.

17 Q. [10:05:45] You didn't hear it ever from anyone while you were there afterwards
18 that that *khor*, that execution (Overlapping speakers)

19 A. [10:05:54] I heard this name, but -- I heard that name, but Khor Kushayb, no. I
20 never heard this name. Only now from you.

21 Q. [10:06:11] Okay.

22 PRESIDING JUDGE KORNER: [10:06:12] I'm sorry. What did you mean when you
23 said, "I heard this name"?

24 THE WITNESS: [10:06:25](Interpretation) I heard the name "Kushayb". I heard it
25 on TV, I heard it on the Dabanga radio, but I don't know that there is a *khor* called

1 Khor Kushayb. As I said before, I heard this name "Kushayb" before, but I don't
2 know anything about it.

3 MR NICHOLLS: [10:06:59]

4 Q. [10:07:00] Now, sir, so while you were there serving in the CRF, driving the
5 accused, Uncle Ali, he never said to you, "Let's go by this *khor*. It's a mass grave
6 site"?

7 A. [10:07:30] Never. Never. He was in Mukjar -- he wasn't with me in Mukjar.
8 In Mukjar, I was driving a military vehicle. He wasn't with me. He was -- we used
9 to change our base every six months -- sometimes in Mukjar, sometimes in Bindisi,
10 sometimes in Garsila, sometimes in Artala. When I was in Mukjar, he wasn't with
11 me, so he didn't tell me anything about that. No, I didn't hear about this at all.

12 Q. [10:08:04] Okay, well, again, I'm going to have to bring you back to your
13 statement. And I'm a little confused, because at paragraph 26 of your statement,
14 your truthful double-checked statement, you say:

15 "As mentioned above, I was in the CRF from 2005 to 2017. During that time, I was
16 assigned {ICR: (Redacted)}

17 There's nowhere in your statement where you say, "I was with him and drive him
18 everywhere except for Mukjar".

19 A. [10:08:50] Yes. I was not a personal driver to him. I was working in the
20 government. I was working in the CRF and then when he used to come, he would
21 say to me, "I need to go on a certain mission," or, "Come and drive me to my home,"
22 or something like that.

23 I was not driving his private car, I was driving a military vehicle that he used to use
24 for his missions.

25 Q. [10:09:35] Yes. Just to be clear, so you don't have to say that again, if I ever ask

1 you about driving him, I am talking about you driving when -- in the CRF period, I'm
2 talking about you driving him in a government car, okay. Do you understand?

3 A. [10:09:58] Understood.

4 Q. [10:10:09] All right. You said yesterday, I think at page 52, something about
5 how -- when you -- before you went to Rahad al-Berdi in 2011, you came there from
6 Khartoum. Do you remember that?

7 A. [10:10:29] I was in Khartoum and I was in Zalingei. And then I went to
8 Khartoum, and then from Khartoum to Rahad al-Berdi in 2011.

9 Q. [10:10:41] Okay, thank you very much. And how long were you in Khartoum?

10 A. [10:10:46] I was in Khartoum for about three months, and, after that, I went to
11 Rahad al-Berdi.

12 Q. [10:10:57] Okay. So was that in 2010 or '11? It doesn't matter if you do not
13 remember, but was it 2010 (Overlapping speakers)

14 A. [10:11:07] I don't -- I don't remember exactly.

16 warrant for your President, President Omar Al-Bashir; right?

17 A. [10:11:29] I heard about it on TV.

18 Q. [10:11:35](Overlapping speakers) I'm not asking if you witnessed it. Okay, you
19 heard about it on TV. And that was big news, right; everybody knew about that --
20 the President being issued an arrest warrant by a foreign court?

21 A. [10:11:53] Correct.

22 Q. [10:11:54] And, similarly, you heard about the arrest warrant for Raheem
23 Muhammad Hussein, who was the minister of the interior, effectively your boss;
24 there was also an arrest warrant for him, right?

25 A. [10:12:16] I didn't hear about Abdel Raheem Muhammad Hussein. I heard

14 A. [10:13:43] Yes, I heard. I heard about that from the Dabanga radio and I heard
15 people also talking about this.

16 Q. [10:13:52] Right. So when you heard about the arrest warrant for Ahmad

18 same arrest warrant, your Uncle Ali?

19 A. [10:14:10] I heard about these names but I don't know anything about them.

13 time that you heard about an arrest warrant for anybody named Ali Kushayb or

16 I don't know. I don't know but I heard this piece of news.

17 PRESIDING JUDGE KORNER: [10:17:04] Well, can you tell us in which town you
18 were when you heard it? Were you still in the CRF?

19 THE WITNESS: [10:17:17](Interpretation) I was in Nyala, I was in Nyala.

20 PRESIDING JUDGE KORNER: [10:17:22] Yes, were you still in the CRF?

21 THE WITNESS: [10:17:26](Interpretation) No. I left it in 2017. I was just a civilian
22 at the time.

24 Q. [10:17:35] Sir, well, let me try to remind you by reading what you said

18 know anything about them.

20 when you were in the CRF?

21 A. [10:20:41] No, nobody talked to me about this same talk.

22 Q. [10:20:57] Right. And the whole time you were driving him,
23 Mr Abd-Al-Rahman never said, "You know there's an arrest warrant for me, they're
24 calling me Ali Kushayb, but I'm innocent"?

25 He never said that to you, right?

9 "Alternatively, Musa Al-Bashir Musa, a member of the Legislative Council for
10 South Darfur State and a notable Salamat, revealed that the hostilities perpetrated by
11 the militia leader wanted by the International Criminal Court, Ali Kushayb, had
12 restarted yesterday in the [Fanduq] area, in the district of Rehed al-Birdi, and that
13 they constituted a clear breach of the two agreements of Umd Dukhn (between the
14 Salamat and Misseriya) and of Rehed al-Birdi [...]"

15 And I'll stop reading there.

16 It then says:

17 "On Radio Dabanga" -- that's your station -- "Musa announced that Ali Kushayb, who
18 commands the Abu-Tirah Forces, attacked the area and the surrounding villages with
19 15 armoured Land Cruisers, reinforced by Military Intelligence Services' troops under
20 the Sudanese army."

21 Now the commander of those forces was Ali Muhammad Ali Abd-Al-Rahman,
22 commander of the Abu-Tirah, right?

23 A. [10:26:56] No, not attacks. From our camp, we did not attack anybody. This
24 is not correct.

14 Q. [10:28:34] You never heard Mr Abd-Al-Rahman called Ali Kushayb, it was on
15 Radio Dabanga at the time you were in the CRF, and it stated that your commander,
16 the commander of the Abu-Tirah forces in Rahad al-Berdi was Ali Kushayb?
17 You never heard that?

18 A. [10:29:10] No, I didn't hear this name. I know that the commander was Ali
19 Muhammad Ali Abd-Al-Rahman.

13 Sir, this is another article, again from your station, Radio Dabanga, dated 17 April
14 2013.

15 Now, do you remember the time around mid-April 2013 when 250 Salamat families
16 left Rahad al-Berdi and went to Nyala? Yes or no; do you remember that
17 happening?

18 A. [10:34:33] I know this, they left Rahad al-Berdi and they went to Nyala. I saw
19 them, I witnessed this personally.

21 If we could go to the next page of this document.

22 And did you hear about it on the radio at the time as a kind of a big thing?

24 Q. [10:35:08] Did you hear about the 250 Salamat families leaving at that time?

25 Did you hear about it on the radio or in the media?

5 their homes had been burned of the Salamat, and some of the shops looted in Rahad
6 al-Berdi, right?

8 a tribal problem between the Salamat and the Ta'aisha, which I -- I don't know about
9 the cause of this conflict. But there was -- yes, there was a conflict, a tribal conflict
10 and people left from Rahad al-Berdi to Nyala.

11 Q. [10:36:24] Right. And the people who left -- the Salamat left because they were
12 scared, right?

13 A. [10:36:32] They must have been scared because that was a tribal issue.

24 So I'm not sure what you want us to reconsider at all. It's simply -- we haven't
25 rejected it outright, I think is the only way of trying to put it.

1 MR LAUCCI: [15:01:27] Well, the request is precisely that this specific document
2 should not be considered as submitted.

3 PRESIDING JUDGE KORNER: [15:01:35] Right. And for the reasons -- do you
4 want to add to the reason -- I mean, the Prosecution in their response have pointed
5 out to you, as they do every time, the test for reconsideration. Do you want to add
6 anything to that?

7 MR LAUCCI: [15:01:55] No. There is nothing I want to add. As you can see and
8 appreciate, this was a very quick made by email instead of a proper motion and
9 everything. Well, we considered that this was the most straightforward way of
10 dealing with that issue, because -- I mean, these emails that we received about the
11 submission of documents and -- well, we just followed the procedure instead of
12 making a very comprehensive submission. We left it to that. I think that's -- the
13 point is very straightforward. This document, the Office of the Prosecutor tried to
14 submit it to the witness, we objected. This objection, this is our understanding, was
15 accepted and instead it was a question that was asked, actually, by you,
16 Madam President, to which the witness replied. So there is no room here for that
17 document in that sequence of the cross-examination.
18 That's our point.

19 PRESIDING JUDGE KORNER: [15:03:08] But, as I say, if -- I understand your
20 arguments about those and those are all arguments that we'll take into consideration
21 at the end of the case. But it is very different, isn't it, from a situation where we did
22 prevent the Prosecution, in fact, using the document because we said they'd failed to
23 disclose it at the proper time.

24 But this is simply one where, at the end of the day, isn't it, we decide whether or not
25 it's a document that -- it's clearly relevant to the case. The question is whether it

5 accept it, at this stage, I mean. The whole -- obviously to me it's still a slightly new
6 system of documents just coming in.

7 MR LAUCCI: [15:04:43] Yes. Well, the answer is very -- is very simple, is that the
8 way the cross-examination unfolded and as it is reflected in the transcript, this
9 document was not used, and for that reason, we considered that it cannot, according
10 to the conduct of proceedings, it cannot be considered as submitted because it was
11 simply not.

12 Well, for the relevance of the document, I will reserve my comments on that for later.

13 PRESIDING JUDGE KORNER: [15:05:19] Well, you can't say it's not relevant to an
14 issue, but, in fact, as I recall, you did object, as the conduct of proceedings goes - or
15 Mr Edwards objected, who seems to have disappeared - but to documents that the
16 Prosecution proposed to use, and we made rulings at that stage.

17 This was one of the ones where we said they were entitled to show it. And once
18 they've shown it and it's reflected on the record, it's a bit difficult, isn't it, if we don't
19 have it there, to go back and see what on earth everybody's talking about.

20 MR LAUCCI: [15:06:04] Well, we believe, once again, the way the cross-examination
21 unfolded at this moment in time, I don't think there is any record to complete. The
22 question was asked to the witness, it was answered and without any linkage to that
23 document that the Prosecutor proposes to submit.

6 We will obviously give the matter consideration and we'll -- reconsideration, and

7 we'll give a ruling again, as everything was done by email, we'll give it by email.
