24 A. [9:35:45] Well, I don't remember that quite clearly. I cannot recall the hour.

9 "We left for Pajule at about 3 or 4 a.m, and we attacked at about 6 a.m."

10 Is that what you said, Mr Witness?

12 Q. [9:36:58] Would you say the same today? Is this correct?

13 A. [9:37:05] It's correct.

11 Q. [9:50:38] Besides being abducted to carry food items, did anything else happen
12 to the civilians in Pajule attack?

13 A. [9:51:07] Well, for that, that I cannot tell because people were divided into
14 various groups, we were actually two different groups and different people had
15 different intentions. There could have been some who killed some civilians and
16 those who didn't kill possibly.

17 Q. [9:51:36] I'm only interested in what you saw, Mr Witness, at this point. Did
18 you see any civilians die in Pajule when you were there at the market?

19 A. [9:51:54] Yeah, there were -- there was some civilian deaths, but I cannot recall
20 who exactly killed them.

21 Q. [9:52:07] You told us, Mr Witness, that the other group went to the barracks.
22 Did they -- if you know, did they stay at the barracks the entire time of the attack?

23 A. [9:52:40] Those who went to the barracks were shooting at the soldiers. After
24 shooting at the soldiers and when the military aircraft came, they had to retreat
25 because the Holy feared the army aircraft. There were those who were abducting

2 A. [9:55:37] There were two gunships. They came, but when they saw there
3 were so many civilians, they couldn't bombard.

4 Q. [9:55:51] And where were the two groups now, were they together or were
5 they still apart, the two groups that you told us attacked in the Pajule? Were you all
6 together now or not?

7 A. [9:56:11] One group just came and joined the other because at the time the
8 gunship came people got scared and they started moving.

9 Q. [9:56:30] And where did you go?

10 A. [9:56:44] We went to an RV where we had agreed to meet.

11 Q. [9:56:51] What is an RV, Mr Witness?

12 A. [9:57:01] RV is a meeting point, a place where it had -- where other people
13 should *meet together with members of the group, whether women or children, or a
14 place that has been agreed upon to be a meeting point. For instance, a place where
15 Odomi would have remained because as standby they would give us instructions on
16 where to go and meet the rest of the people after the operation.

17 Q. [9:57:44] Do you know the location where this RV was?

18 A. [9:57:56] It was on the eastern side, but I cannot recall the exact place.

19 Q. [9:58:10] And what happened at this RV?

20 A. [9:58:19] When we arrived at the RV, then the civilians were told to put down
21 their items.

22 Q. [9:58:43] And did they put down their items?

23 A. [9:58:52] Yes. All of them put down their items.

24 Q. [9:58:58] What happened with the items?

25 A. [9:59:09] The civilians were released and were instructed to move in a line as

3 me what happened with (Redacted)

5 A. [9:59:33] The items were distributed to the people, some were given to the
6 group that I was in. The other standby from the other group when with some items
7 as well. Odomi's group went with some items. And Otti's group also went with
8 others.

9 Q. [10:00:06] Who distributed the items?

10 A. [10:00:14] These items -- well, there was a commander who was -- who was
11 with Odomi, who was under Odomi -- in Odomi's group who was called Opige.
12 I don't know from the other group the name of the commander, but they were the
13 ones who distributed the items. Most times they move together and they're the ones
14 who identify soldiers to move with. So I don't know how they distributed.

15 Q. [10:01:02] You told us, Mr Witness, that the civilians were released. Were all
16 civilians released?

17 A. [10:01:21] Yes, all civilians were released, with the exception, with the
18 exception of the younger ones. The younger ones were held back. But the older
19 ones were released.

20 Q. [10:01:36] When you say "The younger ones were held back," what does that
21 mean?

22 A. [10:01:50] Young children, the younger children from 15, 16, 17. Those ones
23 were held back and distributed in the other groups.

24 Q. [10:02:11] What groups did they stay with?

25 A. [10:02:25] Some of the children went to Otti.

2 A. [10:02:49] I believe there was one who was probably younger than 15. I think
3 he was perhaps 12 or 13. Was a young girl.

4 Q. [10:03:03] What group did she stay with?

5 A. [10:03:14] I do not recall which group she was placed in. I'm not sure.

6 Q. [10:03:24] You said earlier, Mr Witness, that you saw some civilians dead in
7 Pajule. Can you just tell me what location that was in Pajule?

8 A. [10:03:56] The civilians died close to the roadside.

9 Q. [10:04:09] The roadside close to where? To the market or elsewhere?

10 A. [10:04:20] Yeah, the roadside going towards the market.

11 Q. [10:04:26] When you were fighting in Pajule, Mr Witness, did you yourself see
12 Odomi there?

13 A. [10:04:44] No, I did not see him.

14 MS HOHLER: [10:04:50] Your Honours, if I may now request a private session for
15 just one question.

9 MS HOHLER: [10:09:03]

10 Q. [10:09:07] I now want to ask you questions, Mr Witness, about another attack
11 on a camp you mentioned you went to, and that is the Odek camp. Do you know
12 what person ordered the attack on Odek?

13 A. [10:09:34] It was our commander. It was Odomi.

14 Q. [10:09:42] And how do you know that?

15 A. [10:09:46] Because he was overall commander of that group and nobody else
16 in that group could issue orders, so the -- they consulted and instructed the orders.
17 They also instructed the person who was overall commander of the group that was
18 going to Odek.

19 Q. [10:10:20] Did you actually hear the order or not?

20 A. [10:10:31] I saw them huddle together where the commanders were huddled
21 together. As an escort I was by the side, so each commander would come, they
22 would place a seat and the person would sit down next to Odomi. So there was
23 nobody else that went close to him except for the commanders. And that's what I
24 saw.

25 Q. [10:11:01] Who were these commanders that you saw, as you say, consulted

2 A. [10:11:14] Lapwony Okello and Lapwony Okello Kalalang and Lapwony

3 Bomek. There were others present but I do not recall their names.

4 Q. [10:11:50] The first Lapwony Okello that you mentioned, is this the deputy of

5 Odomi, the same Okello as you called was the deputy to Odomi on Friday?

6 A. [10:12:11] Yes, it is.

7 Q. [10:12:14] And you told us that they consulted and instructed the others -- the

8 orders my transcript says. What was the instruction for this attack?

9 A. [10:12:49] Well, I do not recall the instructions, because all I heard was when
10 they said they should select a standby.

11 Q. [10:13:04] Who is "they", Mr Witness?

12 A. [10:13:15] The person in charge of selecting standbys was Kalalang.

13 Q. [10:13:37] Did Kalalang or anyone else say why you should attack Odek?

14 A. [10:13:54] No, I do not recall the explanation.

15 Q. [10:14:00] Who told you the target was Odek?

16 A. [10:14:30] The -- our commander.

17 Q. [10:14:38] Who do you mean by "our commander"?

18 A. [10:14:47] We went with Bomek.

19 Q. [10:15:11] I'm trying to understand, Mr Witness. Was Bomek your
20 commander for this attack?

21 A. [10:15:25] Bomek was the 2IC, but I do not recall the overall commander. I do
22 not recall the name.

23 MS HOHLER: [10:15:45] Your Honours, if I can refresh the witness's memory on
24 this point?

5 of putting the name to the witness. If you look at the second part.

6 MR TAKU: [10:18:03] May it please your Honours, I think when my colleague
7 applies to refresh the memory, the paragraph must answer the specific question or
8 refresh his memory pursuant to a specific question that was asked. If not so, she
9 could ask another question or rephrase. If she intends to refresh memory with this
10 specific paragraph in mind, she can do so, but to ask the question and refresh the
11 memory of something that does not specifically address the question asked, your
12 Honour, would be unfair.

22 Q. [10:19:24] Did you take any weapons, did the group take any weapons for this
23 attack, Mr Witness?

- 10 THE WITNESS: [10:21:33] (Interpretation) Well, the Holy do not go in great
- 11 numbers to combat, but the largest number is probably 30 to 35.

- 14 Q. [10:21:54] What location were you at this point, Mr Witness, if you can
- 15 remember?

- 21 moved and other people joined. The standby went and the convoy group also
- 22 followed because we were instructed -- we were instructed at the RV where we were

- 25 A. [10:23:50] The -- it's the overall -- it's the overall commander who is instructed

1 on the location of the RV, so it's Odomi issued those instructions, told us that we
2 would meet at a particular RV after the mission. After the camp, come back and find
3 us at this RV. They do not actually tell junior soldiers where the -- the location of the
4 RV. It's only the overall commander who is given the specific location of the RV.

5 Q. [10:24:35] Did you hear Odomi say this?

6 A. [10:24:46] Yes, I heard him say that. He said, "Once the standby leaves, once
7 the standby goes, you will meet us at the RV." He was instructing the commander,
8 the commander who was going with us on -- who was going on the standby.

9 Q. [10:25:11] Did he give -- did Odomi give any other instruction at this point?

10 A. [10:25:29] He instructed that any soldier who goes to a civilian home, any -- a
11 thirsty civilian should not drink water without first dropping in some shea butter.

12 Q. [10:25:55] Did he give any instructions what to do if you encounter civilians or
13 soldiers in Odek?

14 A. [10:26:21] No, I do not recall that. Yes, he did give us instructions, but I do
15 not recall those instructions. There were other instructions telling us that "If you
16 abduct any girl, you should not have sex with that girl."

17 Q. [10:26:52] Was this part of the instruction before the Odek attack?

18 A. [10:27:05] Yes. We were told, "Do not eat civilian food. If you find any food,
19 do not eat it."

20 Q. [10:27:19] And again, who told you that? So we're clear for the record.

21 A. [10:27:29] He told the 2IC, the 2IC that selects people, and then the 2IC informs
22 us. His 2IC, for example, Okello, his deputy.

23 Q. [10:27:50] How long did it take you to reach Odek?

24 A. [10:28:07] I do not recall the exact time it took us. I was still young at the
25 time.

9 Q. [10:37:31] Did you see anyone else die at the centre in Odek?

11 when I was still young.

11 inform the government soldiers about the location of the LRA and that would
12 jeopardise their position in Gulu. They were in the bush at the banks of Aswa river.

13 Q. [10:55:48] Who ordered the civilians to be killed?

14 A. [10:56:02] Well, I am not sure who issued the order, but I only saw when the
15 civilians were being killed, because they would direct the soldiers where the LRAs
16 were, and I suspect that should have been from our overall commander because no
17 other person could issue orders other than our overall commander.

18 Q. [10:56:38] Who killed these civilians?

19 A. [10:56:50] The civilians were killed by the seasoned soldiers, they were more
20 seasoned than us because we were part of the people who had just gone to Sudan.

21 There are two categories. There is one of very seasoned soldiers, these are the ones
22 you could have found there in the bush, you also pay allegiance to that category.

19 A. [11:38:39] It was our overall commander.

20 Q. [11:38:44] Can you remind us of his name again, please.

21 A. [11:38:58] Odomi was our overall commander and he is the one who issued
22 instructions to Okello to select a standby.

23 Q. [11:39:08] Did you hear the order by Odomi?

24 A. [11:39:18] No, I did not. But to my knowledge there was no other overall
25 commanding officer than Odomi and Odomi had all authority.

5 soldiers come together, line up in threes and then a standby is selected.

6 Q. [11:40:25] Who blows the whistle?

7 A. [11:40:37] Lapwony Okello.

8 Q. [11:40:39] How many soldiers were selected for the attack on Abok, if you can
9 remember?

10 A. [11:40:50] They're not that -- not that many people. If I hazard a guess, I
11 suppose maybe 20 or 28 because it wasn't a great number of people. When LRA are
12 going to combat they do not take a large number of people. According to the LRA if
13 there is a large number of people going to combat, then many people will be injured
14 or killed, but the less the number of people the less likely they are to get injured or
15 dead.

16 Q. [11:41:33] Who was the commander for this attack?

17 A. [11:41:45] It was Bomek.

18 Q. [11:41:47] Do you remember the names of any other soldiers that went as part of
19 the standby to Abok?

20 A. [11:42:06] I recall there was Oyet, Oyet Tongwok (phon). And there were other
21 soldiers. I do not recall all their names.

23 Did the group take, did the standby take any weapons with them to Abok?

11 were at the border of the camp, before the entrance of the camp.

14 at the camp. We also started using *the twelve and the soldiers ran and entered into

14 A. [12:07:29] He was badly injured. He was actually carried away.

17 a stretcher and we used it for carrying him.

18 Q. [12:08:02] What happened to this injured man later?

6 PRESIDING JUDGE SCHMITT: [12:23:28] Please continue.

7 MS HOHLER: [12:23:31] Thank you, your Honours.

8 Q. [12:23:33] And just so we are clear, Mr Witness, when we are talking about
9 Okello, is this the same Okello as you mentioned was the deputy to Odomi or
10 a different Okello?

11 A. [12:23:54] There were two different Okellos, there was Okello Kalalang and then
12 Okello Wod Lango.

13 Q. [12:24:05] So the Okello Odomi gave the order to for the attack on Bar-Rio,
14 which Okello was that?

15 A. [12:24:17] That was Okello, Okello Wod Lango.

16 Q. [12:24:27] And what was his position or his role in Sinia?

17 A. [12:24:38] I am not very clear about his role, but what I kept on seeing was the
18 fact that he was Odomi's deputy.

19 Q. [12:24:51] Who gave orders to this Okello?

20 A. [12:25:02] That was Dominic.

21 Q. [12:25:05] Did Okello receive orders from anyone else but Dominic?

22 A. [12:25:19] There were other commanders who *were following Okello in their
23 positions, there were also others who were down in the chain of command.

24 Q. [12:25:36] But speaking generally, would anyone else be able to give orders or
25 did anyone else give orders to Okello, but Odomi, that you know of?

1 A. [12:25:54] Odomi was the overall commander and there were other leaders or

6 order given by Odomi to Okello, what was it? What was it that was ordered for that
7 attack?

9 unleash havoc in the camp by burning houses and killing the people.

10 Q. [12:27:11] Who selected the soldiers for the attack?

11 A. [12:27:23] It was Okello. He was the one who blew the whistle and people

13 Q. [12:27:36] How many people came and lined up, approximately?

14 A. [12:27:48] There were so many soldiers, because they were coming from various
15 section and each of the sections was represented there and thereafter they started
16 identifying the soldiers. They would only look for the seasoned soldiers because if
17 you had not reached Sudan, you were not considered a seasoned soldier.

18 Q. Who was the commander for this attack?

19 A. [12:28:31] Well, I cannot recall that.

20 Q. [12:28:38] You mentioned earlier a soldier named Bomek in your group,
21 Mr Witness. What was -- where was Bomek during this time?

23 Q. [12:29:00] And what was his role in this attack, if you can remember?

24 A. [12:29:16] He was, I think, he was the overall.

17 Q. [12:31:27] When you say "most death" who are you referring to? Who was it
18 that died? What people died?

19 A. [12:31:40] Civilians, civilians died there.

20 Q. [12:31:47] How did they die?

21 A. [12:31:55] They were, they were killed. Orders had been issued to kill. We
22 were told that whenever we attacked any camps civilians must be killed.

23 Q. [12:32:11] Who issued these orders?

24 A. [12:32:22] It was the commander.

25 Q. [12:32:27] What's his name?

6 MR TAKU: [12:33:15] May it please, your Honours. Sound procedure demands
7 that at the time the evidence is being led, especially evidence relating to uncharged
8 locations, the Defence is the one that can interject an objection. Obviously it's left to
9 your Honours to allow any evidence at any time to be led. But it's also our duty that
10 if we fail to raise this objection or to place on record that this evidence is being led
11 under protest by the Defence, it would be irresponsible on our part.

12 Secondly, your Honours, when Mr Gumpert and the others led evidence they tried at
13 least to get the witness to situate the attack, the time frame, which is a material issue
14 here. But so far since the witness is starting we have found that there have been
15 absolutely no attempts, even if the witness could not, they tried to use major events
16 that they pleaded either in the indictment or in the pretrial brief in order to at least to
17 give an idea. This we do not have. And this goes to a material issue, your Honours,
18 about the specificity of the evidence being led or the charges which we have raised
19 previously and which we will raise and raise again when it occurs. And we just
20 want to place on record, it is within your power to allow any evidence to be lead.
21 We do not intend to disrupt the proceedings, but we just want to place that on record
22 at this point in time.

23 PRESIDING JUDGE SCHMITT: [12:35:04] Do you want to respond to, that,
24 Ms Hohler?

25 MS HOHLER: [12:35:08] I do, your Honours. A couple of points I want to make on

1 that objection. First, the evidence of this attack is relevant for establishing the

6 Thirdly, on the time frame, your Honours, we have not yet come to the end of this
7 examination, if I may point out. And the witness has stated a couple of times that he
8 was very young when he was with the LRA and he does not remember dates and
9 years very well. Therefore we have not pressed on that issue for that reason.

10 PRESIDING JUDGE SCHMITT: [12:36:05] Thank you very much.

11 MS HOHLER: [12:36:05] Thank you.

12 PRESIDING JUDGE SCHMITT: [12:36:07] I think we don't have to respond to that
13 again. Of course the Chamber is aware of the charged -- not only of the charged
14 issues but especially on the confirmed charges. That's perfectly clear. But beyond
15 the strictly confirmed charges there are of course elements of the crimes that have to
16 be also taken into account, plus, as Mrs Hohler has said, there might be charges that
17 go beyond the four attacks that might also be of relevance.

18 So we duly noted your objection, but as you see, we allow that this evidence is
19 brought into court and we will see what comes out of it. Of course it would be good
20 to have a time frame, but I understand what you have said. I don't know if you will
21 give it a try in the end, but we would not press on it.

22 Please continue.

17 attack from Odomi himself?

18 A. [14:39:25] Like I said, there was no one else who could issue orders other than
19 the commander, because he was the one who was well conversant with Gulu side.

20 MS HOHLER: [14:39:41] Where I'm getting with this, your Honours, is something
21 that is contained in the witness's statement. It is related to his role, which is the
22 question I asked earlier, and about this instruction, so I would apply if I can refresh

4 PRESIDING JUDGE SCHMITT: [14:42:59] And that, Mrs Hohler, because if we
5 look back to what the witness has said, sometimes there was mentioned a certain age
6 that you would qualify as, yes, young or not and sometimes it was children,
7 sometimes it was young people. So this is the reason why I have sustained it.

8 MS HOHLER: [14:43:22] Perfectly understood, your Honour. Let me try
9 differently, maybe mentioning specific ages then.

10 PRESIDING JUDGE SCHMITT: [14:43:33] Or simply saying "young people".
11 "Young people" I think is something you could say.

12 MS HOHLER: [14:43:40] I will bear that in mind, your Honours.

13 Q. [14:43:43] Who made these rules about abducting children, Mr Witness?

14 A. [14:44:02] It was the leader himself. The children are not necessarily very
15 young people like infants, but these young people are actually people of between 13
16 to 18 years of age. Some could be 16, others are 17.

17 Q. [14:44:23] And when you say "the leader himself," who do you mean?

18 A. [14:44:35] That is Mr Dominic giving such orders. He would say we should
19 not abduct any elderly person because the elderly persons really know -- are really
20 mature and they know their way back home, they will be able to escape, but the
21 young people will not be able to escape and go back home.

22 Q. [14:44:57] Did you hear Dominic give such orders?

23 A. [14:45:07] I heard. He said they should not abduct elderly persons. There
24 was one day when we were in Gulu in a place called Position Ngwana (phon).

25 Q. [14:45:27] Have you heard of the term "kadogo" when you were in the LRA,

1 Mr Witness?

2 A. [14:45:40] I heard about kadoge.

3 Q. [14:45:46] What does that term mean? Who was referred as kadoge?

4 A. [14:45:58] A kadogo, these are children between 13 and 15. These are
5 children with very unkempt hair because in the LRA all the soldiers should be
6 uniformed and they would have dreadlocks.

7 Q. [14:46:30] Were there kadoges in Odomi's group?

8 A. [14:46:43] Yes, they were there.

9 Q. [14:46:45] What did the kadoge do when the group went on attacks, for
10 example?

11 A. [14:46:59] The kadoge were also part of the very seasoned soldiers. They are
12 people who were abducted while still very young, but grew up in the bush and they
13 were very dangerous people, that is why they insisted they should abduct young
14 people.

15 Q. [14:47:22] And what would kadoge do during attacks?

16 A. [14:47:38] They are just meant to cause grievous harm to people and loot items
17 like goats, chickens and all that, they would also be engaged in the fighting.

18 Q. [14:47:50] And who gave them these tasks?

19 A. [14:48:05] The tasks depended on how the standby members were identified.
20 If you are identified as part of the standby, you will just know you are now a soldier,
21 whether you are young or old. So long as you have a gun you know you are already
22 a soldier. So that task of a soldier does not -- does not segregate whether you are
23 young or old, you are all soldiers.

24 Q. [14:48:36] How many kadoge were in Odomi's group if you're able to
25 estimate?

1 A. [14:48:52] There were many young kadoge. I cannot figure out the number.

2 There were actually many short kadoge and these were young people who were
3 abducted.

4 Q. [14:49:09] Thank you, Mr Witness. We'll move to another topic now.

5 PRESIDING JUDGE SCHMITT: [14:49:15] May I ask something.

6 Mr Witness, you have said there were short kadoge. Can you explain what you
7 mean by that?

8 THE WITNESS: [14:49:31] (Interpretation) The short kadoge are the young
9 people who were abducted when they were still young; for instance, when you're
10 abducted at 12, because of the weight you've been carrying you will not grow tall, you
11 will just remain stunted. These are the ones who are called kadoge.

12 PRESIDING JUDGE SCHMITT: [14:49:53] Mrs Hohler.

13 MS HOHLER: [14:49:56] Thank you.

14 Q. [14:49:58] Mr Witness, you've already mentioned on Friday and earlier today
15 about girls in Odomi's household and with other leaders. What were the rules in
16 Sinia about women who were abducted?

17 A. [14:50:27] Women who were abducted they were saying if a woman has
18 not -- if a man has not been initiated, such a man is not supposed to have a woman
19 because you are still considered a soldier. But if you're initiated using the shea
20 butter and water and a woman is given to you, that is when you can now begin
21 having that woman as your wife.

22 Q. [14:51:02] Who in Sinia had wives, Mr Witness?

23 A. [14:51:14] The people who had women were Odomi, Okello also had a wife,
24 Odoki also had a wife and Okello Kalalang also had a wife, and other commanders
25 whose names I cannot recall also had wives.

1 Q. [14:51:49] Did you have a wife, Mr Witness?

2 A. [14:51:57] No, I didn't have one.

3 Q. [14:52:03] Did every soldier have a wife?

4 A. [14:52:15] The soldiers who would be given wives depended on how long
5 somebody had stayed in the bush. This would be a trusted person because they say
6 this is somebody who can already be assigned or delegated to go and carry out a task,
7 for instance, to go and lay an ambush or go and carry out any other operation that the
8 other commanders assign, these are people who could be given wives, but it requires
9 that you should have stayed in the bush for a while and not any other -- not anyone
10 just get like that.

11 Q. [14:52:55] How many wives could a soldier have?

12 A. [14:53:07] There was no soldier other than Odomi who had wives. Most of
13 the soldiers would get one wife each.

14 Q. [14:53:23] Do I understand you correctly that it's only Odomi who had more
15 than one wife?

16 A. [14:53:32] Yes, it was Odomi who had wives. He had about four or five
17 wives in his household, other than the girls who were also within his households,
18 under his care.

19 Q. [14:53:51] We will come to talk about Odomi's household in a little while, but
20 at the moment I'm more interested in the wives with other commanders as well.
21 What were the tasks of these wives?

22 A. [14:54:14] The tasks of these wives included gathering grass to make beds,
23 cooking food, carrying the clothes of the soldiers.

24 Q. [14:54:35] Where would the wives sleep at night, Mr Witness?

25 A. [14:54:44] I have not understood that question.

1 Q. [14:54:48] In the night, where would the wives be sleeping? Would they be
2 sleeping with their husbands or away from their husbands?

3 A. [14:55:07] Whenever you're given a woman as your wife, because if I say "a
4 woman" I mean a wife. A girl who is given to a man sleeps together with a man to
5 whom she has been given.

6 Q. [14:55:28] Who gave the soldiers the wives?

7 A. [14:55:39] Odomi himself was the one giving women and he was the one who
8 knew the seasoned soldiers.

9 Q. [14:55:50] Did you see Odomi give wives to seasoned soldiers?

10 A. [14:56:02] Yes, I did.

11 Q. [14:56:07] Do you remember any particular occasion?

12 A. [14:56:17] I saw when he was giving a wife to a soldier called Odoki. He was
13 initiated. They sprinkled water on him, holy water, they sprinkled the water using
14 leaves and then a woman would be given to you.

15 Q. [14:56:44] Do you remember the name of this woman given to Odoki?

16 A. [14:56:55] I do not recall.

17 Q. [14:57:03] Do you know how old she was? Or can you estimate how old she
18 was and why do you think she was that old, if you know?

19 A. [14:57:19] She was between, she was a girl of about 15 or 16 years of age.

20 Q. [14:57:29] Besides the wives, were there any other women in Sinia?

21 A. [14:57:46] Yeah, they were the wives of the leader.

22 Q. [14:57:54] Besides the wives, Mr Witness, were there any women who were
23 not assigned as wives?

24 A. [14:58:12] Yes, they were there.

25 Q. [14:58:16] Where did these women stay?

1 A. [14:58:28] Some of them were at the dog adaki. They were already soldiers,
2 had guns and had uniforms. Others were girls who were still without anything,
3 they were in Odomi's household.

4 Q. [14:58:54] The ones in the dog adaki who had guns and uniforms, the girls,
5 how old were they?

6 A. [14:59:13] They were about 17 years.

7 Q. [14:59:23] We'll talk about Odomi's wives and girls in his household now,
8 Mr Witness.

9 Do you remember any of the names of Odomi's wives when you were there?

10 A. [14:59:46] I remember one I used to call Lapwony Min *Back because her child
11 was called Back.

12 Q. [15:00:04] Besides Min *Back, do you remember names of any other wives?

13 A. [15:00:16] There were other girls, one was called Adong, she also used to
14 reside at his household. There are others as well but I cannot recall all their names.

15 Q. [15:00:29] How old was Adong?

16 A. [15:00:42] Adong was approximately 16 or 17 years old.

17 Q. [15:00:45] Was she a wife or just a girl who stayed in Odomi's household?

18 A. [15:00:57] She was a girl -- she was one of the girls. She slept in a separate
19 tent. It was separate from the tent the commander slept in.

20 MS HOHLER: [15:01:16] Your Honours, the witness in his statement mentioned
21 one other name of a wife on which I would seek to refresh at this point.

22 PRESIDING JUDGE SCHMITT: [15:01:24] You can do that.

23 MS HOHLER: [15:01:25] It is at page 0256-0082, paragraph 62, the second sentence.

24 Q. [15:01:41] Mr Witness, I will again read to you a line from the statement you
25 gave to the ICC investigators. And it's about Odomi's wives and here is what it says:

1 "I remember one was called Min Back and another was called Margaret but I do not
2 remember the names of the others."

3 Is this what you said, Mr Witness?

4 A. [15:02:11] Yes.

5 Q. [15:02:14] Would you say the same today?

6 A. [15:02:20] Precisely.

7 Q. [15:02:25] Did Odomi's wives have children, Mr Witness?

8 A. [15:02:36] Yes, his wives had children.

9 Q. [15:02:40] What were the tasks of Odomi's wives? What did you see Odomi's
10 wives do when you were there?

11 A. [15:02:55] They didn't have -- Odomi's wives did not have any specific duties.
12 They would just stay within the group. There were times, for example, when there's
13 a gunship or when there's -- when soldiers are pursuing us they would be removed
14 from the group, they would be taken to the bay.

15 Q. [15:03:28] What is the bay, Mr Witness?

16 A. [15:03:36] The bay is a place where they keep injured people and mothers with
17 newborn babies.

18 Q. [15:03:50] Besides the wives, Mr Witness, you mentioned there were a number
19 of girls in Odomi's household as well. How many such girls were there?

20 A. [15:04:12] There were approximately six or seven girls.

21 Q. [15:04:22] What did these girl do in Odomi's household, what were their tasks?

22 A. [15:04:39] If food was prepared they are the ones who used to serve the food
23 and take it to the mess to the leader.

24 Q. [15:04:51] Who gave tasks to these girls in Odomi's household?

25 A. [15:05:05] It's the senior -- the senior wife, or Min Back. When food was

1 ready she would serve some food, pick up, select one of the girls and ask the girl to
2 serve the food. One of -- the girl selected would then bathe, make sure that she's
3 clean, and then take the food to the mess to the officers.

4 Q. [15:05:32] Besides serving food, did you see them do anything else?

5 A. [15:05:51] Other than serving food, if Dominic wants to rest he would tell them
6 that he has the holy spirit, the holy spirit with him. And if there is any girl that he
7 wants (Redacted)
8 (Redacted) and he would rest with that girl.

9 Q. [15:06:30] When you say "he would rest with this girl" what does that mean?
10 Can you explain to us?

11 A. [15:06:44] Well, that means that the girl would sleep with him, he would sleep
12 with the girl.

13 Q. [15:06:52] How often did Odomi ask you to fetch him a girl?

14 A. [15:07:15] Well, he would ask me to do that when, for example, he knows that
15 one of the -- one of his wives did not sleep with him. His bed was separate. He
16 would sleep separately from his wives. If he wants one of his other women, his
17 former women, then he would send me to get one of them. He would tell me "Go
18 and call such-and-such a person. Go and ask Min Back to come." And that's what
19 he would do.

20 Q. [15:07:52] Did any girl or wife refuse to go to Ongwen when you came to get
21 them?

22 A. [15:08:11] No, she won't refuse.

23 Q. [15:08:13] Why not? What would happen if they did?

24 A. [15:08:23] They won't refuse because that's the instructions from the
25 commander.

1 Q. [15:08:36] Could Dominic choose any other woman except the ones in his
2 household? Could he call a girl that would be staying with one of the other
3 commanders?

4 A. [15:08:59] No, he wouldn't call them.

5 Q. [15:09:04] Was there a rule about this, Mr Witness?

6 A. [15:09:17] I did not understand your question.

7 Q. [15:09:20] Was there any rule in the group that Odomi was not allowed to call
8 women staying with other commanders?

9 A. [15:09:41] The rules did not -- the rules prohibited this. Because once
10 somebody has been given -- someone has been given a girl and the person is in the
11 custody or in the hands of that commander, no other commander can then go and
12 take that girl away from his -- his colleague.

13 Q. [15:10:22] Was Odomi ever wounded when you were with him?

14 A. [15:10:39] Yes, he was wounded, he was wounded, he was shot in the leg.

15 Q. [15:10:45] Where were you when Odomi was shot in the leg?

16 A. [15:10:59] I was with him. We were in the same group. I was his escort.

17 Q. [15:11:07] Were you close to him when he got shot?

18 A. [15:11:16] We were behind. Most of the people had ran ahead. The two of
19 us had been left behind.

20 Q. [15:11:30] When you say "the two of us" who do you mean?

21 A. [15:11:40] Myself and another soldier.

22 Q. [15:11:46] Are you able to describe to us how Odomi got shot, what happened
23 that he got shot?

24 A. [15:12:00] A mamba shot him. We were crossing the road and we entered
25 into an ambush.

1 Q. [15:12:14] And what happened with him when he got shot? With Odomi,
2 when he got shot, what happened with him?

3 A. [15:12:29] He was shot, he was shot in the leg and he fell. Because they shot
4 his leg and his bones were fractured and he fell. We pulled him, and we pulled him
5 from the roadside and lay him somewhere because the soldiers were -- they were
6 firing. There were no soldiers, but it was an ambush. There was a mamba and
7 there was a buffalo. They fired at us and we ran, but we'd hidden him in the bush.
8 We ran, we got to a place, we started whistling to stop people.

9 Q. [15:13:13] Where did you run?

10 A. [15:13:21] We followed the rest of the group where the others had run. We
11 started whistling and people stopped. We told them that the commander has been
12 shot. They selected a standby to go and retrieve him.

13 Q. [15:13:44] And did the standby go and retrieve him?

14 A. [15:13:53] Yes, they did. They created a stretcher and put plastic wrapping
15 on it. And that's what they used to carry him.

16 Q. [15:14:06] Who selected the standby to retrieve Odomi?

17 A. [15:14:20] I do not recall his name.

18 Q. [15:14:22] Were you part of the standby that went to retrieve Odomi?

19 A. [15:14:30] Yes, I was.

20 Q. [15:14:34] Do you remember any other soldiers in the standby that went to
21 retrieve Odomi?

22 A. [15:14:47] No, I do not recall.

23 Q. [15:14:50] Can you describe to us how you retrieved him?

24 A. [15:15:03] We went, they selected people. Some people went and stopped at
25 the roadside, and while they were preparing the stretcher, we told them where we'd

1 hidden the commander. We found that he was bleeding. He was placed on the
2 stretcher and carried. And we started walking.

3 Q. [15:15:36] Where did you walk with him?

4 A. [15:15:45] We walked towards where -- we walked to where everybody was
5 waiting. People were waiting for us. We met up with the convoy. They took us
6 to the bay.

7 Q. [15:16:09] And where did Ongwen stay? Where did Dominic Ongwen stay
8 while he was wounded?

9 A. [15:16:22] He was in the bay, he was in the Gilva bay. That's where we were
10 taken.

11 Q. [15:16:37] How long did Dominic Ongwen stay in the bay after this injury in
12 the leg?

13 A. [15:16:52] He stayed in the bay for approximately three months.

14 Q. [15:16:59] Where did you stay when Dominic Ongwen was in the bay?

15 A. [15:17:14] We stayed at the bay as well. Two of us were told to take care of
16 him as well as Min Back.

17 Q. [15:17:26] Do you remember any other people from your group that stayed
18 with Dominic in the bay besides those you've just mentioned?

19 A. [15:17:46] There was a soldier, he was a support soldier. He was in charge of
20 the PK, and two signallers.

21 Q. [15:18:02] Who was in charge of Odomi's group while he was wounded and in
22 the bay?

23 A. [15:18:17] There was Lapwony Okello and Kalalang.

24 Q. [15:18:29] You mentioned two signallers stayed with you at the bay. Do you
25 remember their names?

1 A. [15:18:48] If I recall correctly, one was Odongo. I cannot remember the name
2 of the other one.

3 Q. [15:19:09] And what is the job of the signallers, Mr Witness?

4 A. [15:19:22] The signallers are responsible for taking care of a commander. If
5 we are -- if the group is moving or if we are being pursued by soldiers, they were to
6 carry the commander and run with him, because he was being carried on a stretcher.
7 So there was -- bay soldiers, people in the bay, were usually stationary. Sometimes
8 we would stay in one position for approximately one week, because we had to stay
9 quiet, we did not want the soldiers to know our whereabouts.

10 Q. [15:20:05] When you say you did not want the soldiers to know your
11 whereabouts, are you talking about the government soldiers?

12 A. [15:20:18] Yes, government soldiers.

13 Q. [15:20:23] After his leg had healed, after those three months in the bay, where
14 did Dominic Ongwen go?

15 A. [15:20:38] We went back to the rest of the -- we joined the rest of the group.

16 Q. [15:20:52] We move to another short topic, Mr Witness.

17 You told us about the signallers, and on Friday you told us, and I will cite the
18 transcript reference, it is transcript 51, realtime, page 88, lines 16 and 17. You said:
19 "Odomi was the one who would talk on the radio."

20 Who did Odomi talk to on the radio, Mr Witness?

21 A. [15:21:35] I cannot -- I do not know exactly who Odomi spoke to on the radio
22 because there were a number of commanders. On other occasions, he's speaking to
23 Kony, other times he's speaking to Otti Vincent and others times with Raska Lukwiya.
24 There were a number of commanders and there were so many different groups.

25 Q. [15:22:02] Did you hear him speak on the radio?

1 A. [15:22:11] Well, there are times when I was the one who had to place the chair.

2 I would place the chair, the radio call would be set up and he would begin speaking.

3 Q. [15:22:27] How often would he speak on the radio?

4 A. [15:22:39] On a day, average, he would speak about five or six times. In the
5 evening by around four to five, he would be on the radio.

6 Q. [15:23:08] What language was he speaking when he was talking on the radio?

7 A. [15:23:24] He would speak the psychology. He would speak in jargon, jargon
8 that we, the junior soldiers, did not understand. He would speak in -- he would
9 speak in the way that they had been taught how to speak.

10 Q. [15:23:50] That's enough about the radio for now, Mr Witness.

11 What was the most important rule, Mr Witness, in Odomi's group? What was the
12 most important rule?

13 A. [15:24:13] The most important rule was not to have sexual intercourse with
14 women. And when you're drinking water, if you -- you're not supposed to drink
15 civilian water, you're not supposed to eat civilian food. If you've gone to loot, for
16 example, if you go to loot a centre, you should always have money on your person.
17 So even if you find -- you should not have money on your person, if you go and find
18 whatever amount of money, whether it's in the millions you should take that money
19 and give it to the commander.

20 Q. [15:25:05] Who taught you about the rules in Sinia?

21 A. [15:25:22] I was taught about the rules when I was newly abducted and that's
22 when I was informed. One of the rules, the first rule, was when I was beaten as
23 a -- my initiation into the army, I was beaten with a wire lock and that was one of the
24 first rules that I learnt. And that was Mujahideen who gave me that advice.

25 Q. [15:25:54] And what was this rule that you learned while you were beaten?

1 A. [15:26:08] I was told -- first, I was smeared with shea butter. You smeared
2 shea butter on the dorsal side of your palms and on the palm side, you are smeared
3 with shea butter on your chest, on your feet and on your forehead, and then they start
4 reading the rules: One, if you go to a civilian home, don't eat civilian food; if you
5 find water, don't drink the water. You're usually given a small bottle with shea
6 butter in it and you're told that "if you get to a civilian home and you're extremely
7 thirsty, pour some of the water from the small bottle we've given you into the civilian
8 water before you drink it."

9 Q. [15:27:03] Was there any rule about escaping in Odomi's group?

10 A. [15:27:19] There were rules. You're told that if you escaped -- once you've
11 been smeared with shea butter, if you escape, once you get shea butter on your feet,
12 because there's some people who try to escape at night, if you escape at night you
13 walk in circles and come back to where the people are. As soon as you get caught,
14 you're killed.

15 Q. [15:27:54] What happened to people who broke the rules, Mr Witness? Not
16 just the escape rule, but any rule, what happened to them?

17 A. [15:28:14] As long as you break any of the rules, sometimes you're shot.
18 Other times if, for example, you drink civilian water without putting your own water,
19 you'd be shot by a bullet. If you sleep or have sexual intercourse with any -- with a
20 woman or any girl and do not disclose this, when you go to battle, you'll be shot,
21 you'll be shot in your penis.

22 Q. [15:28:58] You said, Mr Witness, "as you break any of the rules, sometimes
23 you're shot". For breaking what rules was the punishment being shot?

24 A. [15:29:24] If you have sexual intercourse with a girl and it becomes
25 knowledgeable, you're shot.

1 Q. [15:29:36] Who are you shot by?

2 A. [15:29:48] Anyone. Any of the veteran officers can shoot you.

3 Q. [15:29:54] Veteran officers within the LRA?

4 A. [15:30:04] Yes.

5 Q. [15:30:09] Who ordered the punishments in Odomi's group?

6 A. [15:30:23] I did not understand the question properly.

7 Q. [15:30:29] When a soldier broke a rule in Odomi's group and he was supposed
8 to be punished, who ordered that he be punished?

9 A. [15:30:47] It depends on your position. If you're in -- whether you're in A coy
10 or B coy or in the operation room, then there's a commander in charge of all those
11 different positions.

12 Q. [15:31:13] Just to make sure I understand you correctly, Mr Witness, it would
13 be the commander who's in charge of that position that ordered the punishment?

14 A. [15:31:28] Yes, as -- as soon as you breach one of the rules; for example,
15 on -- on one occasion when we were shot by gunships, we were in a certain position.
16 I ran and I left the food that I was carrying. I was made to sleep hungry for one
17 week.

18 Q. [15:31:53] And who ordered that you were to sleep hungry for one week?

19 A. [15:32:05] That was one of the commanders called Okello. Because I was not
20 yet in Odomi's household, I was still at the dog adaki with Okello.

21 Q. [15:32:24] Did Okello and other commanders when they ordered punishment
22 within their positions, did they need authorisation from Odomi, or they could order
23 the punishment themselves?

24 A. [15:32:47] They would not get permission from Odomi, they would handle
25 that on their own.

1 Q. [15:32:58] Were there any things that they could not handle on their own and
2 they would have to request permission from Odomi in terms of punishment?

3 A. [15:33:19] I have not understood that.
