12 Could the court officer please call the case.
13 THE COURT OFFICER: [9:33:22] Thank you, Mr President.
14 The situation in the Republic of Uganda, in the case of The Prosecutor versus
15 Dominic Ongwen, case reference ICC-02/04-01/15.
16 We are in open session.
17 PRESIDING JUDGE SCHMITT: [9:33:37] Thank you.
18 I ask for the appearances of the parties. Mrs Hohler first.
19 MS HOHLER: [9:33:41] Good morning, your Honours. For the Prosecution today,
20 Ben Gumpert, Hai Do Duc, Pubudu Sachithanandan, Paul Bradfield,
21 Ramu Fatima Bittaye, Jasmina Suljanovic, Milena Bruns, Agnese Valenti,
22 Sanyu Ndagire, Colin Black and myself, Beti Hohler.
23 PRESIDING JUDGE SCHMITT: [9:34:03] You have to assure yourself a little bit by
24 looking back who is really present.
25 And now for the Legal Representatives. Mr Narantsetseg first.

1 MR NARANTSETSEG: [9:34:08] Good morning, Mr President, your Honours.

2 For the Common Legal Representatives, Orchlon Narantsetseg and with me,

3 Ms Caroline Walter.

4 Thank you.

5 PRESIDING JUDGE SCHMITT: [9:34:16] And Mr Manoba.

6 MR MANOBA: [9:34:17] Good morning, Mr President, your Honours.

7 Joseph Manoba and James Mawira.

8 PRESIDING JUDGE SCHMITT: [9:34:21] Thank you.

9 And for the Defence, Mrs Bridgman.

10 MS BRIDGMAN: [9:34:25] Good morning, Mr President and your Honours. For

11 the Defence, we have Chief Charles Achaleke Taku; Thomas Obhof; our client

12 Mr Ongwen is in Court; and myself, Abigail Bridgman.

13 PRESIDING JUDGE SCHMITT: [9:34:38] And also known to the Court but sitting

14 on the right side this time, Mr Wagemakers.

15 MR WAGEMAKERS: [9:34:46] Good morning, Mr President, your Honours,

16 learned colleagues. Marcus Wagemakers, counsel for Witness 200, and I'm a

17 member of the Dutch Supreme Court Bar.

18 PRESIDING JUDGE SCHMITT: [9:34:57] Thank you very much.

19 The Prosecution is now calling P-200 as its next witness. Before commencing, the

20 Chamber notes briefly that protective measures are granted to this witness by virtue

21 of Decision 612 and that the VWU recommends no further protective measures but

22 the special measures that we see here.

23 We will now discuss the Rule 74 assurances. And to discuss this, we go into private

24 session.

13 PRESIDING JUDGE SCHMITT: [9:36:17] Thank you. The Chamber will now

14 render its decision on the requested assurances. Mindful of the factors specified in

15 Rule 74(5) of the Rules, the Chamber has decided to provide assurances pursuant to

16 Rule 74 of the Rules in order to enable the witness to testify without fear of the

17 consequence of self-incrimination.

18 This concludes the ruling of the Chamber and we can now bring the witness into the

19 courtroom.

20 (The witness enters the courtroom)

21 PRESIDING JUDGE SCHMITT: [9:37:20] We are not in a hurry. Take your time.

22 No problem.

23 Shortly, for the record, Mr Ayena is appearing for the Defence as lead counsel.

24 Thank you.

25 Mr Witness, good morning. Do you hear me?

3 THE WITNESS: [9:38:46] Good morning. I hear you.

4 PRESIDING JUDGE SCHMITT: [9:38:48] On behalf of the Chamber, I would like
5 to welcome you to the courtroom.

6 THE WITNESS: [9:38:52] Thank you.

7 PRESIDING JUDGE SCHMITT: [9:38:53] Thank you. You know, you are well
8 aware of the fact that you are going to testify before the International Criminal Court.
9 And there should be a card in front of you with the solemn undertaking to tell the
10 truth. Would you please be so kind to make this undertaking by reading the card
11 aloud.

12 THE WITNESS: [9:39:15] I solemnly declare that I'll speak the truth, the whole
13 truth and nothing but the truth.

14 PRESIDING JUDGE SCHMITT: [9:39:22] Thank you, Mr Witness. You are now
15 sworn in.

16 Let me now explain the protective measures that the Chamber has put in place for
17 your testimony. First of all, we have face distortion. That means that no one
18 outside the courtroom can see your face during your testimony.

19 THE WITNESS: [9:39:41] Thank you.

20 PRESIDING JUDGE SCHMITT: [9:39:42] Secondly, we use what we call a
21 pseudonym. In accordance with that, we all will refer to you as "Mr Witness", like
22 I am doing at the moment, and not with your real name. That is to make sure that
23 the public does not know your name, of course. And when you answer questions
24 that do not give away your identity, we do this in open session and otherwise we go
25 to private session. Private session means that there is no broadcast and no one

1 outside the courtroom can hear your answer. This is simply to inform you, of course;
2 you understand this.

3 Then we have another protective measure. That is what we call a Rule 74 assurance.
4 That means you have been assigned a lawyer, Mr Wagemakers here to the right, to
5 provide you with legal advice about possible self-incrimination. The Chamber gives
6 you the assurance that your testimony will not be used against you in any subsequent
7 proceedings before this Court.

8 THE WITNESS: [9:40:43] Thank you.

9 PRESIDING JUDGE SCHMITT: [9:40:45] This, of course, only applies if you tell us
10 the truth. If any question is asked that could lead to your self-incrimination, we will
11 hear your answer in private session again and keep this answer confidential.

12 I assume you understand this, Mr Witness.

13 THE WITNESS: [9:41:01] Yes.

14 PRESIDING JUDGE SCHMITT: [9:41:03] Thank you. And before we start with
15 your testimony, we have a few practical matters that everybody has to follow here in
16 the courtroom, and most of the people in the courtroom from time to time have
17 difficulties.

18 First of all, we have to speak slowly. This is because everything what we say here in
19 the courtroom is interpreted and written down, and to allow for the interpretation,
20 we have to speak at a relatively slow pace. Especially the Presiding Judge often does
21 not follow this rule and has to be reprimanded a little bit by some of the parties and
22 participants or the interpreters.

23 To allow for the interpretation, we need to also wait until the person who has asked
24 the question has finished and then only afterwards start. But that is obvious.

25 Last thing, if you have any questions yourself, if you don't feel comfortable, if you

3 PRESIDING JUDGE SCHMITT: [9:51:17] Yeah, back to open session.

4 Perhaps shortly, Mr Witness, I reiterate what I said when I welcomed you to the
5 courtroom, when you feel like you would need a break, you would need to respire,
6 then tell us. So it's -- might be and will be an absolutely new and alien experience
7 for you, perhaps also a little bit frightening to sit here in the courtroom with all these
8 people that you don't know, so whenever you feel uncomfortable in a way that you
9 think you should at the moment not continue, let us know. I simply want to
10 reiterate that that you are made sure of that.

15 Q. [9:52:22] Mr Witness, you told us you spent time with the LRA. How did you
16 come into the hands of the LRA? How did you come to spend time with them?

17 A. [9:52:36] On 24 June 2003 I was abducted by Dominic Ongwen. And that's
18 how I came to be in the LRA.

19 Q. [9:53:26] Can you explain to us in your own words in a little bit more detail
20 what happened that day when you were abducted?

21 A. [9:53:41] That day it was during morning hours when somebody passed in my
22 compound. That you are still there, the rebels are passing on the road. Then I
23 moved with my family trying to escape. Then we met with the five people, Dominic
24 Ongwen with other boys, small boys. Banged me with the butt of a gun and my
25 family members were beaten. I was brought back home to my home, got some

1 money, 5 million, which I counted on the 23rd to 24th night, made me to carry a full
2 box of drugs. We moved with the drugs until they distributed to other group
3 members. We went up to Abia --

4 Q. [9:56:04] Let me stop you there, Mr Witness. I want to ask you just a few
5 clarifying questions about what you have told us up to now.

6 You said you moved from your compound trying to escape. Where did you move
7 with your family? Where did you go?

8 A. [9:56:39] We were crossing a swamp.

9 Q. [9:56:49] That's okay, Mr Witness. We can take some time.

10 PRESIDING JUDGE SCHMITT: [9:56:55] Yes.

11 Mr Witness, as I said, we have, I think -- yes, I think we have a break and we stop, yes.

12 So we stop this here and we talk with the witness and we have a psychological,

13 I think, assessment and I think we should really try to stabilise the witness and if this

14 is possible, we continue and if not, we cannot.

15 So please we have a break now.

16 MS HOHLER: [9:57:24] Thank you, your Honour.

24 I would like to address you shortly before we continue. Mr Witness, you have taken

25 upon you the enormous burden of leaving your family and your country to come to

2 that you have taken this upon yourself must be for a reason. And the Chamber, on
3 behalf of the Chamber, I would simply like to ask you that you tell us what you have
4 at the moment in your mind what happened, simply narrate it, and perhaps later on
5 there might be additional questions, but simply what you recall here at this moment
6 in this courtroom.

7 Please tell us, nobody here was present, we have to picture this ourselves in our
8 minds, and we would very much appreciate if you try it. And whenever you need a
9 break, you will have a break. So perhaps you have already told us that you have
10 been abducted on 24 June 2003. And as I said, if you can, please simply continue
11 and tell us everything that you want to tell this Court.

12 And, Mrs Hohler, afterwards if there would be questions, there would be questions.
13 So please continue, Mr Witness.

14 THE WITNESS: [10:18:02] Make it a bit clearer. I have not understood the
15 question.

16 PRESIDING JUDGE SCHMITT: [10:18:06] That was my fault. You started telling
17 before the break what happened to you. So simply if you feel able to do that, simply
18 tell us everything what happened to you, what you want to tell this Court after you
19 have been abducted, like so that the people here in the courtroom, parties,
20 participants and the Judges can picture in their heads what really happened at that
21 time.

22 THE WITNESS: [10:18:39] Okay.

24 THE WITNESS: [10:18:42] It was on 24 June 2003 when someone passed in my
25 compound that you are still in. Then I moved with the family, my family members, I

1 carried two kids and we moved towards the swamp. There we met Dominic
2 Ongwen plus other young boys. And they brought me back, they brought me back.
3 He banged me with a butt of a gun and beat my family members and he left them.
4 So when we reached home, they got the 5 million in the house, which I counted on the
5 23rd. And they made me to carry full box of drugs, which I carried until I
6 distributed to other group members. So we met up to Abia in Amuria district,
7 where we found Vincent Otti, Banya and Raska Lukwiya.
8 So from there, Raska Lukwiya ordered the killing of the three boys. And Dominic
9 Ongwen ordered for the killing of the police officer, that Wek Nyeri. These are the
10 people who eat government money.
11 From there, from Abia, we moved to Lwala. In between Lwala, Abia and Lwala, we
12 met one man who was trying to escape, so Dominic Ongwen (Redacted)
13 (Redacted)
14 (Redacted), and the face got flat that day.
15 So we went to Lwala. He made us to squat down, and he moved with his soldiers to
16 Lwala Girls. Shortly I heard alarm, people shouting from school. After a short time,
17 we saw Dominic Ongwen coming with his soldiers with the girls, and we continued.
18 He whistled, he whistled and we moved to Abalang, Abalang, where he killed
19 15 people, more especially men.
20 From Abalang, we moved to Idam-Akan. Idam-Akan, they looted, burnt houses,
21 raped so many people. So from Idam-Akan, one girl made an alarm, one girl made
22 an alarm, and Ongwen ordered his soldier to pierce her with a bayonet and she died
23 from -- in Idam-Akan.
24 So we continued up to Morungatuny, where they met with the government troops
25 and they fought, they looted, killed. And they moved up to Obalanga, Obalanga,

1 they killed, raped. And they killed one headteacher of Agonga primary school.
2 So from there we moved to Amoroto river. When we went to Amoroto, the children
3 who didn't know how to swim all drowned in the water because we were, we were
4 chased to cross the water. So we crossed. The ones who were unable to cross the
5 water, for me, I used the seat for crossing the water to the other side.
6 So we moved. After moving, we went and met Kony in Adilang, in Adilang. So in
7 Adilang we met Kony. Then after meeting Kony, of course he distributed the girls to
8 the commanders. When he distributed the girls to the commanders, we went to
9 attack Barlonyo camp in four lines. So I was in the line of my commander Dominic
10 Ongwen, who ordered me to carry enough food for him, and I carried enough food.
11 And again we came back, we met in Adilang and we escorted Kony to Sudan. In the
12 way to Sudan we became very hungry and (Redacted)

16 drink a little bit something, and if you feel free, then you can continue.
17 And after the witness has finished his narrative we make a break.
18 Thank you, madam, for your assistance. Thank you very much.
19 So please continue, Mr Witness.
20 THE WITNESS: [10:26:15] Thank you.
21 So after we escorted Kony to Sudan, we came back to Uganda. We roamed up and
22 down. We moved to Lwala, Kitgum Atidi, Pader, those points of northern Uganda,
23 because some other groups remain in Lango, some in Teso, some in Acholi sub-region.
24 So we roamed up and down from there.
25 And problems arised when we were gathering. When we are gathering, trying to

1 see, we were seated in a group. When they see you quiet, they ask you why you
2 want to be quiet, because some people did not know the language of Acholi. You
3 say yes, they close your mouth with the padlock and sometimes they can even cut
4 your mouth.

5 So we moved, we moved until such a time the attempts again to kill us started, the
6 attempts to kill us started. First they picked six of us, they picked six of us and they
7 killed three and ordered to stop. That was for the first time. The second time
8 picked four of us and killed three and ordered to stop. Then again we moved, we
9 moved, we roamed up and down.

10 Again when I tried to escape, again I met with Dominic Ongwen. He said, "Why are
11 you here?"

12 I said, "Aeroplane, helicopter gunship".

13 Then he said, he said, "Ateso laming, Ateso laming".

14 Then he made me to lie, see direct to the sun. He made me lie direct to the sun.

15 Then he started piercing me here, on the forehead here, and even in my side he
16 pierced me with a bayonet.

17 PRESIDING JUDGE SCHMITT: [10:29:52] Mr Witness, simply try to calm down.

18 Perhaps take another -- we take another short break but we stay here in the courtroom.

19 I think you will be able to continue. And once you have finished the narrative, we
20 have a longer break then. So if you feel able to do, please continue.

21 THE WITNESS: [10:30:14] Yeah, then after piercing the side, he pierced me on the
22 back. Then he ordered the abductees to carry me up the river Pece. I can even
23 show you these wounds. Can I show?

24 PRESIDING JUDGE SCHMITT: [10:30:49] I think it's not necessary. I don't know
25 if we have some photographs, perhaps. I'm not sure. Mrs Hohler.

2 not intending for the witness -- the need to show their wounds. But it's up to you, of
3 course.

4 PRESIDING JUDGE SCHMITT: [10:31:05] No, no, we would not look at them here
5 in the courtroom.

6 Thank you, Mr Witness. Please continue.

7 THE WITNESS: [10:31:12] Then he ordered the abductees to carry me up the river
8 Pece. We went to the waters to cross the water of river Pece. As we were crossing,
9 I sank down into the water and I moved three steps aside. When I moved, when I
10 moved, I let my nose a little out for breathing in the water, then I turned my ears, my
11 ear, to hear whether they have all crossed the water.

12 So I waited for some time. When again I checked, the water was quiet. I waited
13 because for them, they don't cross at once, there are some guards who remain behind.
14 So I waited until they crossed, then I came off shores to hid myself. So after they
15 crossed the other side, again they came back looking for me. They moved to the way
16 we were coming from. They checked the shores of the river, but they could not see
17 me. They tried to step some grass around the river, but they couldn't see me.

18 I stayed there until I moved, because I heard some voices of the people from the
19 camp.

20 So I moved. I met one local with an axe who wanted to finish to me. Then I moved.
21 I got the eldest one, who put me on their bicycle and he took me to Palenga barracks,
22 Palenga. From Palenga, I was given porridge. I went up -- I was taken to Bobi
23 brigade, Bobi brigade. From Bobi, I was taken to World Vision. World Vision,
24 I was taken to Lacor hospital. From Lacor, Soroti. From Soroti, I was brought to
25 Mulago and later united with my family members.

2 The question would be, if we have -- if we would start questioning, I think it's now
3 possible, I would say.

4 MS HOHLER: [10:34:14] Your Honour, if I could ask you perhaps for a half an
5 hour or 45 minutes' break. And my intention would be to go carefully through the
6 narrative and I will then ask really only necessary questions.

7 PRESIDING JUDGE SCHMITT: [10:34:27] This was exactly the idea that we had in
8 mind here. So I think we have now --

9 MR TAKU: [10:34:32] May it please the Court, your Honours. At this point we
10 wish to assert -- to refer the Court to our standing objections and to assert
11 Mr Ongwen's fair trial rights of notice. We have the confirmation of charges
12 decision, which, as you know, is operative; it charges Mr Ongwen before this Court.
13 He's being tried on the charges as confirmed by the pre-trial Judges.
14 Obviously, most of the evidence by this witness were not -- are not contained in that
15 instrument by which Mr Ongwen was committed for trial.

16 Furthermore, your Honours, I know that at various times you've taken a decision on
17 this, this ongoing trial, and ultimately at the end of the case, you are the guarantors of
18 fair trial in this case, and I know that you will be guided very strictly by that charging
19 instrument that is before the Court.

20 Secondly, your Honours, and I say this, I really commend the effort to get the
21 evidence, to give everybody the opportunity to let his story be heard. Then we can
22 test that witness. But I just want that this witness will cooperate and bear with the
23 Court that this is a process. If you look at his profile, which I don't want to say here,
24 he must have had many avenues to tell his story publicly in northern Uganda,
25 probably to the international press, in many ways. And therefore in those instances,

1 people who were there, he didn't display these emotions. He can ask somebody, in
2 the status that we now know he has, please cooperate with us; you know that the

4 want that these proceedings should be marred by this display of emotion. If he can
5 control himself, it would be good for everyone because we are here for the truth and
6 nothing but the truth.

7 So we appeal to him to try as much as possible to be patient and to let the evidence
8 come out so your Honours will make a determination. It is not about -- for us here,
9 it's about the search for the truth. Mr Ongwen, as a victim himself, wants to search
10 for the truth. He's not here being tried for the crimes of the LRA. He wants to
11 search for the truth, and we too are committed to that.

12 At the beginning of this trial, I made the statement that we would respect all
13 witnesses and their dignity, everybody coming here. And your Honours have just
14 made that -- showed that display by letting him tell the story. But let him make an
15 effort to keep the emotions apart so that the story can come out, knowing that at some
16 point in time whatever he say will be tested.

17 Thank you, your Honour.

18 PRESIDING JUDGE SCHMITT: [10:37:26] Any comment by the Prosecution to
19 that?

20 MS HOHLER: [10:37:28] Your Honour, with regard to the first argument by the
21 Defence, alleging that this is again an expansion of charges, this is not the case, and
22 your Honours have ruled on this, to my account, at least seven or eight times.

23 This witness's evidence - I will just repeat very briefly - is relevant for at least three
24 topics. One is the contextual element of crimes against humanity and war crimes.

25 The second one is the position of authority of the accused during the relevant period,

6 have any issues with cooperation during that -- during their time, then that is the time
7 to make that objection, not at the moment.

9 (Trial Chamber confers)

10 PRESIDING JUDGE SCHMITT: [10:38:54] So there is a short ruling by the
11 Chamber. The standing objection - we have done this before, but I think it is
12 necessary to do it again - is rejected. We have four attacks, that is correct, that form
13 part of the charges confirmed. However, this does not mean that other than these
14 four attacks cannot be evidence of other facts and circumstances described in the
15 charges. Examples could include contextual elements, modes of liability, and
16 perhaps also conscription and use of child soldiers. And as we have said many
17 times before, we reiterate that with all evidence received in this case, the Chamber
18 will consider the appropriate use of this evidence when deliberating its judgment.
19 So this concludes the hearing.
20 When it comes to the cooperation of the witness, it is clear -- and, Mr Witness, I tell
21 you that Prosecution will ask you, will put questions to you, and later on also Defence.
22 This is the process in a courtroom and you are well aware of that and we have no
23 indication that you are intending not to answer questions by the Defence, for example.
24 So we are not at that process.
25 And to all the parties and participants, what we do here in this courtroom today and

9 We will have at some point in time the Defence questioning and we look further then,
10 and I think you -- and I don't know who is going to question, but experience also
11 shows that also the Defence always had in mind what kind of witness we had here
12 and what problems it caused. There would -- we had no complaint whatever to
13 make in that regard by the Chamber.

14 So we'll have a break then until half past 11. I think you said 30 -- yes, why not, half
15 past 11, nearly 45 -- a little bit more, 45 minutes. Then you can rearrange yourself a
16 little bit.

17 Thank you, Mr Witness, for the moment.

18 A. [14:33:07] At the moment, yes.

19 Q. [14:33:18] You have received training in human rights previously; isn't that true?

20 A. [14:33:36] I forgot.

21 Q. [14:33:51] Do you recall receiving training in human rights in 2006 from the
22 Uganda Human Rights Commission?

23 A. [14:34:09] I forgot because it has taken a couple of years.

24 Q. [14:34:15] Actually, my apologies. It's from 2008.

25 A. [14:34:29] I respond, I respond what I remember now.

21 Can you explain why you would not be willing to share your information with any
22 other person, apart from the ICC?
