11 by the Defence team for Dominic Ongwen; that's correct, isn't it?

14 may be referring to some of the things that you told them; is that clear?

24 friend questioned this witness in private session so I'm in your Honours' hands.

4 PRESIDING JUDGE SCHMITT: [9:40:17] Thank you. Few things go unnoticed
5 here in the courtroom. Please, Mr Choudhry.

6 MR CHOUDHRY: [9:40:23] Your Honour, the thing that I forgot to do was to
7 mention the transcript and that is transcript 208.

8 Q. [9:40:33] Mr Arop, I'd like to talk to you about some of the things you said about
9 Kony's powers, okay? On Tuesday you told us that Kony "can give an order to
10 someone who is lower than you and say you go and do this work. Sometimes he
11 would pick [the person] ... close to him as signallers. For you, the officer, you are
12 irrelevant." Do you remember that?

13 A. [9:41:02] Yes, I do.

14 Q. [9:41:08] Now the phrase "to do work" in the LRA means to go and do an attack,
15 doesn't it?

16 A. [9:41:16] Yes, that's correct.

17 Q. [9:41:23] So when you said that, you meant that Kony could give a lower-ranked
18 LRA fighter more responsibility than a higher-ranked LRA fighter in an attack, didn't
19 you?

20 A. [9:41:40] Yes, that would happen.

21 Q. [9:41:51] Now, Mr Witness, Vincent Otti was the LRA's number 2 at a point in
22 time, wasn't he?

23 A. [9:42:02] Yes, he was.

24 Q. [9:42:07] And just like Kony, Vincent Otti also had the authority to give
25 a lower-ranked LRA fighter more responsibility than a higher-ranked LRA fighter in

2 A. [9:42:23] Yes, that's correct.

3 Q. [9:42:32] And staying with the subject of ranks, on Tuesday, and this is it
4 realtime transcript page 32, lines 11 to 13, you said:

5 "I saw that the ranks which are given there, you are given rank to try and lure you to
6 stay so you would not be able to escape." You said that, yes?

7 A. [9:43:00] Yes, I did.

8 Q. [9:43:03] When you said ranks could lure you to stay, you meant that ranks in
9 the LRA were sometimes used to discourage LRA fighters from escaping; isn't that
10 correct?

11 A. [9:43:19] You're given a rank to make it difficult for you to escape.

12 Q. [9:43:31] This was because the higher the rank you had, the more power you
13 had, correct?

14 A. [9:43:43] No, you did not have more authority based on your rank.

15 Q. [9:43:56] What was your rank, your highest rank in the LRA, Mr Witness?

16 A. [9:44:04] I was a captain.

17 Q. [9:44:07] What was Vincent Otti's highest rank in the LRA, Mr Witness?

18 A. [9:44:16] When I left, he was the brigadier.

19 Q. [9:44:21] Did you have the same or more authority than Vincent Otti,
20 Mr Witness?

21 A. [9:44:29] No, I did not even have the audacity to speak with him. I did not
22 have the rank to enable me to speak to him directly.

23 Q. [9:44:42] So Vincent Otti, his rank, he had more power than you; isn't that right?

24 A. [9:44:50] Yes, he was highly ranked than myself.

25 Q. [9:45:01] So you agree with me that the higher your rank, the more power you

2 A. [9:45:08] You have power in the area where you're located but you do not have
3 power over other people in other areas.

4 Q. [9:45:26] And the more power you have in the areas that you're located, the
5 more privileges you have; isn't that right?

6 A. [9:45:39] Based on your locality, you live socially with other people, but all the
7 orders come from above and whoever is above is in charge of everybody else.

8 Q. [9:46:01] Let's look at it this way: Senior commanders had escorts, didn't they?

9 A. [9:46:13] Yes, they did have escorts.

10 Q. [9:46:18] Lower-ranked commanders didn't have escorts?

11 A. [9:46:24] They did not have escorts.

12 Q. [9:46:30] And on Tuesday, you gave us an example of when a lower-ranked
13 officer was jealous of a higher-ranked officer, and that example was of Matata being
14 jealous of Otti Lagony; isn't that correct?

15 A. [9:46:55] That's correct.

16 Q. [9:47:02] I'd like to ask you a few questions now about the death of Otti Lagony.
17 It's right in saying that before Otti Lagony was executed, you were originally ordered
18 to go with the group that were tasked with killing him; isn't that right?

19 A. [9:47:28] Yes, that's correct.

20 Q. [9:47:37] And when you realised that you were in a group that was going to kill
21 Otti Lagony, that upset you, didn't it?

22 A. [9:47:49] It made me afraid.

23 Q. [9:47:55] You didn't agree with the decision that he should be killed, did you?

24 A. [9:48:05] Well, I did feel that he should not be killed, personally, but I could not
25 speak out about it.

1 Q. [9:48:19] But you refused to go with the group that killed him, didn't you?

2 A. [9:48:25] Yes, I did refuse.

3 Q. [9:48:33] And in fact you told Kony that you refused to go with that group,
4 didn't you?

5 A. [9:48:42] No, I did not tell him personally but they asked me.

6 Q. [9:48:53] When you say "they" do you mean Kony asked you?

7 A. [9:49:00] The soldiers, the soldiers who I lived with at Kony's household.

8 Q. [9:49:11] Mr Witness, I'm going to refer to something in a summary that the
9 Defence have provided me which they say you said to them, okay? And I'll read
10 this:

11 "The witness was one of the last persons to see Otti Lagony and Okello Director alive.
12 He was part of the long walk 'to Uganda', and they were eventually split just before
13 Lagony and Okello Director were executed. He stated that he refused to go the last
14 mile, noting that he told this to Kony. He said that Kony did not kill him because
15 Kony respected his ability to speak his mind and the truth."

16 PRESIDING JUDGE SCHMITT: [9:50:08] Perhaps for the information of the witness.
17 Mr Arop, this is a summary of a conversation obviously or interview you had with
18 the Defence. It's not your -- not exactly one on one your words written down here,
19 but it is, as I said, a summary.

20 Just so that the witness is clear about what you put to him.

21 MR CHOUDHRY: [9:50:34]

22 Q. [9:50:34] So my question to you, Mr Witness, is that you told Kony that you
23 refused to go with the group that executed Otti Lagony, didn't you?

24 A. [9:50:47] Yes, I did.

25 MR OBHOF: [9:50:52] And I wonder, just a small point before we go forward. I'm

5 PRESIDING JUDGE SCHMITT: No, no, I --

6 MR OBHOF: [09:51:03] -- and I understand it is something that could be used.

7 PRESIDING JUDGE SCHMITT: [9:51:06] Yes, I also shortly thought about telling
8 everyone where we -- that is paragraph 7 of your summary, everything. But since
9 this is a very short summary and since you have fabricated it, I think it's not too
10 complicated to follow here. Because of that I did not intervene.

11 Please continue --

12 MR OBHOF: [9:51:27] I actually pulled it up on my computer screen earlier today.

13 PRESIDING JUDGE SCHMITT: Yes.

14 Please continue, Mr Choudhry.

15 MR CHOUDHRY: [9:51:33] Your Honour, in that regard I can apologise if -- and I'll
16 do that in future.

18 continue.

19 MR CHOUDHRY:

20 Q. [9:51:42] Mr Witness, after you told Kony that you refused, Kony didn't kill you,
21 did he?

22 A. [9:51:50] He asked me -- he asked me why did you refuse to go. And I told him,
23 I said no, I couldn't go and witness him being killed because I used to live with him.
24 And he didn't say anything else to that.

25 Q. [9:52:06] And you believed that when you told Kony that, Kony respected your

2 right?

3 A. [9:52:18] I was afraid. But when he did not take any action against me I
4 believed that he understood what I'd told him.

5 Q. [9:52:36] So there were times, Mr Witness, that Kony actually listened to LRA
6 fighters and respected their opinions; isn't that correct?

7 A. [9:52:53] If he asks you a question, and you respond to him directly and
8 correctly, then, yes. But you are not the one who asks him, you don't question him.

9 Q. [9:53:13] Mr Witness, I would like to move on to a different topic now and that's
10 the subject of an attack at Odek. Do you understand that?

11 A. [9:53:22] No, I do not -- I did not understand but I did hear about the incident.

12 Q. [9:53:36] When you spoke to the Defence team, you told them about an attack at
13 Odek, didn't you?

14 A. [9:53:45] I do not recall.

15 PRESIDING JUDGE SCHMITT: [9:53:57] It's paragraph 14 of the summary. I think
16 you may put it to him if you want. Again, under the -- that it is clear that we have
17 here a summary and not his original words.

18 MR OBHOF: [9:54:10] Your Honour, you mean paragraph 16, correct?

19 PRESIDING JUDGE SCHMITT: [9:54:14] I would put 14 to him, but it's up to the
20 Prosecution, first of all.

21 MR OBHOF: [9:54:20] I believe you are reading the old summary.

22 PRESIDING JUDGE SCHMITT: [9:54:24] It might be then the old summary. So we
23 won't discuss that.

11 Odek was attacked.

12 Q. [9:55:10] Can you tell us what you did hear happen at Odek?

13 A. [9:55:16] I heard that there was an attack, but I did not get any other details
14 about the actual attack.

15 Q. [9:55:26] Who did you hear that there was an attack from?

16 A. [9:55:31] The soldiers who came back from Uganda.

17 Q. [9:55:39] And how did the soldiers who came back from Uganda know about
18 the attack?

19 A. [9:55:47] I did not ask. Because when you're there, as I stated earlier, you do
20 not go around asking questions because if you ask questions, you raise suspicions
21 about yourself.

22 Q. [9:56:03] What LRA units were these soldiers who told you about the attack at
23 Odek, what units did they belong to?

24 A. [9:56:15] Some of them were part of Trinkle.

25 Q. [9:56:20] What about Sinia, were any of them from Sinia?

5 Q. [9:56:53] Now, Mr Witness, I'm going to read something that the Defence team
6 have said that you told them, so I would just like to understand that.

7 Your Honour, that is paragraph I think I've got 14. It might be corrected.

8 PRESIDING JUDGE SCHMITT: [9:57:10] Yes, okay, 14/16.

9 MR CHOUDHRY: [9:57:13]

10 Q. [9:57:14] "The witness was in Trinkle sickbay at this time. He did not go, and
11 he heard about it after the fact. After the attack, some of the wounded came to his
12 sickbay. He said that the wounded said that it was an attack was a mixture of all
13 brigades. As some of the injured were from Sinia brigade, the witness assumes
14 Dominic was there."

15 My question to you, Mr Witness, is, does that help you remember what you told the
16 Defence?

17 A. [9:57:54] I do remember that there were a lot of people who came to the bay and
18 I did speak to those people, but I did not get concrete information or I did not fully
19 understand that Ongwen was there.

21 concluded also from paragraph 14, to make it clear. So what the witness now says
22 would concur with this paragraph, let me put it this way, or not contradict it.

- 5 Q. [9:59:20] And he didn't just treat people well, but he treated LRA fighters that
- 6 were under him well, correct?
- 7 A. [9:59:31] Yes, he treated them well.
- 8 Q. [9:59:38] And you told us on Tuesday that you were able to get close to him?
- 9 A. [9:59:46] Yes, I was able to get close to him when we were in the Sudan.
- 10 Q. [9:59:53] So you yourself liked Dominic Ongwen?
- 11 A. [9:59:59] Yes, I did like him.
- 12 Q. [10:00:04] You told us on Tuesday that you last saw Dominic Ongwen in 2004; is
- 13 that correct?
- 14 A. [10:00:14] I -- the last -- the last time I did see him was in 2004.
- 15 Q. [10:00:23] What did you talk about when you last saw him?
- 16 A. [10:00:27] The minute I found him he was limping. I didn't take time with him,
- 17 I didn't talk about his injury, but he had his thigh bound by something. And we
- 18 were all on the go, it was not somewhere where we are stationed. So we eventually
- 19 separated.
- 20 Q. [10:00:59] Mr Witness, you should have a binder in front of you. I ask you to
- 21 turn to tab 2, please.
- 22 PRESIDING JUDGE SCHMITT: [10:01:14] So if you could please open the binder
- 23 and then at tab 2.
- 24 And I think on top, if I am correct, Mr Choudhry, there is The Telegraph and there is
- 25 a picture, too.

6 Q. [10:04:25] If you could turn now to tab 3 in your binder, please.

7 MR CHOUDHRY: [10:04:37] Your Honour, that's UGA-OTP-0286-0647.

8 PRESIDING JUDGE SCHMITT: [10:04:48] 647? I have on tab 3, I have 664.

9 MR CHOUDHRY: [10:04:57] Your Honour, it's my mistake, it's tab 4.

21 Your Honour, I'm reading from 0648, and it's -- one, two, three, four, five, six,
22 seven -- the eight paragraph or the penultimate paragraph.

23 The journalist wrote this: "Many feel strongly that Ongwen, a former child soldier
24 himself, should not be prosecuted but instead sent home to benefit from
25 a government amnesty offered to other former LRA soldiers. Among them is Alfred

1 Arop, a former bodyguard to Joseph Kony."

2 My question, Mr Witness, is you believe not only that Dominic Ongwen should not be
3 prosecuted, but you think he should be granted an amnesty as well, don't you?

4 MR OBHOF: [10:06:50] Your Honour, the Defence objects. We have asked this
5 question before about whether or not Mr Ongwen should be up here, and we have
6 been denied the right to have the witness answer. It's only fair the Prosecution be
7 not allowed to do the same thing.

8 PRESIDING JUDGE SCHMITT: [10:07:04] I think this -- but the difference here is
9 that you can infer it from what the witness has said formally, and I would not see any
10 reason, even from the perspective of the Defence, why not ask him that.

11 MR OBHOF: [10:07:21] Well, you know, I'm just saying it's been denied to us before,
12 so it should be treated equally.

13 PRESIDING JUDGE SCHMITT: [10:07:27] Yes, but this is, as I said, this is a little bit

7 the *dog adaki* to become an escort. But each time he is above me, yes, that would

8 happen. But that would be changed at any one point. I mentioned this clearly even

9 on Tuesday. I think I have answered that question.

10 Well, let me emphasise further. For instance, if Otti was in this rank, and at that

11 point I cannot antagonise him because by his rank he's above me, because I would be

12 below him in terms of rank. But there is another person who would be lower in rank

13 than me; I would send them to fetch water or run for errands because I am above

14 them. But all the orders come from Kony and not from Otti.

15 Have I answered you?

6 is, when Kony finally asked you, how did he come to know that you had not
7 participated? Was it you who told him or some other persons?

8 A. [10:30:25] Thank you. I think this -- the question is very clear. I had not
9 understood the other one. At the time when they picked me, I carried the bomb; I
10 did not know they were taking Otti to be killed. When I arrived at the *dog adaki*, I
11 just bumped into him, I got angry, I threw down the B-10. And when I returned,
12 Kony himself came and asked me, he didn't ask -- he asked me why I did not shoot
13 these people with the B-10. Because I was asking why they took me to go and see
14 him. He asked me himself. Because at that time I was so angry I had comment to
15 myself, I was -- I wanted to even die. I didn't want to do anything else.

16 MR AYENA ODONGO: Thank you very much.

17 PRESIDING JUDGE SCHMITT: [10:31:17] But now for me, it is not clear anymore
18 if you knew what was going to happen with Otti Lagony. I understood you before
19 that you knew that this person would be killed; is that correct when I say this?

20 THE WITNESS: [10:31:32] (Interpretation) Initially, I did not know because they
21 were kept in another place. I was picked from a different place and then we all just
22 bumped into each other and I saw them. And at that time, he was now a prisoner.

24 going with these other peoples who were about to kill Otti Lagony? That we have
25 understood correctly?
