10 (The hearing starts in open session at 11.02 a.m.)
11 THE COURT USHER: All rise.
12 The International Criminal Court is now in session.
13 Please be seated.
14 PRESIDING JUDGE TARFUSSER: Good morning to everybody in the court.
15 Before giving the floor to the Prosecutor, I think on Rule 74, so that's an email
16 we received a short while ago, I would just – I wanted just to read out the
17 decision on the in-court protective measures. This is the oral ruling on the
18 Prosecutor's application for protective measures for Witness P-520.
19 All files, I just want to tell you, have been filed as confidential filings, of
20 course, but the ruling has been drafted in such a way that the information can
21 be given in public session.
22 On 15 April 2016, the Prosecutor filed an application for Witness P-520 to give
23 testimony by means of video technology. I'm referring to filing 486.
24 On 9 May 2016, the Prosecutor filed a request for in-court protective measures
25 for the witness; namely, face distortion and voice distortion, use of

1 pseudonym, and use of private sessions in order to protect the witness's
2 identity vis-à-vis the public, as well as special measures given the witness's
3 conditions, filing 507.

4 The Blé Goudé and Gbagbo Defence filed on 18 and 20 May 2016 their
5 responses opposing to the request, filings 555 and 557.

6 The Chamber authorised the testimony of P-520 via video link in a previous
7 oral ruling on 27 May 2016. On the same day, it directed the Registry to
8 submit its assessment and any observations in relation to the protective
9 measures sought for P-520 by 3 June 2016.

10 On 2 June 2016, via email to the Chamber, the VWU recommended the use of
11 in-court protective measures.

12 Moreover, on 6 June 2016, the VWU also submitted via email a vulnerability
13 assessment to the Chamber recommending special measures, including
14 in-court support, possible breaks during the hearing sessions, and adapted
15 sitting hours. A further assessment recommending the protective measures
16 was emailed to the Chamber on 13 June 2016.

17 Pursuant to paragraph 56 of the directive on the conduct of the proceedings,
18 the Chamber ruled that it will generally grant protective measures,
19 protective and special measures sought by any party which are supported by
20 a favourable assessment and recommendation by the VWU.

21 In its assessment, the VWU has recommended the requested protective
22 measures on the basis of the witness's own concerns and fears and his
23 specific personal circumstances as well as the general situation in Côte
24 d'Ivoire.

25 The Chamber is also aware, particularly in light of events that surrounded

1 the testimony of the previous witness, that there is an effort by persons in
2 Côte d'Ivoire and elsewhere to interfere with this trial proceedings,
3 particularly via social media outlets.

4 Given the particular and personal circumstances of P-520, the Chamber
5 hereby grants the requested protective and special measures.

6 So this was the oral ruling. I will now to give the floor to the Office of the
7 Prosecutor for the Rule 74 issue in public session I think, of course. Thank
8 you. You have the floor.

9 MR DEMIRDJIAN: Yes, your Honours. Good morning, your Honours.

10 Good morning to everyone in and around the courtroom.

11 Your Honours may have seen our witness examination sheet in respect to the
12 topics that this witness will testify about. The witness was interviewed
13 pursuant to Article 55(2) and was given his rights, so we believe that the line
14 of questioning that we will be proceeding with this morning will not
15 necessarily raise concerns of self-incrimination.

16 However, given the witness's position, we believe, and given his position
17 during the conflict, we believe that it may be, out of an abundance of caution,
18 it may be safe to give the witness the assurances against self-incrimination.

19 And, of course, during the testimony, again if the need arises, I believe
20 counsel is on standby for the witness.

21 So that is all we have, your Honours. Thank you.

22 PRESIDING JUDGE TARFUSSER: Thank you very much. There is nothing
23 to say, well, by the Defence, I hope.

1 International Criminal Court has been established to try the case of the
2 Prosecutor against Mr Gbagbo and Mr Blé Goudé. You in your capacity as a
3 witness, you are called to assist the Chamber in the search of the truth. You
4 will be asked questions by the Office of the Prosecutor, by the Defence teams,
5 the Defence of Mr Gbagbo and Mr Blé Goudé, and if needed also by the
6 judges.
7 If at any point you have concerns, you are tired, you have any need, just ask
8 me and we will try to accommodate them accordingly.
9 I know that you are testifying in French. You know that this Court
10 is working languages are English and French. So all what you are saying in
11 French has to be translated in English. So please speak slowly. Please
12 before answering, let a couple of seconds go so that the interpreters and the
13 court reporters can translate and write the report in a way which is exact,
14 which exactly reports what you are saying.
15 The protective measures that you have in place there, the Chamber ordered
16 protective measures for you, are as I said before voice distortion and face and
17 image distortion. So you cannot be seen and your voice cannot be heard
18 outside this courtroom. So everything what is broadcasted is broadcasted in
19 a distorted way.
20 You have also obviously to help us in protecting your identity by obviously
21 not going -- not saying things which could lead to your identification. If you
22 think that something could do so, please advise us so that we can go in
23 private session. So you have to collaborate in this endeavour to protect your
24 identity.
25 As far as Rule 74 is concerned, and I understand that you have been duly

1 informed by your lawyer on what Rule 74 is, as I said, you have been
2 assigned a lawyer by the Court, who will give you and probably has given
3 you all necessary legal advice about possible self-incrimination.
4 OTP, but you as well, have requested to be given by the Chamber certain
5 assurances for in case of self-incrimination by the Chamber. The Chamber
6 will rule on this request shortly. In the meantime we will start your
7 testimony with the questions by the Office of the Prosecutor, who just before
8 you have been brought in assured that he is not, at least at the beginning,
9 making questions which could lead to your self-incrimination. So we will
10 start this way and then we will rule on this later.
11 Before starting, you have to as a witness in the proceedings before starting
12 your testimony, you obviously know that you have the duty to tell the truth.
13 So before I start giving -- before I give the floor to the Office of the
14 Prosecutor, who will start his questioning, you are required by law to make a
15 solemn undertaking.
16 So I would ask you to please repeat with me the following words: I
17 solemnly declare that I will speak the truth.
18 THE WITNESS: (Interpretation) I solemnly declare that I will speak the
19 truth.
20 PRESIDING JUDGE TARFUSSER: The whole truth and nothing but the
21 truth.
22 THE WITNESS: (Interpretation) The whole truth and nothing but the truth.
23 PRESIDING JUDGE TARFUSSER: Thank you.
24 Now, last thing --

6 Prosecutor for his questioning. I really ask you to say what you know in a
7 truthful way and so we can release you as soon as possible from the seat, so
8 hopefully within the three days you are requesting.

9 The floor is to the Office of the Prosecutor.

10 MR DEMIRDJIAN: (Interpretation) Thank you, Mr President. We're
11 talking at the same time.

13 QUESTIONED BY MR DEMIRDJIAN: (Interpretation)

14 Q. Good morning, Witness.

16 Q. My name is Alexis Demirdjian, and we met very briefly yesterday
17 afternoon, and I'd like to put some questions to you for the Office of the
18 Prosecutor. You heard the instructions provided to you by the Presiding

20 We shall start with a brief session in private session and we shall broach your
21 professional background, after which we shall go back into open session for
22 the rest of your testimony. And if at any moment in time some questions
23 might be identifying, we would then very briefly go back into private session
24 just with a view to protecting your identity.

25 So at this juncture I would request that we go into closed session.

9 Q. Could you please provide us the titles of these various special advisers,
10 which fields they worked in?

11 A. Well, there are a number of them, as I said, in a various number of
12 fields. You could have a special adviser in economic and financial matters.
13 You might have a special adviser in security and defence. You had special
14 advisers in the cultural field. You had special advisers in social matters.
15 Those are what I referred to earlier on as the various socio-professional
16 groups.

17 Q. Thank you very much for that point of clarification.

18 You told us that there were advisers in security and defence. Could you
19 please tell us who the special adviser was for defence?

20 A. Yes. It was Minister Kadet Bertin.

21 Q. And do you know how often these special advisers were consulted by
22 President Gbagbo?

23 A. Whenever necessary. Otherwise, there was not a specific rhythm to
24 my knowledge.

3 The organisation had two information or intelligence gathering services also,
4 and it was based on those briefs that a summary was made, analysed and
5 then sent to the president.

6 Q. Now regarding this intelligence that (Redacted), what was the type
7 of information that was of interest to ANSI in its daily activities?

8 A. (Redacted)

9 (Redacted) and they also had their representatives on the ground, and
10 they worked on activities relating to attempts to destabilise the country,
11 because general intelligence was not really within the ambit of ANSI's work.
12 So I would say that they were more focused on external activities rather than
13 internal activities when it came to anything that related to attempts to
14 destabilise the country.

15 Q. You have said that the organisation was interested in information relating to
16 attempts to destabilise the country. So if (Redacted) had information
17 about a group in this case, what type of details would (Redacted) want to have from
18 this group? What would be the important information (Redacted)

19 A. I really do not understand the question, because the idea was to
20 identify the ways and means in which those attempting destabilisation were
21 operating. There would be attempts to identify them and to see whether
22 they had accomplices outside or inside. And this information would be
23 transmitted or shared with the various other services given that ANSI could
24 not itself intervene.

25 Q. Thank you, Mr Witness. And, in fact, you did understand the

2 Now, going back to 2010, before the elections of 2010, can you tell us

3 approximately how many people worked within ANSI?

4 A. I do not know to be precise, but there would have been about 100 to
5 150 from different socio-political groups. You had *teachers, policemen,
6 gendarmes, customs officials, there were also civilians.

7 Q. Very well. Can you tell us where ANSI would be located in the
8 organigram of the state?

9 A. ANSI was not a state organ. It was an intelligence service answerable
10 personally to the president of the republic.

11 Q. Very well.

12 MR DEMIRDJIAN: (Interpretation) I think that for the next series of
13 questions we need to return to private session, Mr President.

14 PRESIDING JUDGE TARFUSSER: We are out of court officer. We are
15 running out of court officers. Here he comes.

16 MR DEMIRDJIAN: I know I'm very demanding today, but it's for a good
17 cause.

1 Q. It is a decree dated 24 February 2011 to organise the functioning of the
2 presidency of the republic.

3 A. 2011?

4 Q. It is at the top of the page, if that can be scrolled up for the witness. Now
5 you can see decree *No. 2011-62 of 24 February 2011.

6 Before you look at this decree I would like to ask you, when it comes to the
7 organisation and functioning of the presidency of the republic, was there a
8 decree in relation to this *prior to that? Because here we are in February 2011.
9 So the question is: Was there a decree, before this particular decree?

10 A. Yes, I believe so.

11 Q. Very well. Now, this is a 10-page document, but I would like to show
12 you just certain excerpts. You can see on the first page that the presidency is
13 organised as follows, and there are three sections mentioned: The general
14 secretariat, the civil cabinet, and the military cabinet of the president of the
15 republic. Does this faithfully reflect this real situation during that period?

16 A. Yes.

17 Q. Very well. There are *three sections in this decree, and the first
18 section deals with the secretariat general of the presidency, and we are going
19 to go to page 7. That is CIV-OTP-0025-0977. Thank you.

20 And we are talking here about the civil cabinet of the president of the
21 republic. That is section 2. I would like to draw your attention to article 21.

22 Can you see the document well or do you want it to be zoomed for you?

23 A. Yes, please, if you can zoom into the article. I have some problems
24 with my eyesight.

25 Q. Is it better now?

1 A. Can we zoom in a little bit more? Yes. Yes, I think I can see it now.

2 Q. Article 21, the civil cabinet will have as its head the director of the civil
3 cabinet, and Article 22 stipulates that the director of the civil cabinet -- and
4 you can see some bullet points here. The second bullet point states that he
5 shall coordinate the activities of the special advisers and technical advisers of
6 the president of the republic.

7 Once again I would like to ask you to answer generally. So does that reflect
8 the reality at that time? Did the director of civil cabinet coordinate activities
9 of the special advisers and the technical advisers?

10 A. Yes.

11 Q. Very well. Now, let us move on to page 9. And it ends with
12 0025-0979. If it can be blown up a little bit to go to Article 34.

13 And here mention is made of the military cabinet of the president of the
14 republic. And the head of this cabinet is the chief of the military staff of the
15 president of the republic. And you just told us that it was General Touvolvy;
16 is that correct?

17 A. Yes.

18 Q. Now, we have just seen that there was a cabinet --

25 decided that the self-defence groups be dissolved and disarmed. I believe

5 and he really wanted for there to be peace, and he wanted for elections to be
6 held.

7 And I remember that he invested himself, and he even went to Guiglo in
8 order to preside over these first disarmament ceremonies. And he even went
9 to Bouaké with the prime minister at the time, Mr Guillaume Soro, to go
10 about the disarmament and incineration of the weapons that had been
11 gathered.

12 And I believe that it was under such a context that the information came in
13 talking about the reconstitution of little self-defence groups here and there,
14 which turned out to be thugs, bandits. And I think that it was a question of
15 not letting them prosper in any way. I think that's the comment that I can
16 make here. The reconstitution came about because he had already talked
17 about dissolving and disarming these self-defence groups on the way to
18 peace and elections.

19 Q. [14:16:34] Very well. Thank you, Mr Witness.

20 You're talking to us about these self-defence groups that were dissolved and
21 disarmed. Now, for our better understanding, could you possibly tell us
22 what these groups or which these groups were? Maybe gave us their
23 names?

25 But these are names that I can no longer recall. There we are. I do

7 if each weapon had to be paid for. There we are more or less. But the
8 names aren't coming back to me. If they do come back to me, I'll tell you.

10 of the country, and you said that the Ouaga accords -- what accords are you
11 talking about here?

12 A. [14:18:18] The Ouaga accords that talk of reconciliation, disarmament,
13 election, et cetera. There were a number of accords that he worked under in
14 order to bring back peace.

15 Q. [14:18:42] When you say "Ouaga," do you mean Ouagadougou?

10 Ivorian government do in order to encourage the disarmament of these
11 groups?

12 A. [14:21:01] Which government are you referring to?

13 Q. [14:21:09] The Ivorian government.

14 A. [14:21:12] That of President Gbagbo or President Alassane?

15 Q. [14:21:19] I do apologise. I'm talking about the time of the
16 Ouagadougou accords, the time of the disarmament. What did the Ivorian
17 government do at the time to encourage the disarmament of these groups?

19 it be reinsertion, whether it be the payment of weapons handed in, and all of
20 this was encouraged by the president. That's what I was saying, that he even
21 travelled to the west of the country in order to preside over the first ceremony

23 group had been called and had been paid. And each head of a self-defence
24 group was requested to provide a list of their men, and this was done.
