12 The International Criminal Court is now in session.
13 Please be seated.
14 PRESIDING JUDGE TARFUSSER: [10:33:02] Good morning. Good
15 morning to everybody here inside and in the public gallery.
16 I think we have this half an hour to spend in questions by the OTP.
17 Good morning to you, Mr Witness. Can you hear me?
18 WITNESS: CIV-OTP-P-0321 (On former oath)
19 (The witness speaks French)
20 THE WITNESS: [10:33:29] (Interpretation) Good morning, Mr President.
21 Yes, I can hear you. Thank you.
22 PRESIDING JUDGE TARFUSSER: [10:33:34] Yes. Today we have another
23 bit of questioning by the Office of the Prosecutor and then we start with the
24 questioning by the Defence of Mr Gbagbo, okay?
25 THE WITNESS: [10:33:51] (Interpretation) Very well, Mr President.

1 PRESIDING JUDGE TARFUSSER: [10:33:53] So I give the floor immediately

2 to the Office of the Prosecutor for the questioning. Yours the floor.

3 MS PACK: [10:33:58] Thank you, your Honour. Good morning.

4 QUESTIONED BY MS PACK: (Continued)

5 Q. [10:34:03] Good morning, Mr Witness.

6 A. [10:34:12] Good morning, Ms Pack.

7 Q. [10:34:14] Now, we left off on Friday and I was going to play you a

8 video which I'll play you now.

9 And if we can have control of the technology going to the Office of the

10 Prosecutor, please, to my colleague Ms Chubin.

11 I'll play you a video that relates to the incident on 3 March 2011, and I would

12 ask you just to watch it and I'm going to ask you to identify the vehicles that

13 you see after.

14 A. [10:34:46] Very well.

15 MS PACK: [10:34:49] It's CIV-OTP-0082-0357. And, for the record, we want

16 to start at 3 minutes and 36 seconds and we'll conclude at 4 minutes and 32

17 seconds. And I should just note for the record also that this is a better

18 quality version of *CIV-OTP-0082-0357.

19 (Viewing of the video excerpt)

20 MS PACK: [10:36:30]

21 Q. [10:36:42] Now, I think you've seen a less high quality version of that

22 video before; is that right?

23 A. [10:36:57] Well, I believe that the quality of the video that I had seen

24 with the investigators was a lot better than this one. It's a shaky image, and

25 the image isn't very clear in terms of the movement of the vehicles.

1 Q. [10:37:15] What I'll do is I'll pull up some stills and then you can just
2 see the vehicles just still, in photos. So let's just start with the first one. It's
3 CIV-OTP-0079-5973.

4 And can we have the control back to the Registry, please, for these images.
5 Thank you very much.

6 You needn't worry about the order in that case. I'll just ask you just to
7 identify, these are stills from the moving image that you just saw.

8 A. [10:38:02] Very well, ma'am. Well, here I can see that it is a BTR-80
9 belonging to the Republican Guard.

10 Q. [10:38:34] Yes. And you were shown this earlier in your testimony.
11 So we can just move on to the next image, please, which is
12 CIV-OTP-0079-6054.

13 A. [10:38:59] The image has not yet changed. This is the same BTR-80
14 from the Republican Guard.

15 Q. [10:39:07] It will just take a couple of moments to come up. I think it's
16 appearing now.

17 A. [10:39:13] This is a four-by-four vehicle. By virtue of the colour, I can
18 say that it belongs either to the surface artillery battalion, or to the BASA, or
19 to the Republican Guard, or to the armoured battalion. Those are the three
20 units who often have such vehicles mounted with a 14.5 millimetre.

21 Q. [10:40:02] You referenced a 14.5 millimetre. Is that the weapon you're
22 saying is mounted there on the vehicle?

23 A. [10:40:09] Yes, I'm distinctly under the impression that it is a
24 14.5 millimetre.

25 Q. [10:40:25] Thank you. We'll go to the next image which is

1 CIV-OTP-0079-6177. We can deal with that briefly.

2 A. [10:40:59] Well, I believe that the same four-by-four vehicle that I
3 described earlier is there, and then just behind it I can see a white vehicle
4 resembling an ambulance by virtue of the siren and the rotating light on top
5 of it.

6 Q. [10:41:24] And then the next image at CIV-OTP-0079-6157.

7 A. [10:42:05] Here is a troops transport vehicle, blue in colour, but I
8 cannot say which unit it might belong to, this troops transportation vehicle.
9 But by virtue of its colour, it would seem that it is a gendarmerie vehicle.

10 Q. [10:42:28] And the next one, 0079-6349, can you identify that vehicle?

11 A. [10:43:15] Yes, yes. It is an RG-12 armoured vehicle belonging to the
12 national police. It is the riot brigade. It belongs to the riot brigade.

13 Q. [10:43:37] Now, when you were listening to the video just now, did
14 you hear gunshots?

15 A. [10:43:41] Yes, I did hear gunfire.

16 Q. [10:43:51] And can you tell from listening to the shots, and please say if
17 you can't, but can you tell from listening from which weapon those shots
18 came, which type of weapon?

19 A. [10:44:00] Well, if we could play it again because I was concentrating
20 on the images more and I didn't really listen.

21 Q. [10:44:25] We'll play it again then.

22 Can we have control going back to the OTP, please. And we'll just play
23 again the -- the same, excuse me, the same video which is CIV-OTP-0082 ...

25 MS PACK: [10:45:15] Apologies, just a little technical issue, but it will be

2 MR KNOOPS: [10:45:55] Mr President, good morning.

3 PRESIDING JUDGE TARFUSSER: [10:45:57] Yes, please, Mr Knoops.

4 MR KNOOPS: [10:46:00] Observation, the witness here is not examined as
5 an expert on ballistical issues. So the question of the Prosecution, although
6 understandable, I think is crossing the border of going to a witness of fact to
7 an expert, and I think on this reason the questions should not be put to the
8 witness because it also triggers the witness to speculate on what he might
9 have heard.

10 PRESIDING JUDGE TARFUSSER: [10:46:32] I'm not of this opinion. I think
11 it's a fact to which he can in any case say what he -- what he thinks, what he
12 knows and what he hears and give his factual answer.

13 So please go ahead.

14 (Viewing of the video excerpt)

15 MS PACK: [10:47:39] So it was played to 4.32.07.

16 Q. [10:47:56] Now, just having heard that again, are you able to decipher
17 shooting?

18 A. [10:48:03] Mr President, I believe that when I listen I would not like to
19 get things wrong. I believe that I'm not in a position to specifically identify
20 on the basis of sound the type of weapon that was firing because the noise
21 that I heard might be the noise of an *AA-52 or 14.5 millimetres, but it might
22 have been -- obtained such a noise by three Kalashnikovs being fired at the
23 same time. So I don't want to commit myself on this ground on the basis of
24 sound.

25 PRESIDING JUDGE TARFUSSER: [10:48:55] Mr Witness, I think this is

1 legitimate and understandable, so do not apologise. And we continue with
2 the questioning by the Office of the Prosecutor.

3 MS PACK: [10:49:07] Thank you.

4 Q. [10:49:08] To whom would you expect an incident involving civilian
5 demonstrators like this to be reported?

6 A. [10:49:16] Madam, looking at the image that you presented, I know
7 that the Ivorian army was professional enough at the time of the events,
8 which would lead me to believe that were I to interpret the image before me, I
9 would say that there must have been -- they must have been in a situation of
10 legitimate defence, or maybe amongst those people marching there were
11 people with heavy weaponry for the army to be in a position to then fire on
12 the crowd. Otherwise it might be a method --

13 Q. [10:50:13] Pause a moment. Well, continue, continue what you were
14 saying and then pause. I want to ask you a question.

15 A. [10:50:19] Very well. Also it might have been, in another case, a case
16 of firing into the air in order to disengage. So when I see or watch this video,
17 I can see that these situations must have unfolded, these two situations.
18 I wanted to describe those two situations because the first situation, if there
19 was gunshot, gunshot on a military cortège, protocol says or stipulates that
20 when you move around and when you come under enemy fire, you then
21 respond and then you report back to your immediate hierarchy, that is the
22 commander of the operational area.

23 Now, the second scenario, if there was no shots fired and were you to have
24 to fire into the air, then you also report back to the commander of the
25 operational zone to -- who gives you authorisation to open fire.

1 In both cases, reports -- they report back to the commander *of the
2 operational zone, who then reports back to the CPCO.

3 Q. [10:51:58] Yes, Mr Witness, I didn't ask you to speculate what
4 happened but simply the reporting lines. Now, you've told us the reporting
5 line is to the commander, who then reports to the CPO. That's the -- that's
6 *Sako, is that right, you mentioned earlier?

7 A. [10:52:19] Yes.

8 Q. [10:52:21] Then he reports to who?

9 A. [10:52:26] Yes, yes.

10 MR KNOOPS: [10:52:30] Mr President, I'm sorry to interrupt, but the
11 questioning of the Prosecution suggests that the firing was conducted within
12 the context of an official force within a reporting line, which is not
13 established. So I think the question to the witness whether this should have
14 been reported and to whom suggests an official reporting line. There is a
15 possibility that the shooting was conducted by in-official forces without
16 reporting line. So the question is somewhat misleading.

17 MS PACK: [10:53:07] I don't think it's at all misleading, actually.

18 PRESIDING JUDGE TARFUSSER: [10:53:10] No, I don't think it's misleading
19 also because the question was to whom such incident would have been
20 reported. So that's a legitimate question and we are expecting the answer.

21 MS PACK: [10:53:31]

22 Q. [10:53:31] I'll repeat the question then. So who did -- who would
23 Sakho report to?

24 A. [10:53:36] In the hierarchy, the -- *Sako reports to General Mangou
25 Philippe, the chief of general staff of the army.

1 Q. [10:53:55] And General Mangou would report to whom?

2 A. [10:53:58] As I said to you, he might either report to the minister of
3 defence, who -- well, the rest of the circuit, that's down to the political actors.

4 Q. [10:54:16] Now, you suggested two, two scenarios that might explain
5 this shooting. What if there was no shot on the convoy? Is it normal to
6 shoot at demonstrators?

7 MR O'SHEA: [10:54:39] That's a question of opinion.

8 PRESIDING JUDGE TARFUSSER: [10:54:41] This is a question of opinion. I
9 would say the same.

10 MS PACK: [10:54:43]

11 Q. [10:54:44] Now, let me just round off on this. At this time, and you've
12 mentioned some units who were asked to provide equipment to the Abobo
13 operational zone, at this time, 3 March, what equipment was based at Camp
14 Commando to your knowledge?

15 A. [10:55:07] At the Camp Commando of the Abobo squadron there were
16 armoured vehicles, the BTR-80s with a 14.5 millimetre gun and *16.5
17 millimetre guns. There was also an RG-12, as indicated earlier.
18 Also there was an AML of 90 millimetres. And there was also a mortar team.
19 It might have been 90 or 120 millimetres, I'm not sure, but there was a mortar
20 team.

21 And then, of course, there were troops armed with Kalashnikovs and with
22 PKMs.

23 Q. [10:56:19] And just briefly with the 90-millimetre AML, what's that?

24 A. [10:56:26] It is an armoured vehicle which is mounted with a gun of
25 90 millimetres. It was an armoured vehicle belonging to the Akouédo

1 armoured battalion.

2 Q. [10:56:48] Now, I'm moving topic and we'll have to be -- I'll have to be
3 quick. Now, you testified on 8 July, that's Friday, you testified about
4 someone called Alcide Djédjé, who you said was, in French, I use the French
5 word, "un homme de confiance" of the president --

6 A. [10:57:14] Oui.

7 Q. [10:57:15] -- Laurent Gbagbo. What did you mean by that, "un homme
8 de confiance" in French?

9 A. [10:57:21] I don't know quite what explanation to furnish. I mean, "Un
10 homme de confiance" is an "un homme de confiance," this is somebody you
11 can trust.

12 Q. [10:57:41] Were there others around the president, to your knowledge,
13 whom he could trust?

14 A. [10:57:47] Yes, somebody like Mr Sangaré *Aboudramane. You know,
15 these were trustworthy individuals.

16 MR N'DRY: [10:58:11] (Overlapping speakers)

17 THE INTERPRETER: [10:58:17] Overlapping speakers, Mr President.

18 PRESIDING JUDGE TARFUSSER: [10:58:20] Mr Witness. Yes, I know.

19 Mr Witness, can you a moment hold on because Maître N'Dry is going to say
20 something on this.

21 You have the floor.

22 MR N'DRY: [10:58:27] (Interpretation) Mr President, I believe that we are
23 here entering into an area of pure speculation. How can we ask a witness
24 who is not close to the president to say who *were the trustworthy
25 individuals around *the president? We are really entering, or up against an

1 approach here that will *lead to the witness saying things that he really is not
2 in a position to know. *Trust is something personal. It is the person who
3 vests that trust in another person who can say whether yes or no, not
4 someone else.

5 PRESIDING JUDGE TARFUSSER: [10:59:33] I do quite agree. That's why I
6 think if you reformulate or --

7 MS PACK: Yeah.

8 PRESIDING JUDGE TARFUSSER: -- put it another way, but I think without
9 putting the witness in front of possible speculations. Thank you.

10 MS PACK: [10:59:49] Thank you.

11 Q. [10:59:50] Now, you mentioned -- you mentioned before Bertin Kadet.

12 Were you aware from your direct experience what the president's
13 relationship was with this man?

14 A. [11:00:07] I said that Mr Bertin Kadet was the minister of defence and
15 as such he was the -- he was in charge of the Ministry of Defence. He is a
16 family member of Mr Laurent Gbagbo. He hails from the same village, and
17 he is in charge of an association of managers in the town of Mama.

18 MS PACK: [11:00:59] Your Honour, in order to deal with this more
19 effectively, I think I will need to go into private session, if I may.

20 PRESIDING JUDGE TARFUSSER: [11:01:07] Can we go into private session,
21 please.

4 then, just in relation to the list that you gave us of persons in the "carré
5 décisionnel" around Mr Gbagbo. So you had talked about Vagba
6 Faussignaux, and I just wanted to ask you in reverse order, Désiré Tagro, who
7 was that?

8 A. [11:12:21] Désiré Tagro was the minister of the interior.

9 Q. [11:12:28] And do you know the ethnicity of this person?

10 A. [11:12:36] He's from the *Issia region, which is somewhat to the west,
11 the western part of Côte d'Ivoire.

12 Q. [11:12:53] Are you able to state his ethnicity or not?

13 A. [11:12:58] Yes, *Issia is a Bété area. He's a Bété. He's Bété from Issia.

14 Q. [11:13:11] And then you mentioned other people. You also mentioned
15 Mr Alain Lobognon, Lobognon - I'm sorry - who was he?

16 A. [11:13:26] Mr Alain Lobognon -- no, it's not Alain -- Alain Dogou. I
17 beg your pardon. Not Alain Lobognon. Alain Dogou. Not the other
18 Alain.

19 Q. [11:13:48] And Alain Dogou was who?

20 A. [11:13:52] At the time of the events, he was the minister of defence.

21 Q. [11:14:05] And then, please, you also in that list, I think then, the other
22 two were Bertin Kadet. If you could just tell us, please, you mentioned him
23 before, he -- what his position had been or were at the time?

24 A. [11:14:34] Yes, yes. He was the minister, well, that was before the
25 post-election crisis. He was at the presidency. But, well, he was more of an

1 advisor. At the time of the events he was an advisor, an advisor to the
2 defence ministry.

3 Q. [11:14:57] And previously had he been the minister of defence at one
4 time?

5 A. [11:15:01] Oh, yes, before the crisis.

6 Q. [11:15:08] Was he minister after Lida Kouassi?

7 A. [11:15:17] Yes, he was the minister after him and then after that there
8 was Minister Amani, René. And then there were other ministers, Assoa
9 Adou. There were several other ministers.

10 Q. [11:15:34] And for Alain Dogou, what was -- going back to him, sorry,
11 what was his ethnicity?

12 A. [11:15:41] I don't know what his ethnicity was.

13 Q. [11:15:52] Bertin Kadet, do you know his ethnicity?

14 A. [11:15:56] *I said that he comes from Gagnoa. He is a Bété person.

15 Q. [11:16:03] You mentioned also Alcide Djédjé. Do you know his
16 ethnicity?

17 A. [11:16:12] Yes, yes. I think he's a Bété person as well.

18 Q. [11:16:18] Do you know, you mentioned before in your testimony,
19 Katina Koné.

20 A. [11:16:29] Oh, yes. That person was the minister of the -- responsible
21 for the budget. Minister Katina Koné, Tagbana, from Katiola region
22 somewhat to the north.

23 Q. [11:16:47] Do you know his ethnicity?

24 A. [11:16:49] I said that he was Tagbana, Tagbana. That's an ethnic group
25 somewhat to the north of Côte d'Ivoire. After Bouaké.

1 Q. [11:17:05] Do you recall mentioning previously a Désiré Dallo?

2 A. [11:17:17] Oh, yes, Désiré Dallo.

3 Q. [11:17:23] And who was that?

4 PRESIDING JUDGE TARFUSSER: [11:17:25] Maître Gbougnon.

5 MR GBOUGNON: [11:17:27] (Interpretation) Your Honour, now, the witness

6 mentioned this "carré décisionnel," this group of decision-makers. *And I believe

7 that he mentioned four people. Now the Prosecutor is mentioning names of

8 people whom he did not mention as part of what he called the "carré

9 décisionnel" I don't know on what grounds because this witness has mentioned

10 several names. So what is the link she is making between this – all these various

11 names she is mentioning now and what the witness said previously?

12 PRESIDING JUDGE TARFUSSER: [11:18:04] The Prosecutor.

13 MS PACK: [11:18:05] The witness can tell us that.

14 Q. [11:18:06] Could you tell us, please, the link, all these people that

15 you've named and the group of decision-makers? What's the link?

16 PRESIDING JUDGE TARFUSSER: [11:18:17] Is there a link, first of all?

18 Q. [11:18:19] Is there a link between them and the group of

19 decision-makers?

20 A. [11:18:23] Yes, I just wanted to say that those were the people who

21 were around the president. That's what I meant. And I mentioned those

22 various names. I omitted, I didn't mention Mr Désiré Dallo and I was going

23 to tell you about that person.

3 dealing with two things here. Initially the witness spoke about the "carré
4 décisionnel," the group of decision-makers. And now *we are talking about a group
5 of people within the inner circle or around the *president. When the Prosecutor
6 puts her questions, she says something different. Either we use the expression
7 "people around the president" or we use the word "decision-makers." These are
8 two different things because the witness says, he is talking about them because they
9 are the ones who were around the president.

10 PRESIDING JUDGE TARFUSSER: Agreed. It's a bit of a confusing scenario.

11 MS PACK: [11:19:35] Okay. Well, I've just asked the witness the question
12 and he said yes. Were these people in the group of decision-makers that you
13 had spoken about? And his answer was yes.

14 Q. Just to clarify that you're not talking about another group, you're
15 talking about the group of decision-makers, and the people you have
16 described to us, were they within that group?

18 Q. [11:20:05] And was there a group of decision-makers also around the
19 first lady, Mrs Gbagbo?

20 A. [11:20:12] Well, I gave you a number of names, and I added the
21 various --

1 The first is the point which Mr Altit addressed a moment ago. Your
2 Honours will remember Mr MacDonald at the beginning of this witness
3 standing up and making the point that under no circumstances can this
4 witness be split. And it's in that context that we have been very careful
5 about time.

6 We, of course, on the side of the Defence, we are confronted with 500 pages
7 of interviews.

8 PRESIDING JUDGE TARFUSSER: [11:21:11] I do get a bit irritated with the
9 OTP which, after 30 minutes now it's nearly an hour taking, so I really urge
10 the OTP to finish in 8 minutes time, okay, because I give you 8 minutes and
11 then it's finished.

12 MR O'SHEA: [11:21:27] The other point is this, I'm not sure we have notice
13 of this. We've got 500 pages of interviews which I've read through, and
14 maybe my friend can help me to locate where this is in the interviews because
15 if she is going outside the scope of the interviews, then that's another issue,
16 then she's addressing issues we don't have notice of.

17 MS PACK: [11:21:48] No, well, I'll give -- I'm reading, actually reading from
18 the transcript as I ask the question. So it's transcript 16, item number 16 on

8 you are -- if you come under attack but there is no situation of legitimate
9 defence, here, for example, it is a military convoy that is not conducting a law
10 enforcement mission, then it can fire into the air, and have people scatter, and
11 make the most of people fleeing in order to move on.

12 Q. [12:43:05] If I understand you correctly, you are saying to us that these
13 pictures can be read in three different ways. So, you know, correct me if I
14 am wrong in what I am saying. You are at freedom -- you are free to say
15 whatever you like here.

16 So first scenario, the gunshot comes from the convoy on to the crowd
17 gratuitously, you understand? Secondly, there is gunfire from the convoy
18 against assailants and *thus the convoy is in a situation of legitimate defence.
19 And third scenario, they're firing into the air from the convoy and they're
20 trying to get themselves out of the situation, or it's warning shots.
21 And, fourthly, there is attack and gunfire coming from attackers without the
22 convoy answering.

23 Are those the four ways in which these images can be read?
