4 A. [10:37:24] The instructions given for the protection of the civilian  
5 population, are you talking about these generally speaking or specific  
6 instructions concerning Abobo?

7 Q. [10:37:53] Well, at the moment, I'm on a general level. At the moment  
8 I'm on a general level. When there were operations which had to be  
9 conducted, are you able to comment on what were the standing or usual  
10 instructions in relation to the protection of the civilian population, on a  
11 general level first?

12 A. [10:38:19] I would say that, generally speaking, the military authorities  
13 circulate a message in which the situation is assessed and specific missions  
14 are assigned to us and the methods in which those missions have to be  
15 implemented.

16 Q. [10:38:56] And what would normally, if there was anything, normally  
17 be said about the protection of civilians?

18 A. [10:39:15] Let me tell you that it depends on the type of mission. The  
19 mission for the protection of civilians is a major mission, generally speaking;  
20 the protection of their property and the population and ensure that there are  
21 no acts of violence, rapes, pillaging and so on. But when it comes to a  
22 specific situation, it is what is happening on the ground that determines the  
23 nature of the missions to be accomplished.

24 Q. [10:40:06] And without referring to any specific incidents at this stage,  
25 what about in the context of a march?

1 A. [10:40:19] For a march, you would be in, you would be informed that  
2 there is a march, the situation would be explained to you, that certain people  
3 would be marching from such a location to another location and that your  
4 mission is to provide security for that march, which means you will have to  
5 guide the march from point A to point B.

6 Q. [10:41:17] Now, during the course of your testimony, you spoke about  
7 the fact that in a time of crisis, the chef d'état-major would, would be  
8 essentially the head of operations. When you use the word "operations,"  
9 were you talking about only military operations or were you talking about  
10 military and non-military operations?

11 A. [10:41:57] When I talk about head of operations, this means everything  
12 that relates to the defence and security forces, the responsibility would be that  
13 of the chief of general staff. That is the person who directs all the actions that  
14 have to be taken.

15 Q. [10:42:31] Now, on a slightly different aspect, when we were at the  
16 time of the post-electoral crisis, did there come a time when there were  
17 difficulties of communication with Mangou or others in high authority?

18 A. [10:43:00] I can say that there are or there were unit commanders who  
19 were not able to contact their hierarchical leaders. There were also internal  
20 communications between the networks and the VHF systems which were  
21 disrupted.

22 Q. [10:43:54] By who?

23 A. [10:43:56] Well, I do not know, but I know that it was no longer  
24 possible to communicate with the entire hierarchy using the VHF system.  
25 We were compelled to use a local channel with a range of between 1.5 and

15 taken place during the course of the events in 2010 and 2011, so far as you  
16 know, Mr Witness, what measures were taken by the high command of the  
17 military to ensure the safety of vehicles when they moved in convoy?

18 A. [11:01:18] First of all, there were not many convoys travelling, not many  
19 military vehicles moving about because the Invisible \*Commando was training,  
20 so at any moment the different vehicles. So in terms of the safety of convoys  
21 towards Abobo, security was stepped up, particularly military convoys.

22 Q. [11:02:04] As far as you know, were any decisions taken about the size  
23 of a convoy or a minimum number of vehicles that should be in a convoy or  
24 the nature of the vehicles that should be in a convoy for the purpose of  
25 securing that convoy?

1 A. [11:02:19] Yes, we could see that when vehicles moved towards Abobo,  
2 the defence and security forces would have the armoured battalion vehicles  
3 first and then there would be the vehicles of the Republican Guard, and then  
4 after that you would have the armoured vehicles from the gendarmerie, and  
5 then after that the vehicles for transportation of personnel, including pickup  
6 trucks, and then at the end of the convoy, you would have the riot police  
7 armoured vehicles.

8 Q. [11:03:23] Obviously every situation is different, but in terms of the  
9 description you've just given, what kind of numbers of vehicles would one  
10 expect to see in a convoy like that?

11 A. [11:03:38] Well, assuming normal operations, you would have at least  
12 one armoured vehicle from the Republican Guard, then two, you would have  
13 one armoured vehicles from the gendarmerie, and then, well, there are two  
14 personnel carriers, and perhaps at the height of the crisis two or three pickup  
15 trucks with heavy weapons mounted on them, as well as one armoured  
16 vehicle from the Republican Guard.

17 So, generally speaking, the convoy would contain between eight and ten  
18 vehicles during normal operations.

1 Q. [11:06:43] Now, Mr Witness, we're in open session again, and I'm going  
2 to move on to a new topic, which is the question of the DDR, the  
3 disarmament, demobilisation and reintegration. So I will take you through  
4 chronologically, if I may, through the years that are relevant to us and see  
5 what you can do to help us on this topic.

6 Now, we know there was the agreement of Linas-Marcoussis in 2003 and in  
7 that agreement there were dispositions with regard to DDR. And if I can  
8 situate you in time, if we move in the same year, 2003, to the 11 of July, 2003,  
9 is it right there was installed in Bouaké a headquarters for trying to put into  
10 effect and implement the DDR?

11 A. [11:08:05] I don't know the specific date, but I do know that the Bouaké  
12 department for the DDR was established during that year, namely, 2003-2004.

13 Q. [11:08:38] And I understand you've said you're not that good with  
14 dates, and that's okay, and I'm just trying to help you situate yourself and also  
15 trying to help the Chamber follow the sequence of my questions. So don't  
16 worry too much about the specific dates which I give you, but they're there to  
17 situate you. If any particular date is in dispute, the Prosecution will tell me.  
18 On 16 July 2003, did you hear that there was a committee that was put in  
19 place, again, with a view to implementing the disarmament process?

20 A. [11:09:29] Yes.

21 Q. [11:09:37] And do you know how that committee was composed and  
22 anything about its operation?

23 A. [11:09:52] No, I don't. Mr Ouattara, Mr Ouattara was the person  
24 responsible for that committee, the DDR committee, namely, DDR for the  
25 former combatants. And regarding the recruitment of personnel, well, that's

1 all. I know that there was a gendarmes who was part of that structure.  
2 There was Captain Nanga, Captain Nanga from the gendarmerie, and  
3 Colonel N'Guessan who took part -- well, he was part of another committee  
4 or something of the like, the CCI.

5 Q. [11:10:48] CCI standing for?

6 A. [11:10:54] The integrated command centre.

7 Q. [11:11:06] And its mandate as far as you know?

8 A. [11:11:11] The integrated command centre, generally speaking, had a  
9 mandate to merge the two commands, namely, the command of the New  
10 Forces at the time and ensure coordination with the defence and security  
11 forces. So as part of that, you see, General Kouakou Nicolas was designated.  
12 And during the elections, there was a government order and the CCI was  
13 requisitioned and in actual fact that centre was working with soldiers from  
14 the two armies.

15 THE INTERPRETER: [11:12:06] Interpreter correction. The general  
16 mentioned was General Kouakou Nicolas.

17 MR O'SHEA:

18 Q. [11:12:15] Now, one of the other aspects which was included in the  
19 agreements of Linas-Marcoussis was the idea in order to facilitate this process  
20 that there should be amnesty for rebels who could then disarm and  
21 reintegrate. Can you confirm that there was an amnesty process that was  
22 put in place?

23 A. [11:12:46] Yes, there was an amnesty process and thus many rebels  
24 were not prosecuted. But I realised that (Redacted) that it was a  
25 kind of amnesty that was limited in nature. Because in 2002, the death of

1 Guéï Robert was also part of the amnesty issue because people were talking  
2 about all the events that occurred in 2002 and the collateral damage, so to  
3 speak. (Redacted)

6 Q. [11:14:04] Was it right that those crimes which were excluded were,  
7 first of all, human rights violations? Human rights violations were excluded  
8 from the amnesty, weren't they?

9 A. [11:14:31] I haven't quite understood.

10 Q. [11:14:38] Well, you've just said that the amnesty did not apply to all  
11 crimes. Is it right that the crimes --

12 A. [11:14:44] Yes.

13 Q. [11:14:44] -- that it did not apply to included human rights violations?

14 A. [11:14:50] Truly, I don't want to analyse the criterion, (Redacted)

17 Q. [11:15:22] Just to correct myself for the record, I should have said grave  
18 violations of human rights, not just human rights violations.

19 And with respect to the period that it covered, it included from the 17 of  
20 \*December 2000 to the 19 of September 2002. Would that accord with your  
21 recollection of the period that the amnesty would cover in terms of crimes?

22 A. [11:15:56] Yes, counsel.

23 Q. [11:16:12] So the actions which were taken in order for the rebels to  
24 secure the north of the territory of Côte d'Ivoire and to install themselves, I  
25 say install themselves partially in Abobo, all of those actions would have been

1 covered by the amnesty because they would be covered by that period.

2 Would that be right?

3 A. [11:16:57] Yes, normally that would be the case except for crimes  
4 involving bloodshed.

5 Q. [11:17:16] And just for completion on this topic, there was actually a  
6 law which was passed, wasn't there, a law on amnesty, the date being  
7 6 August 2003. You may not know the detail, but it was actually passed into  
8 law through the national parliament.

9 A. [11:17:50] Yes.

10 Q. [11:17:54] And was there a quid pro quo from the rebels, did the rebels  
11 disarm in 2003?

12 A. [11:18:10] Yes. Now, normally going by my understanding of what  
13 happened, it was a process whereby they were granted amnesty. They were  
14 told they would not be prosecuted, and they in return took part in the  
15 disarmament process and -- which the state authorities had established  
16 throughout the entire country.

17 Q. [11:18:50] And what was the reality in 2003 with regard to control of  
18 the state over the entire territory of Ivory Coast?

19 A. [11:19:07] Between 2003 and 2011, the state did not have authority  
20 throughout the entire country. The state had authority over two areas, one  
21 area where the rebels -- well, there were, you see, there were demarcation  
22 lines that went through Bouaké that divided the country in two, between the  
23 west and the east.

24 So nothing was done until 2011, when the post-election crisis broke out. So,  
25 you see, state authority was not established throughout the entire country.

12 aspect was revisited with more determination. Now, did you hear about the  
13 steps which were taken to implement the agreements in Pretoria for the  
14 purposes of making this PNDDR, this national plan for disarmament,  
15 demobilisation and reintegration a reality?

16 A. [11:27:24] I don't have the details about the Pretoria agreement. I've  
17 given you a general overview of what was understood by DDR. But I really  
18 don't have the specific details or what specific measures were taken with a  
19 view to obtaining the DDR.

20 Q. [11:27:45] What about a meeting in 2005 between the FDS and the  
21 Forces Nouvelles with a view to creating one army, is that something you  
22 have any knowledge of?

23 A. [11:28:01] I made mention of the integrated command centre, the CCI,  
24 led by General Kouakou Nicolas, because you see, the CCI was, well,  
25 something along those lines.

1 Q. [11:28:26] And in terms of what you know, did the situation improve at  
2 all with regard to the implementation of DDR once this organ had been  
3 created?

4 A. [11:28:54] To be quite frank, there was a ceremony in Bouaké with a  
5 flame of peace. And there were weapons, these weapons were destroyed.  
6 But they were old weapons, and there really were no probative results, no  
7 effective results in terms of disarmament. They burnt some old weapons.

8 Q. [11:29:42] You've already spoken quite a lot about the weapons of the  
9 rebels. You've just said that the ones that you saw destroyed were old arms,  
10 old weapons. When you encountered the rebels, and when your units  
11 encountered the rebels, were they using new arms, new weapons?

12 A. [11:30:19] I really couldn't say new weapons, but they were using  
13 operational weapons. When I mentioned old weapons that had been burnt, I  
14 believe that the images exist. If you look at the images, you will see some  
15 rifles that had been used in the First World War in 1914 and MAT-49s that  
16 were used during the Second World War. Those weapons were burnt,  
17 destroyed. Maybe a few Kalashnikovs, but they were quite old, obsolete  
18 weapons. So you could see from the images that yes, those weapons were  
19 destroyed. They were burnt, and you can see for yourself and confirm what  
20 I've said.

21 Q. [11:31:28] And this observation that you've just made, was this shared  
22 by the military generally? Was this well known?

23 A. [11:31:38] I'm not in a position to say. I do not know what everyone  
24 thought. But those images are very clear. If you see them, you will know.  
25 During that ceremony, I believe that President Laurent Gbagbo and Charles

6 FDS has a mission to protect the civilian population. But if there is a march  
7 that disrupts public order, the orders given were to disperse the march by  
8 using tear gas.

9 Q. [11:39:31] With respect to the use of tear gas, can tear gas be fired from

20 practically the leader of that march.

22 A. [11:47:59] KKB was a member of the RHDP. In fact, it would be very  
23 difficult to distinguish between the RHDP and the rebels. It is really difficult  
24 to make any distinction between them.

7 kilometres, because he marched a lot. But I never saw or observed

9 usually uses the expression "street general," and this is because the  
10 secretaries general of FESCI were known as generals. So Soro Guillaume  
11 was also called general. Ahipeau was also referred to as a general. And Blé  
12 Goudé, who was also secretary general of FESCI, was referred to as general.  
13 I can therefore say that I never observed him leading a group of militia. He  
14 was the initiator of protest marches and demonstrations against the French  
15 army, sit-ins in front of the French embassy. It was Blé Goudé who  
16 organised that. He was the one who took his mattress to go and sleep in  
17 front of the 43rd BIMA.  
18 And when he came to the airport where I went to pick him up, we had a  
19 discussion inside the car. I told him, "Really it is a good thing that you have  
20 returned because we have done everything that we can do at the military
