8 (The hearing starts in open session at 9.31 a.m.)
9 THE COURT USHER: All rise.
10 The International Criminal Court is now in session.
11 Please be seated.
12 PRESIDING JUDGE FREMR: Good morning, everybody.
13 Court officer, please call the case.
14 THE COURT OFFICER: Thank you, Mr President.
15 The situation in the Democratic Republic of the Congo, in the case
16 of The Prosecutor v. Bosco Ntaganda, case reference ICC-01/04-02/06.
17 And for the record, we are in open session.
18 PRESIDING JUDGE FREMR: Thank you, court officer.
19 Now appearances please in usual order starting with Prosecution.
20 MS SOLANO: Good morning, your Honours. The Prosecution is represented by
21 Rens van der Werf, assistant trial lawyer; Eric Iverson, trial lawyer; Laura Morris,
22 assistant trial lawyer; Selam Yirgou, case manager; and I am Julieta Solano, trial
23 lawyer.
24 PRESIDING JUDGE FREMR: Thank you, Ms Solano.
25 Now Defence, please.

1 MR BOURGON: (Interpretation) Good morning, this morning. Good morning,
2 your Honours, as well as everybody else present in the courtroom. Representing
3 Bosco Ntaganda, who is present this morning, Maria-Kim Vasconi, Sandrine De Sena,
4 Margaux Portier, and myself, Stéphane Bourgon. Thank you very much, your
5 Honour.

6 PRESIDING JUDGE FREMR: Thank you, Mr Bourgon.

7 Now Legal Representatives of Victims, please.

8 MS PELLET: (Interpretation) Thank you, your Honour. The former child soldiers
9 are represented by myself, Sarah Pellet, counsel with the Office of Public Counsel for
10 Victims.

11 MR SUPRUN: Good morning, your Honour, your Honours. The victims of the
12 attacks are represented by the Office of Public Counsel for Victims, Anne Grabowski
13 and myself, Dmytro Suprun.

14 PRESIDING JUDGE FREMR: Thank you, Ms Pellet. Thank you, Mr Suprun.

15 And I further note the presence of the legal adviser appointed pursuant to Rule 74
16 of the Rules so assist the witness.

17 Welcome, and please state your name for the record.

18 MR VON BÓNÉ: (Interpretation) Good morning, your Honour. Julius von Bóné
19 and I am the legal counsel for the victim, thank you -- the witness.

20 THE INTERPRETER: Corrects the interpreter.

21 PRESIDING JUDGE FREMR: Thank you very much, Mr von Bóné.

22 As you all know, we are going to conduct testimony of the last witness of this
23 evidentiary block, but before the witness can be called I will be addressing a few
24 procedural matters.

25 First, the Chamber recalls it's oral decision contained in transcript number 116,

1 granting in-court protective measures for Witness P-769 in the form of face and voice
2 distortion and the use of pseudonym.

3 The Chamber had to defer its decision of special measures until receipt of the VWU's
4 vulnerability assessment for this witness.

5 And now we shall move into private session to deliver the Chamber's ruling on this
6 matter.

7 So, court officer, please, let's move into private.

8 (Private session at 9.35 a.m.) *(Reclassified partially in public)

9 THE COURT OFFICER: We are in private session, Mr President.

10 PRESIDING JUDGE FREMR: Thank you, court officer.

17 As noted in its decision on in-court protective measures, the Chamber will determine
18 on a case-by-case basis the relevant time during the witness testimony whether
19 private sessions are necessary for hearing certain of his evidence.

20 Next, Mr von Bóné is present, as I said, to assist the witness in respect of any
21 self-incrimination issues which may arise. Mr von Bóné informed the Chamber by
22 way of filing 1452 yesterday that he has met with the witness and explained Rule 74
23 of the Rules to him. Mr von Bóné further requested assurances under Rule 74(3)
24 of the Rules on behalf of this witness. The Prosecution subsequently provided
25 observations on this issue by way of email and indicated that it considers the granting

1 of such assurances appropriate. So, accordingly, the Chamber shall provide
2 assurances under Rule 74(3) in the presence of the witness before he commences
3 testifying.

4 PRESIDING JUDGE FREMR: Mr von Bóné, is there anything you wish to add while
5 we are in private session and addressing this particular topic?

6 MR VON BÓNÉ: No, your Honour. I think it covers it all.

7 PRESIDING JUDGE FREMR: All right then. So now we can move into open
8 session for the next issue.

9 (Open session at 9.38 a.m.)

10 THE COURT OFFICER: We're in open session, Mr President.

11 PRESIDING JUDGE FREMR: Thank you, court officer.

12 According to its email of 10 July 2016, the Defence objects to certain documents
13 the Prosecution may seek to use with or to tender through this witness. These
14 objections will be addressed if and when they arise throughout the course of the
15 examination-in-chief.

16 And finally the Chamber will address the issue of timing for this witness. By way of
17 email of 12 May 2016, the Chamber encouraged the Prosecution to complete its
18 examination-in-chief of this witness within five hours. The Chamber notes that after
19 this email was sent the Prosecution continued to list a six-hour estimate in its updates
20 to the list of forthcoming witnesses. However, in light of the topics the witness is
21 expected to testify about and the materials for this witness, the Chamber finds five
22 hours to be an appropriate amount of time for examination-in-chief.

23 The Prosecution is therefore instructed to finish its questioning within such time.

24 And as usual, the Chamber therefore considers the Defence ought to complete its
25 cross-examination in the same amount of time.

1 So now we can turn to the scheduled testimony.

2 Court officer, please have the witness brought in the courtroom.

3 (The witness enters the courtroom)

4 PRESIDING JUDGE FREMR: Good morning, Mr Witness. Can you hear me?

5 WITNESS: DRC-OTP-P-0769

6 (The witness speaks French)

7 THE WITNESS: (Interpretation) Yes, good morning, I can hear you.

8 PRESIDING JUDGE FREMR: Very well. Mr Witness, on behalf of this Chamber I
9 would like to welcome you to the courtroom. You are called to testify in the case
10 against Mr Bosco Ntaganda. You will be soon asked questions both by the Judges
11 and lawyers and in this connection I would like to guide you as follows:

12 Please listen carefully to those questions. If you do not understand, feel free to ask
13 for the question to be repeated.

14 We want you to tell the truth and tell us what you saw, heard, and sensed yourself.

15 If you did not see or hear it yourself, but you found out some other way, then you
16 should explain how.

17 Please testify just on that which you remember. Don't guess. Don't make things up.

18 There is nothing wrong in saying, "I don't know" or "I don't remember."

19 Do you understand all this, Mr Witness?

20 THE WITNESS: (Interpretation) Thank you. I have understood well.

21 PRESIDING JUDGE FREMR: Good. Mr Witness, protective measures are put in
22 place to ensure that your identity is not revealed to the public. It means that the
23 public cannot see your face and that your voice is being disguised so that the public
24 cannot recognize it. We all will refer you as "Mr Witness" and ensure that your
25 name and any other information that risks revealing who you are is not broadcast to

1 the public. Therefore, whenever you need to describe anything that might reveal
2 your identity, we will do so in private session so that no one outside the courtroom
3 can hear your answer.

4 Do you understand, Mr Witness?

5 THE WITNESS: (Interpretation) Yes, I understand.

6 PRESIDING JUDGE FREMR: Fine. Mr Witness, you also have been assigned
7 a lawyer, who is sitting on your right, to provide you with legal advice about possible
8 self-incrimination. Mr von Bóné also has requested that you be given certain
9 assurances by the Chamber.

10 There may be questions asked to you for which you can fear that answering them
11 truthfully may incriminate you because these questions relate to your own conduct.

12 In such cases we will require you to answer the question, but we can assure you that
13 your answer will be kept confidential and will not be disclosed to the public or to the
14 government of any country.

15 Moreover, the Prosecution has further assured that they will not themselves use this
16 information to prosecute you before the ICC, provided that you tell the truth.

17 Do you understand all this, Mr Witness?

18 THE WITNESS: (Interpretation) Yes, I have understood.

19 PRESIDING JUDGE FREMR: And in this regard I request the parties to be vigilant
20 about going into private session for areas of evidence that are likely to elicit responses
21 that might self-incriminate the witness.

22 Now, Mr Witness, you will be provided with a piece of paper containing the solemn
23 undertaking. So please now make your solemn undertaking to tell the truth by
24 reading out the declaration you have in your hands, please.

25 THE WITNESS: (Interpretation) Do I need to stand up for this?

1 PRESIDING JUDGE FREMR: It would be better.

2 THE WITNESS: (Interpretation) I solemnly declare that I will tell the truth, the
3 whole truth and nothing but the truth.

4 PRESIDING JUDGE FREMR: Thank you very much, Mr Witness. You can sit
5 down.

6 And now you are under oath, so you also need to be aware that it's an offence within
7 the jurisdiction of this Court to give false testimony.

8 Do you understand that?

9 THE WITNESS: (Interpretation) Yes, I understand.

10 PRESIDING JUDGE FREMR: All right. And finally a few practical matters you
11 should have in mind when giving your testimony:

12 It's important to speak into the microphone, to speak clearly and to speak at a slow
13 pace approximately like me now.

14 When a question is asked, please do not respond immediately, it's very important, but
15 count in your head to three and only then give your answer. This pause is essential
16 to properly interpret and record what you are saying.

17 And if you have any questions during your testimony or if you feel that you need
18 a break, do not hesitate to let us know by raising your hand. We will then give you
19 the opportunity to speak.

20 Have you understood all that, Mr Witness?

21 THE WITNESS: (Interpretation) Yes, I've understood.

22 PRESIDING JUDGE FREMR: Very well. Then we can start with your testimony.

23 So now Prosecution, I guess it will be Ms Solano, yes, you have the floor.

24 MS SOLANO: Thank you, your Honour.

22 Q. At the time that you joined the UPC, who was in control of Bunia?

23 A. It was -- there was -- first of all, there was the UPC, there was the RCD of Mbusa

24 Nyamwisi -- no, first of all it was the RCD which was in control of Bunia town.

1 Q. What do you mean that the UPC was already there?

2 A. The UPC was there, there were events that were taking place, one would hear
3 about it on the radio and we would even see them. Thomas Lubanga was
4 the minister for youth and sport in Mbusa Nyamwisi's movement, and it was when
5 he left that movement that he set up the UPC.

6 Q. Did Mbusa Nyamwisi remain in control of Bunia?

7 A. No.

8 Q. Did anyone else come to control Bunia after he did?

9 A. I think that there was a Professor Wamba Dia Wamba with -- he was I think
10 with the pro-government forces or pro-RCD, I think, I'm not sure, and then later it
11 was UPC that took control of the town.

12 Q. Do you remember the date on which the UPC took control of Bunia?

13 A. No. I know that there were clashes with the APC. The APC was the army of
14 Mbusa Nyamwisi with Professor Wamba Dia Wamba.

15 Q. When you joined the UPC, had the UPC already taken control of Bunia?

16 A. Yes.

17 Q. When I asked you a moment ago what you meant that the UPC was already
18 there, you referred to -- you said you would hear about it on the radio and you would
19 even see them. Can you explain what you mean?

20 A. Yes.

21 Q. There were militiamen passing through town in jeeps, singing. There were big
22 events held in the town; for instance, there were days when -- there were the days
23 when Commander Bosco Ntaganda had killed a Commander Claude. That, I think,
24 was one of the big UPC events. There was also the arrest of Chief Kahwa and his
25 release by Bosco Ntaganda.

1 There was also a murder, Bosco Ntaganda shot a military inspector dead. He was
2 called Inspector Ngwene, Ngwene. He murdered him and then he released
3 Chief Kahwa to bring him back to Mandro.

4 And it was those type of events that made UPC a well-known force and, if you like,
5 were triggering events.

6 Q. Did you see the killing of Claude and the killing of Inspector Ngwene yourself?

7 A. I think -- I don't know if I have understood correctly. Did you see -- did you
8 see, or do you mean was I present?

9 Q. My question was did you see?

10 A. No. (Redacted)

1 A. He is Hema-Nord.

4 A. (Redacted) And it was the word

5 "cadre", just like you use it also in English. And that word "cadre" was known in the

6 town because it was also used by the RCD rebellion. They also talk about the cadre,

7 they too at the time, the RCD, would also hire cadre who were in fact information

8 officers, journalists, politicians.

9 Q. What kind of movement was the UPC?

10 A. At the outset, the UPC was a military movement.

11 Q. And so what was your understanding at this point in time that the cadre would

12 do in this movement? Were they supposed to have a role in the management of the

13 militia?

14 A. I believe that the idea was to train people who would be good in politics who

15 would be negotiators, journalists, spokespersons for the movement, if you like, the

16 diplomats of the movement.

2 Q. And apart from you, were any other students present at this meeting?

3 A. Yes, there were other students present.

4 Q. What ethnic group or groups did they belong to?

5 A. Most particularly Bahema.

6 Q. Which UPC members were present at this meeting at the primary school?

7 A. There was Commander Bosco, Commander Rafiki, Professor Dhetchuvi.

8 I don't know if Professor Pilo was actually a member of the UPC, but he was certainly

9 a dignitary in the Bahema community. There was also an official called Lokuni

10 Nembe, as well as other people who I didn't know.

11 Q. What was this Commander Bosco's full name?

12 A. He was called Bosco Ntaganda. And he also went by the name of Tango

13 Romeo.

14 Q. What makes you say that he was a UPC member?

15 A. Well, it was him who was the commander. He was the best known member of

16 the UPC military, together with the chief of staff, Kisembo.

17 Q. What is or was Bosco Ntaganda's ethnicity, if you know it?

18 A. I don't know exactly, but what we know is that he was from north Kivu -- or,

19 rather, Goma and that he was Nilotic, so a Tutsi.

20 Q. What happened at this meeting at the primary school? Did anyone speak and,

21 if so, what did they say?

22 A. I think that at first it was Mr Lokuni Nembe who said some introductory words

23 stating, "Well, we've invited these people to address you." And he handed over to

24 Commander Bosco. For me, it was the first time to see Commander Bosco face to

25 face.

1 Q. What did Commander Bosco say?

2 A. (Redacted)

4 (Redacted) He also said this conflict that's taking place here is like the one in

5 Rwanda, so you really need to get involved, get involved heavily in the militia (Redacted)

6 (Redacted) to support the movement. He also said that all of the families

7 should give young people to bolster the UPC. That was the message he was putting

8 across. The meeting didn't last very long.

9 Q. What was the conflict in Rwanda that he was comparing the conflict taking
10 place there to?

11 A. He was referring, at least my understanding of course, is that he was referring
12 to the conflict between the Hutu and the Tutsi which took place in Rwanda.

13 Q. At this meeting were the objectives of the UPC explained by anyone?

14 A. No.

15 Q. This conflict that Bosco Ntaganda was talking about, who did it involve?

16 A. I haven't understood your question, Madam.

17 Q. You have referred to the existence of a conflict. Who was involved in this
18 conflict?

19 A. In Ituri?

20 Q. Yes.

21 A. The Bahema and the Walendu.

22 Q. What happened, sir, after this meeting was over?

23 A. Well, we all went our separate ways and they left in their jeep.

24 Commander Bosco was the first to leave. And the other teachers then left,

25 Professor Pilo, Dhetchuvi, Lokuni, and then we also left.

1 Q. Sir, I noticed that you've referred to Bosco Ntaganda and to Rafiki as
2 commanders. How were they dressed at this meeting?

3 A. They were in military attire. I think that Rafiki was wearing a khaki jacket
4 with jeans and he had a Motorola radio, and Bosco Ntaganda was wearing a full
5 military set.

6 Q. Did you attend any other events together with UPC members after this meeting
7 at the primary school?

8 A. Yes. I attended the preparatory meeting for the UPC celebrations with the
9 young people of Ituri.

16 Q. You said that this house, Thomas Lubanga's residence in town, was behind the
17 Cueb. What -- what was Cueb?

18 A. The Cueb is the university centre of the Bunia extension.

19 Q. And did a big reception follow on after this meeting at Thomas Lubanga's
20 residence?

21 A. Yes. There was a big celebration. It took place in Mudzipela, in the parochial
22 hall, which is located at -- just a few kilometres -- or, a few metres, rather, from the
23 cathedral Mudzimaria.

24 Q. When did this big celebration take place?

25 A. I don't know the exact date because of the amount of time that's passed since

1 then. But in relation to the meeting at the primary school, think that the event took
2 place about one month later, about one month later.

3 Q. And that is -- do you mean one month after the meeting at Lubanga's house, or

14 A. Yes. There was food laid on, cattle, cows that had been slaughtered, there was
15 rice, potatoes, a lot of alcohol, a lot of students. The whole hall was packed out.
16 There were people even outside. And right at the centre of the celebration, there was
17 the president of the UPC, Thomas Lubanga. And practically the whole UPC staff
18 was there; Thomas, Bosco, Kisembo, Bede Djokaba, Tinanzabo and a lot of other
19 people.

20 Q. What was the age or what was the age of the students who attended the
21 celebration?

22 A. I can't really specify the age of all of these people, but I can certainly say they
23 were young people. Some of them had just finished their sixth year in secondary
24 school and were waiting for the results of their state examination. They were there.
25 There were also students, that is to say, students who had already begun university.

1 Those were university students from every year, from the first year right through to
2 the postgraduate students. So I couldn't say exactly what the age of all of those
3 people was. There were also minors as well. There were people who were under
4 the age of 17 or 18 because they had just finished secondary school. So there were
5 some quite young people, but *more adults.

6 Q. What ethnic group or groups did these students belong to?

7 A. On that day, as it was a celebration, all the people who were in the town who
8 were students were present, apart from the Banande, who were afraid. Most of the
9 Banande students, *they had left, they'd left the Mudzipela neighbourhood after
10 Commander Claude had been killed.

11 Q. Did you know these students who were present at this meeting?

12 A. I didn't know them all, but I knew some of them.

20 MR BOURGON: Thank you, Mr President, can we get some precisions and some
21 spelling for all of these names so we would avoid any problems in the future.

22 PRESIDING JUDGE FREMR: Yes, I think it would be necessary.

23 MS SOLANO: Your Honour, I am giving a second to the French transcript to see if
24 it -- if the interpreters managed to capture all that and if not I will go back on each of
25 the names.

6 prepare themselves.

7 THE INTERPRETER: Your Honour, message from the English interpreting booth:

10 interpreters with us today, so it's not possible at the moment to translate that. It
11 would be better if you can just paraphrase it in French.

12 MS SOLANO: Your Honour.

13 PRESIDING JUDGE FREMR: Yes.

14 MS SOLANO: Can I suggest, your Honour, that the witness be allowed to say the
15 words in Swahili before he himself tells us in French what they mean?

16 PRESIDING JUDGE FREMR: Yes, good point.

17 So you have heard Ms Solano, so please now our direction to you is that first you say
18 this message in Swahili and then try to interpret it to French. All right?

19 THE WITNESS: (Interpretation) Very well. Bosco said the following:
20 (Speaks Swahili)

21 That's what his message was. And what that means in French, he said: "We have
22 come to give you support. You take part so that we can finish the problems in your
23 land and the UPC needs you intellectuals so that it can support you."

24 A. When I speak about kadogo, they are under the age of 18. Some of them
25 looked 12, 13. I couldn't say the ages precisely, but some were adults,

5 behaviour, the way in which they amuse themselves. The jokes, the jokes they make
6 between them. It was infantile.

16 training to join the militia.

13 session. I just want to caution the witness not to say any names in open session that
14 might lead to his identification. If we need names, then we can go into private

17 Then, court officer, please, let's return back into open session.

19 THE COURT OFFICER: We are back in open session, Mr President.

20 PRESIDING JUDGE FREMR: Thank you. Ms Solano, please.

21 MS SOLANO: Thank you, your Honour.

22 Q. Sir, you said you were taken to camp Ndromo. What was this camp?

23 A. Camp Ndromo was a former camp, a military camp previously used by
24 Mobutu's forces, and it's located close to the road to the subregion near the abattoir.

25 Q. Is that in Bunia?

1 A. Yes, it's right in the city of Bunia.

2 Q. What is the sous-région?

3 A. Well, we can describe the subregion as being the location where there are the
4 governmental offices that manage the town, so the governor's office, the various state
5 offices, tax offices, et cetera. That's what we referred to as being the subregion, the
6 sous-région. It's the name that we gave to that whole area, in fact.

7 Q. Who had control of camp Ndromo when you were taken there?

8 A. There were a number of military commanders. I don't know who the highest
9 officer was in the camp.

10 Q. What group had control of camp Ndromo?

11 A. It was the UPC.

12 Q. Were you taken there by yourself or with others?

13 A. All of us who had been in town at (Redacted) were taken to camp Ndromo in
14 a pickup truck, our whole group.

15 Q. How many were you?

16 A. I don't know.

17 Q. What did you find at camp Ndromo when you arrived?

18 A. First of all, we saw a very big building, which had been very well built, with
19 a large space which served as a courtyard where we would play -- or where we
20 would undertake our military exercises and parade.

21 Q. Were there any people there?

22 A. Yes, there were a lot of other soldiers there at that location, people who were
23 already being trained there.

24 Q. What was the gender of the soldiers present at camp Ndromo?

25 A. There were both men and women.

1 Q. What were their ages?

2 A. I don't know.

3 Q. How long did you stay there?

4 A. I couldn't say the number of days exactly, but we certainly spent more than one
5 week there.

6 Q. You mentioned parades and military exercises. Can you explain what you
7 mean. Did you participate in parades and military exercises while you were at
8 camp Ndromo?

9 A. Yes. When I say "parade," first of all, we would be divided into platoons of 36,
10 so 36 in each platoon. That was the structure.

11 Then we would carry out drills, marching, how to march, how to parade, how to bear
12 arms. We would also do physical gymnastics, push-ups. We would jog. There
13 were also parades at night. There would be commanders who would give us advice
14 and would also explain the ideology of the UPC by means of songs. That would
15 take hours, often late at night. And then at about 10, 11 o'clock at night we would go
16 and sleep in large rooms, like large classrooms, if you like, so each platoon would be
17 sent to sleep and that is where we would sleep.

18 Q. Did you come into contact with any weapons at camp Ndromo?

19 A. Yes, indeed. We saw weapons, old weapons, calibre 12, which the soldiers had.
20 But they also had other weapons but had been -- which had been damaged. Yes, I
21 saw weapons, indeed.

22 Q. Were you taught how to use them? Did you come into physical contact with
23 the weapons yourself?

24 A. Yes. We were taught to disassemble and reassemble Kalashnikovs.

25 Q. You said that you received advice or conseils from the commanders. What

1 kind of advice was this?

2 A. For instance, we would be told: "You're here in this militia, you should avoid
3 raping girls; you should avoid AIDS; you need to learn to obey the orders that you're
4 given; you should not try to run away, to desert; you are not allowed to go just
5 anywhere; there may be mines around the camp; you must comply with the
6 instructions that you are given here."

7 And as regards the ideology, they would talk about the UPC, what the UPC was,
8 what the UPC's vision was. We were told that the UPC was not a tribal militia.
9 Rather, that their aim was to take over Congo in its entirety and that we weren't just
10 fighting enemies, be they Bahema or Balendu, but that we were fighting the
11 government.

12 I think that's it, in a nutshell.

13 Q. Can you describe the singing, what kind of songs did you sing?

14 A. Well, revolutionary songs, songs in praise of the leaders of the movement, songs
15 to insult our opponents, our enemies, the government, those who would attack the
16 UPC, also songs to build up morale amongst the soldiers.

17 Q. Which enemy did the insults -- were the insults directed at?

18 A. A. *To the Kabila government, to the Balendu, the Ugandans, UPDF, with -- as
19 well as the president of their republic, Museveni.

20 Q. Do you recall specifically the wording relating to the Lendu?

21 A. Would you -- are you looking to have me sing, or -- or what?

22 Q. If you can, please go ahead.

23 A. Well, the songs were in Kilendu, so there is no translation. Of course I can
24 translate them.

25 MS SOLANO: Your Honour, in my submission the witness should be allowed to

1 sing in Kilendu. I appreciate that there probably isn't any interpretation available at
2 this moment, but at least it will be captured by the audio recording and if the witness

5 appreciate it if Mr Witness is ready to sing for us, fine, and then he could just provide
6 us with French translation, if possible.

7 MS SOLANO:

8 Q. Please go ahead, sir, with the song.

9 A. Well, just before I sing, while I was thinking of the songs I -- it's occurred to me
10 that there were also songs in the honour of President Wamba Dia Wamba, he was also
11 *insulted in songs. For example, vis-à-vis the Lendu, we would sing.

12 (Witness sings)

13 (Interpretation) And that means "Micheline, give me a knife with a basin so that
14 I can slit the throat of a Lendu."

15 And there was a song about Wamba Dia Wamba in Kilendu. I don't know the whole
16 song, but I -- there's a little bit of --

17 (Witness sings)

18 (Interpretation) Something along those lines. And what that means is -- well, these
19 are very derogatory insults, very vulgar.

20 (Speaks English) I'm not able to translate because --

21 PRESIDING JUDGE FREMR: No, go ahead. I think even it's important for us, so
22 don't be shy.

23 THE WITNESS: (Interpretation) Well, that means, in Wamba Dia Wamba's
24 mother's vagina there are birds that fly out of it.

25 MS SOLANO:

1 Q. Sir, how about the songs about the UPDF and the Kabila government.

2 A. Ah, yes.

3 (Witness sings)

4 Now that means: I heard the sound of heavy weapons, my eyes looked to the sky,

5 my eyes looked to the ground. I saw the Ugandans. I greeted them. They

6 couldn't answer me. They can't speak Lingala. They are ignorant. They're

7 ignorant, they're peasants. Museveni, Museveni, take the corpses of your soldiers.

8 We could say Museveni or we could say Kabila. And we could say the FARDC, or

9 the FAC. So you could interchange the names of the various leaders of the enemy,

10 *Mbusa, the APC, et cetera.

11 Q. Thank you, sir. Were you able to hold on to these Kalashnikovs that you were

12 taught to assemble and disassemble? Did you have a weapon for yourself for your

13 individual use?

14 A. No.

15 Q. Do you remember the names of your instructors at camp Ndromo? And if you

16 do, I'm going to ask to go into private session. But I need to know first if you

17 remember them.

18 A. The names of those at that location I don't remember anymore. But I do

19 remember the name of the general who would come and visit us from time to time.

20 Q. And who was that general?

21 A. You said that I shouldn't mention any names, so how should I proceed?

22 PRESIDING JUDGE FREMR: I guess general is -- it doesn't make any problems, I

23 would say, because general, you know, it's a general common to many soldiers, so I

24 think just the name of the general couldn't identify you, I believe.

25 THE WITNESS: (Interpretation) It was General Kitembo, who was also referred to

3 Q. Did he speak to you when he visited you at camp Ndromo?

6 A. What he was saying was to encourage us, to build us up: *take heart ! Even you,
7 students, will go back to your studies but first, you have to go through this procedure
8 here, the militia. And he would also warn, warn us against deserting because there
9 had already been some who had run away.

10 Q. What did he say by way of warning?

11 A. "We will warn you not to run away because all those who desert, they reveal
12 our secrets in town and we track down and find anyone who deserts. And this is
13 a serious warning."

14 Q. Did General Kisémbé say *what would happen ?

15 A. He simply said that they would track down and apprehend them, that's all.

16 Q. How do you know that there were some who had run away?

17 A. Well, even in our group those who had come from (Redacted) some of them,
18 my friends, had already disappeared. I'd already got to know them. Such as my
19 friend (Redacted) he managed to get away.

20 Q. Did you think of escaping camp Ndromo?

21 A. Yes, I did.

22 Q. Did you try it?

23 A. I couldn't see how many troops were patrolling around the camp, so I didn't
24 attempt it but I did feel that I want to get away, I wanted to escape.

25 MS SOLANO: Your Honour, we seem to have a delay on both the English and the

7 So now I got slightly different information. The technicians are dealing with that.

8 So I am asking you for some indulgence and hopefully it will be solved shortly.

9 (Pause in proceedings)

10 MS SOLANO: Your Honour, I'm happy to continue with some questions if
11 the Chamber wishes me to.

12 PRESIDING JUDGE FREMR: What is our chance for change?

13 I was told that it's more serious problem, it's a server issue, so I would rather prefer to
14 break because -- I think if it will be just for one, two minutes, no problem, but it seems
15 that it will be permanent, at least for some time permanent problem, so we will have
16 to break until the problem is solved.

17 So please remain on your seats. We will be in the deliberation room, but still as soon
18 it will be solved we will continue.

13 PRESIDING JUDGE FREMR: *Ms Solano, your comment?

14 MS SOLANO: Your Honour, I had asked the witness for the ages of those present at

15 the camp, that is -- that is correct. I have now just asked him were there children

16 there and he has said yes. So I think I can at least -- if the Chamber wants to bar me

17 from asking him the ages of those children, I can go about it in some other way.

18 PRESIDING JUDGE FREMR: All right. The objection is overruled. The topic was

19 not fully exhausted, so please proceed.

20 MS SOLANO: Thank you, your Honour.

21 Q. Sir, how young was the youngest amongst the children present at camp Ndromo?

22 A. It's difficult for me to say the age of the youngest, but there were children

23 *among our trainers.

16 MS SOLANO: And indeed, your Honour, in the French transcript, on page 46 at
17 line 3 --

20 MS SOLANO: Yes. Your Honour, at page 46, line 3 of the French transcript, it is
21 recorded that the witness said that there were children among the instructors. And
22 this has not been captured in the English transcript on page 42, line 6. So I request
23 a correction of the English transcript.

5 Q. How do you know that this was their age?

6 A. Well, a child is a child. The way they talk. In particular, the instructors, they
7 gave orders in a childlike way. They were having fun with us, if you like. They
8 were playing with us. Sometimes we would watch them, we would see them
9 playing soccer together as if they were home. In fact, they weren't using a ball, but
10 they were playing with a can or whatever as if it was a football when they had free
11 time. And most of the children that we saw in Ndromo camp were -- in fact, they
12 spoke Kilendu in the camp. *It was as if they were displaced by the war, these
13 children. They came from Ndjugu and they had been in Bunia and they spoke
14 Kilendu for the most part, those smaller children.

15 PRESIDING JUDGE FREMR: Ms Solano, sorry to interrupt you, I would like to put
16 one additional question for clarification, but I have to put it in private session.
17 Court officer, please, let's move just for this one question into private session.

24 A. They were all wearing civilian clothes, or some of them had military pants or
25 military shirts, half and half, but for the most part they were wearing civilian

2 Q. Were they armed?

3 A. Some of them had weapons and others didn't. The ones who didn't have
4 weapons were called commandos.

5 Q. And the ones that were not instructors, the ones that were just training, did they
6 have the same or different activities from the older recruits such as yourself?

7 A. We all carried out the same exercises. There was no distinction.

8 Q. How did these very young children cope with these exercises?

9 A. Well, they -- they resisted. They did what they could. They were very tired.
10 They were more tired than we were, but there were moments where we could rest.
11 We started at 5 in the morning until 11, and then there was a rest period, you could sit
12 down in the courtyard, in the shade. So there were moments when we could rest.

13 Q. How long did you rest for on your average day at camp Ndromo?

14 A. It depended on the instructor that was in charge. I -- I can't tell you exactly.
15 I don't know exactly how many rest periods there were.

16 Q. What would you do between 5 and 11 in the morning?

17 A. At 5 o'clock we would wake up and go jogging, running. It's called mchaka.
18 We would run around the courtyard several times. And at about 7 o'clock there was
19 the parade and there would be an instructor giving orders. And the others would
20 come and divide us up into small groups to carry out drills; marching, moving your
21 arms and your legs, chanting, singing. We spent a lot of time singing. We were
22 taught songs, the revolutionary songs, the songs of the movement. Sometimes we
23 would spend one or even two hours chanting and singing. It was a way of enabling
24 us to forget our fatigue and it was also a form of indoctrination, teaching us the
25 military spirit.

1 Can I sum up? So from 5, very early in the morning, we did the mchaka and the
2 jogging. I haven't given you a precise hour because it would depend on the
3 commander who was with us.

4 And then there was a parade and we were given the instructions for the day.

5 And then there were drills, along with songs. And that's where we learned those
6 things.

7 And after about a week, we were taught how to dismantle and remount the weapons,
8 especially the AK-47, the Kalashnikovs.

9 Q. Were these very young children around within sight on the two occasions when
10 Commander Kisémbó came to visit you?

11 A. Are you talking about the parade?

12 Q. I'll rephrase because I don't know how it was interpreted to you.

13 A. (Speaks English) All right.

14 Q. The very young children, you've said about nine years old, I want to know
15 whether you know if Commander Kisémbó saw them when he came to visit camp
16 Ndromo?

17 A. Yes, of course. They were there. They were amongst the parade, they were
18 lined up like all of the militiamen in their own platoons. We were mixed up. There
19 weren't -- you didn't have small children separate, they were taught the same way as
20 everyone else. So they were part of the platoons, each one side by side.

21 Q. You said there were also women at camp Ndromo. Where did they sleep?

22 A. In the evening we were separated and I don't know where they slept.

23 Q. Where did you go after camp Ndromo?

24 A. After camp Ndromo, one night they got us together in a parade and we crossed
25 the town at night and we went all the way to Mandro, to the elementary school in

1 Mandro. We travelled by night.

2 Q. What did you find at the elementary school in Mandro?

3 A. There were a lot of militiamen with weapons. Many militiamen and also many

5 Q. Where exactly did you see Commander Bosco?

6 A. In one of the school buildings. Outside. In fact, there were students who
7 were going off to study who were there and he was introduced to them.

8 Q. Who introduced Commander Bosco to the students?

9 A. I don't know the name exactly. I did recognize a number of commanders
10 whose name I do recall. But the person who made the introductions, his name
11 I don't recall.

12 Q. Which other commanders did you recognize at Mandro?

13 A. Aside from the commanders who travelled on foot with us, I recognised
14 a commander there who was a former school mate of mine.

15 Q. Can you please wait and provide that name in a moment.

16 MS SOLANO: Your Honours, may -- may we move into private session to obtain
17 this name, please?

6 A. Yes.

7 Q. What lists were these, if you know?

8 A. It was a list of the students. A list of students. So we, that is to say those who
9 were to go on to undertake studies.

10 Q. Do you know whether these lists contained any information apart from your
11 names?

12 A. No, I don't. I didn't have any access to the lists. They would put questions
13 such as "What is your name? What is your first name? Your second name?"
14 et cetera.

15 Q. When I first asked you about the commanders you saw at Mandro you said that
16 some of them had come with you by foot from camp Ndromo. Can you tell us who
17 they were? And I remind you that if any of the names are identifying you should
18 please let the Presiding Judge know before you provide the names.

19 A. Aside from Abelanga, there were the little children who were our instructors
20 there, and there were other commanders whose name I didn't know. But I knew
21 Commander Abelanga very well because he had been with us (Redacted) in
22 camp Ndromo and right through to Mandro.

23 Q. Can you describe the location you were in? Can you describe this camp
24 physically, what did it look like?

25 A. It was an old school. It was half destroyed. It was as if there were two -- two

1 or three buildings. At the back there were trees and bushes. And it was located on
2 a piece of land where the ground was red, the clay was red. And it was really full of

4 recognised some old friends who I knew from the old neighbourhoods who had
5 already been trained *with (Redacted) and, in fact, had already spent time in Uganda.
6 They were already there and were commanders and they were the ones who were
7 now our instructors.

8 Q. What were their names?

9 A. I recognised Roger Mukili (phon); I recognised Malobi Brandon; I recognised
10 Christian Banga, who is also called De Gaulle; I recognised -- oh, who else? There
11 was also Tiba, Tiba who had come with us to Mandro, that's Tiba Jogoo, he had
12 already been trained and gone to Uganda. He said he had been trained in
13 Kyankwanzi. *He spoke about Kyankwanzi.

14 Q. What ethnic group were -- did these individuals belong to, or ethnic groups?

15 A. Well, there in Mandro there were a number of different tribes but most people
16 were Bahema. Such as Abelanga, Abelanga is not a Hema, I was told he was an Alur
17 whose mother was Hema.

18 PRESIDING JUDGE FREMR: And Mr Witness, if you are saying that there were
19 many tribes represented, was there any Lendu among them?

20 THE WITNESS: (Interpretation) No, no, I didn't see any Balendu.

21 PRESIDING JUDGE FREMR: Thank you.

22 MS SOLANO:

23 Q. Sir, what -- how long were you at this camp in Mandro for?

24 A. We spent about one and a half or two weeks in Mandro. We did not spend
25 longer than that there.

1 Q. How did you spend your time at Mandro? What did you do?

2 A. Well, in Mandro we took part in parades and, in fact, the same types of drills as

4 Q. Was this school in Mandro a military training camp?

5 A. Well, it wasn't a training camp, it was more of a transit camp. There were one
6 or two camps a little further than the school. I know the name of one, it was Saikpa,
7 because each time people would leave they were being channelled on to Saikpa.
8 Mandro was a kind of a collection point.

9 Q. Did you go to Saikpa yourself?

10 A. I don't recall.

11 Q. Were there any children at Mandro where you were?

12 A. In fact there were a lot more children there than anywhere else I had been.

13 Q. What were their ages, if you know?

14 A. I can't say specifically, but they were children.

15 Q. Were there -- at Mandro were there children as young as the ones you had seen
16 at camp Ndromo or were they perhaps all older than the ones you had seen at
17 camp Ndromo?

18 A. No, it was the same ages. I recall that on one occasion an effort was made to
19 gather the children together there and to return them to their homes. But those
20 children came back of their own accord. They refused to go. Whereas
21 were -- would imagine every possible means of escape, those children would stay
22 there. I just couldn't understand that. They wanted to remain in the militia.

23 Q. On this one occasion, who made the effort to gather the children and return
24 them to their homes?

25 A. I don't know. I don't recall who was -- who carried out that operation that day.

1 I don't know if it was Commander Bosco himself. I know it was one of the very high
2 officials, either General Kisembo, perhaps Commander Bosco.

3 Q. And how do you know that either Commander Bosco or Commander Kisembo
4 were involved in this effort to return the children to their homes?

5 A. Because it appeared to be an instruction that had come from the level of the
6 president, Thomas Lubanga. In Mandro, there was time to stay there, but it was said
7 that Thomas Lubanga had said that the little children should go back to their families.
8 Perhaps it was pressure from the humanitarian NGOs or something like that.

9 Q. Who told you that Thomas Lubanga had said that the little children should go
10 back to their families?

11 A. Well, we would talk amongst ourselves. I don't know where the information
12 came from, but it was passed on amongst the group and we had heard that it was said
13 that the children had to go back home. But I can't say who told me or if
14 a commander -- and it's not the case that a commander gathered us in a group to
15 inform us, no.

16 Q. These children who wanted to remain in the militia, were they able to remain in
17 the militia?

18 A. I don't know. I can't answer for them. But they wanted to. They really had
19 taken a liking to life in the militia. Those who were instructors, they felt like adults
20 with their weapons in hand, they could order around adults. So sending them back
21 to civilian life would be a way of demoting them. So I think that above all, those
22 who were instructors refused to go back to the ordinary life of a child living at home.

23 Q. As far as you were able to observe in Mandro at the time, did the adult
24 commanders engage with instructors who were young children?

25 A. (Speaks English) Please, would you mind repeat your question?

1 Q. Did the adult commanders perhaps set the young children aside because they
2 were supposed to return home, or from your observations did these child instructors
3 take active part in the activities at Mandro?

5 the other children, those without weapons, and they were told, "Right, now we're
6 going to accompany you home to your families. Line up. We're going" and they
7 were taken out of the camp. But in the evening they returned and they patrolled,
8 just like everybody else, they instructed, they set drills for those who came, they
9 would work with the new recruits coming in because there were a huge number of
10 recruits coming in at that time, it really was a recruitment phase, and they would go
11 with the recruits through to the other training centres which were located lower, near
12 Saikpa.

13 Q. What do you mean that this was a recruitment phase?

14 A. Sorry, could you repeat?

15 Q. According to the transcript in English you referred to this period of time while
16 you were at Mandro as a recruitment phase.

17 A. Actually I said a wave, a wave of recruitment. What I mean is there were a lot
18 of recruits coming into Mandro, really a wave or an influx of recruits.

19 Q. Was Mandro an area associated with a particular ethnic group at that time?

20 A. Mandro was the fiefdom of Chief Kahwa, who was a Muhema chief.

21 Q. Did Chief Kahwa have any links to the UPC?

22 A. Yes. He was a member of the UPC at that time.

23 Q. How do you know that?

24 A. I saw him in Mandro. He is of mixed blood, very dark. He was pointed out
25 to us, people would say, "Oh, that's Chief Kahwa." We would see him talking to

9 my colleague will know that what is being adduced that is different. And we have
10 no trace of this -- these new answers coming out this morning, whether when they
11 contradict things he said previously or whether it's blatantly new information.
12 So at this point in time I just want to make it as an observation. We will on this side
13 analyse the answers of the witness, and if we can come up with a specific request, we
14 will at a later time.
15 Mr President, I ask of course that these submissions made before the Chamber at this
16 stage in the presence of counsel representing the witness are to remain in this
17 courtroom and are not to be discussed with the witness.

18 Thank you, Mr President.

18 Registry to explore with us whether in this particular case it can be done so that
19 the Chamber can, in due course, listen to the melody intonated by the witness this
20 morning alongside this video, and of course we can at the appropriate moment
21 provide the exact references, because we will be submitting that the song is the same
22 one, and it's a video that the Prosecution has referred to many times as the Rwampara
23 video.

7 Q. Sir, where did you go after Mandro?

8 A. Well, we went on a trip from Mandro to Tchomia. Tchomia, that's a centre
9 next to Lake Albert.

10 Q. What do you mean by "centre"?

11 A. *Well, I mean it was not a village, a village next to the lake.

12 Q. How did you get to Tchomia from Mandro?

13 A. Well, we left on foot and went via the mountain. We followed the Monts Bleus
14 chain towards the lake, through the mountain and we travelled by night. We left at
15 night -- no, we left very early in the morning and we arrived in the evening there.

16 Q. Who were you with?

17 A. With the students. With other militia as well. There were lots of us. A long
18 line of people.

19 Q. How many were you?

20 A. I don't have the number in mind, but there were lots of us. Some had weapons,
21 some didn't have weapons. Those who had weapons were walking next to each
22 other, and those who didn't we were in a line. So some walking side by side,
23 whereas we were walking in single file, the ones who didn't have a weapon.

24 Q. How did you feel during this -- during your travel there?

25 A. Well, I was in a lot of pain because of what I'd suffered. It was a terrible

1 journey for me, but we did arrive. We were very tired but we did arrive there.

2 Q. Did you come across anyone on your way there?

3 A. Yes. Yes. On the way, I remember, we came across other UPC militia in the
4 high mountains. They were coming back up from the lake, Tchomia, and we crossed
5 each other, and they were all in new military uniform. And they had weapons boxes,
6 ammunition boxes, they were in military uniform which was completely new. It
7 was a major event. It was as if it was the first time that military equipment was
8 entering, uniforms, weapons, et cetera.

9 Q. What did you see when you arrived in Tchomia?

10 A. Well, we arrived -- when we arrived there there were other soldiers. There
11 was a Commander Mugisa who was there, he was the person who was in charge.
12 There were other militia as well. We were well received, we ate, we ate fish. It was
13 for the first time for several days. And the commander was Mugisa Muleke. We
14 had boxes of ammunition, boxes of military uniform. They were called officers. I
15 said officers had arrived.

16 Q. Sir, according to the French transcript you said "caisse d'armes." According to
17 the English transcript you said "boxes of ammunition." Can you clarify?

18 A. Well, there's a difference between weapons and ammunition.

19 Q. What did you see at Tchomia that day?

20 A. We saw crates of weapons and we saw boxes of ammunition, bullets, bombs
21 and crates of military clothing.

22 Q. Do you know what these weapons and ammunition and uniforms were doing
23 there?

24 A. Well, they'd come from somewhere. They'd just come from somewhere.
25 They were being *stored there before they were taken to the other sites.

1 Q. What makes you say that?

2 A. Well, you had munitions, you had weapons of the UPC, and they had to go so
3 that the militia could have them. There were lots of militia who didn't have
4 weapons. And there wasn't a uniform up to that point. So what we saw is that
5 they were heading towards Mandro and they were carrying it on their heads. I think
6 the others might have been sent to Bunia, everywhere where the UPC militia were.

7 Q. How long did you stay in Tchomia?

8 A. In Tchomia, just one night. The day we arrived, in the evening we slept there,
9 we ate and in the morning, towards 8 o'clock in the morning we *were chosen and we
10 left. Next to the lake there was a beach there. We found people who were there
11 and they allowed us to enter into the compound. We -- just one night, we just spent
12 one night there.

13 Q. Apart from Mugisa Muleke did you see any other commanders in Tchomia?

14 A. Yes, next to the plane there was the commander, Safari.

15 Q. Who was he?

16 A. Well, Safari, he's a UPC commander as well. He -- well, that's somebody who's
17 lived in Bunia for a long time, but it's also the same as Bosco Ntaganda, same -- he's
18 from the same area as Bosco Ntaganda, he's also a Rwandophone.

19 MS SOLANO: I request a correction to the English transcript, page 74, line 16, where
20 it says compound. The French transcript at page 79, line 13 refers to a plane.

21 Q. You said that they made you board the plane.

22 MS SOLANO: Your Honour, the witness appears to have a --

23 PRESIDING JUDGE FREMR: Yes, Mr Witness, you have the floor.

24 THE WITNESS: (Interpretation) I -- please, if I could be allowed to leave for a
25 moment.

- 21 night because I hadn't seen it land.
- 22 Q. Did the plane take off while you were on it?
- 23 A. Yes. Yes, it took off and we left and we landed at the airport, Kigali airport I
- 24 think it was, but next to the military part.
- 25 Q. And where did you go from the Kigali airport?

1 A. Well, we got out of the aircraft. We were put in a stockage area where there
2 were lots of empty boxes for about an hour, I think. And afterwards there was a

4 And when we entered it covered the behind part. And we were taken -- well, we
5 didn't know, they took us to Gabiro, military training centre in Gabiro.

6 Q. Who did this training centre belong to? Who was it run by?

7 A. When we arrived there was a captain called Charles Sibbo. He was slim. He
8 spoke French with a bit of English in it. He told us he was the person who is the
9 chief of the centre and who had succeeded. He explained to us what the objective of
10 our arrival there was. We had come for training in artillery, artillery training. That
11 was information that we got from there. And I thought, well, it's no longer about
12 cadres or officers, this is still army business. We're going to learn to use heavy
13 weapons, to assemble them and to disassemble them, to set them up. And that was
14 because there are weapons that you have with you, but you have nobody who can use
15 them and that's the reason why we have to help you, train you so that you can use
16 these weapons there.

17 And he left us. And we were given military uniform. That was the first time that I
18 had military uniform. There was a poncho, there were covers, blankets, that was it.
19 Then we were accompanied towards the other side of the valley, the other slope.
20 There were two mountains. There was the part where we'd come, there were some
21 rooms there, and on the other side that's where we were staying, that was the camp
22 we were staying in. Whereas the training rooms were the other side. You could see
23 the friends there, from a distance, basically two mountains with a small valley
24 between them.

8 PRESIDING JUDGE FREMR: Yes, no problem.

9 MS SOLANO: Your Honour, and if while the witness is writing if the court officer
10 could prepare the Elmo so that we can see what he writes please.

11 PRESIDING JUDGE FREMR: Yes, yes, for sure.

12 THE COURT OFFICER: The document will be displayed on the evidence 2 channel.

13 MS SOLANO: Can we see the top of the document first please, or the whole
14 document?

15 Are we seeing everything that the witness has written, numbers 1 through 8, or is
16 there more below number 8? It's from numbers 1 to 8.

17 PRESIDING JUDGE FREMR: Court officer, can you confirm that it is nothing more
18 than from 1 to 8, or is there any --

19 THE COURT USHER: It is 1 to 8.

20 MS SOLANO: Your Honour, it has been confirmed.

21 Q. Sir, what is the 93 millimetre? What weapon is that?

22 A. It was a universally forbidden weapon, it was a chemical bomb, a very
23 destructive weapon. We were told how to use it, but we were told that it was
24 forbidden to use it, but we learned about it. It's called a 93 millimetre.

25 Q. What does "field mining ingénierie" mean? That's what you wrote down at

2 A. Well, we were trained to use mines, that is anti-personnel mines and anti-tank
3 mines.

4 Q. And at number 8, is there a reason you put an asterisk where it says "AKA-47"?

5 A. Yes, I put an asterisk there because it's not a heavy weapon. It's not really a
6 part of the artillery. Artillery refers to heavy weapons.

7 Q. Did you receive instruction regarding these weapons in theory, in practice, both?
8 Can you explain?

9 A. Yes, all of these weapons. First of all, we learned about them in a classroom,
10 we studied them, sometimes we were taught to draw them, and then in the afternoon
11 we went outside to learn to dismount and mount them, and then we would have
12 firing practice. For each weapon, once we had studied the weapon in the classroom,
13 then we would have shooting practice in the afternoon.

14 Q. Who gave you this instruction?

15 A. Well, there were several instructors, several different ones, but they were from
16 the Rwandan army, the instructors.

17 MS SOLANO: Your Honour, I seek to tender this document into evidence.

18 PRESIDING JUDGE FREMR: Defence, any objection?

19 MR BOURGON: No, Mr President.

20 PRESIDING JUDGE FREMR: All right. So this list made by Mr Witness is
21 admitted into evidence as a further Prosecution exhibit.

22 THE COURT OFFICER: For the information of the parties the document will bear

23 who was a UPC member. There was General Kisémbu.

24 THE INTERPRETER: Inaudible.

25 THE WITNESS: (Interpretation) That day they came with the chief of staff from

6 Q. When did they visit you? Was it at the beginning of the training, sometime in
7 the middle of the training, towards the end of the training?

8 A. It was right in the middle of the training.

9 Q. Sir, and where did you go after Gabiro?

10 A. We went back to Bunia.

11 Q. How did you get there?

12 A. We took an aeroplane from Rwanda directly to the Bunia airport, and from the
13 airport we went to a house, a building in the sous région.

14 Q. Do you know the date on which you returned from Gabiro to Bunia?

15 A. I'm afraid I don't remember the dates. I'm very sorry.

16 Q. Who was in control of Bunia when you came back?

17 A. Well, in any case, when we went back, the UPC was in control of almost all of
18 Ituri, all the way to Aru, except perhaps Komanda, Mambasa, that way. But toward
19 the north the UPC controlled everything.

20 Q. Do you know what troops the UPC had in the area of Aru?

21 A. What troops?

22 Q. Yes, you said the UPC was in control most of Ituri, all the way to Aru, so I want
23 to know if you know who controlled the area of Aru, who within the UPC
24 commanded that area?

25 A. There was the commander Jérôme Kakwavu. Before he separated from them,

1 and he -- he was controlling that area.

2 Q. Where did you spend Christmas and New Year in 2002, so in December 2002?

4 Q. Who was in control of the Bunia airport when you came back from Gabiro?

5 A. I remember that there were still the Ugandan soldiers there. There was
6 MONUC. Those were the two groups of -- the two troops, if you will, who
7 were -- who were there at the time.

8 Q. Were you carrying any weapons on the flight back from Gabiro?

9 A. Yes. We were given a weapon, each of us, and we had a briefing. They told
10 us, "You're going to arrive in Bunia and if the Ugandans dare to attack you, fight
11 back."

12 Q. What weapons were you given?

13 A. Each one had an AK-47, a Kalashnikov.

14 Q. How were you dressed when you came back from Gabiro?

15 A. Well, okay, the day we were supposed to leave we were told to leave our
16 uniforms that we had, to leave them there. And when we crossed through the
17 classrooms during the parade, we were given new uniforms and those new uniforms,
18 as I mentioned at one point, those uniforms were the same colour as the uniforms
19 worn by our militiamen brothers that we had crossed paths with in the Monts Bleus
20 when we were going to Tchomia. It was the same colour, the same type of uniform
21 that they had been wearing.

22 Q. Can you describe --

23 A. Well, yes, we had gumboots, that is plastic boots, and they were different from
24 the other militiamen wore in Bunia.

25 Q. How were they different?

6 Q. And the uniform itself, can you explain what colour it was, whether it had any
7 patterns?

8 A. Yes, it was chocolate coloured with military khaki design on it.

9 Q. Was there anyone waiting for you at the airport in Bunia?

10 A. Yes. At the airport when we got off the plane General Kisémbó was there on
11 site with a few other people.

12 Q. Do you recall whom else was with Kisémbó?

13 A. No, I'm afraid I don't remember.

14 Q. How did you get from the airport to the house in the sous-région?

15 A. There was a truck that was waiting for us. As soon as we disembarked from
16 the plane, we immediately got into the truck that had been parked right nearby, a few
17 metres from the airstrip.

18 Q. Sir, and you said earlier that UPC was in control of almost all of Ituri, but you
19 also mentioned that the UPDF and MONUC were present at the airport, so I'm going
20 to ask you again who was in control of Bunia?

21 A. At that the point in time, well, there were several different militias. There was
22 the FNI from the other side, the UPC and -- well, to say that the UPC controlled, in
23 fact, the situation was stable, the schools were functioning, even the university was
24 functioning. Thomas had his government, he had ministers. Of course the
25 Ugandans were there. I don't know exactly how things occurred. I was in a militia.

1 I don't really know. There was a combination at the time.

2 Q. This house that you were taken to, what -- what did you find at this house?

3 What was this house?

5 headquarters. It was a -- one of the buildings from the sous-région, it was a concrete
6 building, a former official building of the city.

7 Q. Which members of the UPC were there at this house?

8 A. There were militias, several commanders, General Kisembo himself came. He
9 accompanied us right to that building until the evening or the afternoon when
10 President Thomas Lubanga joined him. We were called into -- for a parade and they
11 spoke to us one after the other.

12 Q. In what part of the house did this parade take place?

13 A. It was outside, in the courtyard of the compound.

14 Q. And what did Kisembo and Lubanga say to you?

15 A. The president, Thomas Lubanga, congratulated us. He was very pleased that
16 we had come back and he said he was proud of us. He sang and he had us sing with
17 him, we sang with him, and then General Kisembo spoke and he spoke in more
18 military terms, he said, "You've come back, you've had military training and now
19 you're going to have to put it into practice."

20 Q. How long did you stay at this house?

21 A. Well, that very night we were deployed. The first person who left was
22 Christian De Gaulle.

23 MS SOLANO: Your Honour, can we move into private session, please.

18 Q. Sir, where is (Redacted) relative to (Redacted)

19 A. Would you like me to say where it is with regards to north, east, south, west?

9 Q. And you mentioned the number of locations to which other soldiers were
10 deployed. Were these soldiers, had they received training in Rwanda like you, or
11 were they a different group of people who were deployed to these locations, (Redacted)
12 (Redacted)

13 A. No. Yes. During the deployment it wasn't just us from Gabiro. We were
14 put together with other militia who'd already been trained. They were also armed.
15 They were there when we got there. And when we arrived, *in (Redacted) for example,
16 Commander (Redacted) was there.

17 Q. Sir, the -- the people you had trained with at Gabiro, had they remained in
18 Gabiro when you went back to Bunia or did they also leave Gabiro?

19 A. No, no, we all went back on the same day. Gabiro camp was emptied.

20 Q. How do you know that?

21 A. When you call a parade nobody stays outside it, nobody remains behind. We
22 all went to the parade and afterwards we were given uniform, we changed there, we
23 got into the truck and we left.
